

Discussion and direction to staff regarding proposed City of Bastrop Charter Amendments for the November 2024 election.

BACKGROUND/HISTORY:

In 2022, the City Council faced numerous charter amendments, but ultimately decided not to pursue the cost of an election in an uncontested council election period. The existing charter calls for the charter to be reviewed at intervals not to exceed six (6) years.

Section 13.09 - Charter Amendment.

Proposed amendments to this Charter shall be framed and submitted to the voters of the City in the manner prescribed by state law.

The Council shall, at intervals not to exceed six (6) years, formally consider the need for revision(s) to the Charter. This review shall be based on a written report from the City Manager, with special attention given to conflicts, if any, between the Charter and state law, and recommending such amendments to the Charter as may seem necessary for legal, administrative or other reasons.

The existing amendments include:

PROPOSITION A

Shall Section 2.03 of the Charter be amended to conform with state law by removing reference to the City's power to annex territory without consent of the inhabitants?

PROPOSITION B

Shall Section 3.06(6) of the Charter be amended to conform with state law creating a vacancy on the city council when a council member announces their candidacy for certain elected offices and the unexpired term of the council member exceeds one year and thirty days?

PROPOSITION C

Shall Section 3.15(b) of the Charter be amended to authorize the city council to waive by an affirmative vote of four (4) or more Council Members the requirement that an ordinance be read in two separate meetings?

PROPOSITION D

Shall Section 3.16 of the Charter be amended to reflect the fact that codes of technical regulations are available to the public digitally and free of charge?

PROPOSITION E

Shall Section 3.17(b) of the Charter be amended to reflect the fact that ordinances are available to the public digitally and free of charge?

PROPOSITION F

Shall Section 5.02 of the Charter be amended to conform with state law by stating that the term of office of municipal court judges shall be provided for by ordinance?

PROPOSITION G

Shall Section 10.04 of the Charter be amended to conform with state law by requiring petitions calling for initiative or referendum elections to comply with the Texas Election Code?

PROPOSITION H

Shall Section 10.08 of the Charter be amended to conform with state law by requiring petitions calling for recall elections to comply with the Texas Election Code?

PROPOSITION I

Shall Section 12.01 of the Charter be amended to provide that the number of Planning and Zoning commissioners shall be established by ordinance?

PROPOSITION J

Shall Sections 14.03 and 14.04 of the Charter be repealed in their entirety as outdated, transitional provisions that are now irrelevant?

PROPOSITION K

Shall the Charter be amended throughout to replace gender -specific language with gender-neutral terminology?

PROPOSITION L

Shall Section 4.01 be amended to allow the City Manager to reside in the City Limits and the 1-mile extra-territorial jurisdiction?

PROPOSITION M

Shall section 3.08 be amended to allow the Mayor or 2 council members to appoint to boards and commissions subject to confirmation of the city council?

FISCAL IMPACT:

Approximately \$25,000 for a shared election expense.

RECOMMENDATION:

Direct staff to prepare an ordinance considering the above mentioned charter amendments, and prepare for a November 2024 election.

Explanation of proposed 2022 Amendments to the Bastrop Home Rule Charter

Introduction

The City of Bastrop's Home-Rule Charter is a foundational governmental document. Much like a municipality's constitution, the Charter is both the legal source of authority and a limit on the City's authority. Along with state law, it establishes the essential framework for the local government.

The Charter was last amended by the voters at an election held on in 2016. State law prevents charters from being amended more frequently than every two years. Bastrop's Charter states that it should be evaluated at least every six years.

The proposed Charter amendments will be adopted if approved by a majority of the qualified voters at an election held for that purpose. All registered voters of the City will be entitled to cast a vote.

At the Special Election voters can vote FOR or AGAINST each of the individual amendments to the Charter. Below are the individual propositions and brief explanations of why they are offered for consideration. Most propositions may be characterized as non-substantive clean-up edits. This is *educational material*, *only*. The City of Bastrop as an organization offers these propositions for consideration but does not advocate for or against passage of these items.

Propositions

Prop A: Shall Section 2.03 of the Charter be amended to conform with state law by removing reference to the City's power to annex territory without consent of the inhabitants?

Explanation: Legislative changes to Texas statutory law have made it difficult to annex property without the consent of the property owners. See Texas Local Government Code Chapter 43.

Amended Text: If approved, the section will read (in relevant part):

Section 2.03 - Annexation

The Council shall have the power by ordinance to fix the boundary limits of the City

to provide for the alteration and the extension of said boundary limits, and the annexation of additional territory lying adjacent to the City, in compliance with state law with or without the consent of the territory and inhabitants annexed. During the annexation process, the Council shall provide an opportunity for all interested persons to be heard at public hearing(s), in conformance with state law....

Prop. B: Shall Section 3.06(6) of the Charter be amended to conform with state law creating a vacancy on the city council when a council member announces their candidacy for certain elected offices and the unexpired term of the council member exceeds one year and thirty days?

Explanation: The Texas Constitution has a provision commonly referred to as the *Resign to Run* rule, which automatically creates a vacancies in certain elected offices if the incumbent announces they are seeking another elected office. The *Resign to Run* rule applies (in relevant part) when certain candidates for other offices have 1 year and 30 days left on their current term. The current Charter provision only references the 1 year mark, but omits the additional 30 days.

Amended Text: If approved, the section will read (in relevant part):

Section 3.06 - Vacancies, Forfeiture of Office and Filling of Vacancies. The office of a Council Member shall become vacant upon the member's death, resignation, removal from or forfeiture of that office. A Council Member shall forfeit that office if the Council Member: ...

(6) announces his/her candidacy, or shall in fact become a candidate, in any General, Special or Primary Election, for any office of profit or trust under the laws of the State of Texas or the United States other than the office then held, at any time when the unexpired term of the Council Member then held shall exceed one (1) year and 30 days, such announcement or such candidacy shall constitute an automatic resignation of the Council position then held, as set forth in Article XVI, Sec. 65(b) of the Texas Constitution.

Prop. C: Shall Section 3.15(b) of the Charter be amended to authorize the city council to waive by an affirmative vote of four (4) or more Council Members the requirement that an ordinance be read in two separate meetings?

Explanation: State law does not require that all ordinances be read at two separate meetings before being adopted. However, the current Charter does. There are occasions when it would be expeditious and advantageous to dispense with the second reading (e.g., at the end of the year and during holiday seasons). This amendment allows waiver of the two-reading requirement if the waiver is approved by a super-majority vote of the City Council.

Amended Text: If approved, the section will read (in relevant part):

Section 3.15 - Ordinances in General.

(b) Procedure. An ordinance may be introduced and acted upon at any regular or special meeting of the Council. No ordinance shall be passed, except in cases of emergency, until the descriptive caption of the ordinance shall have been read in two separate meetings of the Council.

The requirement for considering ordinances and reading the descriptive caption thereof at two (2) separate meetings may be dispensed with: (1) where an ordinance relating to the immediate preservation of the public peace, health or safety is adopted as an emergency measure by a majority vote of the Council Members and such emergency ordinance shall take effect immediately upon its adoption and execution without a second consideration; or (2) when a majority vote of four or more Council Members determines through a separate motion that the first reading is sufficient for adequate consideration of the ordinance.

Prop. D: Shall Section 3.16 of the Charter be amended to reflect the fact that codes of technical regulations are available to the public digitally and free of charge?

Explanation: Technical regulations such as the *Building Bastrop Block Technical Manual* are often necessary to implement city policies regarding building and construction. State law does not require such rules to be posted online Whether to provide technical codes online is a local policy decision. With advances in technology, it is not always necessary or feasible to print and sell hardcopy versions of the City's Code of Ordinances. Instead, the technical codes can now be accessed by the public at-will and without fees from the City's home page.

Amended Text: If approved, the section will read (in relevant part):

Section 3.16 Codes of Technical Regulations.

The Council may adopt any standard code of technical regulations by reference thereto in an adopting ordinance. The procedures and requirements governing such an adopting ordinance shall be that prescribed for ordinances generally. A copy of each adopted code of technical regulations, as well as the adopting ordinance, shall be authenticated and recorded by the City Secretary pursuant to Section 3.17. Copies of any adopted code of technical regulations shall be made available by the City Secretary digitally without charge through the City's website for purchase at a reasonable price.

Prop. E: Shall Section 3.17(b) of the Charter be amended to reflect the fact that ordinances are available to the public digitally and free of charge?

Explanation: Ordinances are municipal rules and regulations. State law does not require ordinances be compiled into a published collection called the Code of Ordinances (i.e., codified). Whether to codify ordinances is a local policy decision. State law does not mandate how Codes of Ordinances are published when codified. Bastrop has a Code of Ordinances. With advances in technology, it is no longer necessary or feasible to print expensive hardcopy versions of the City's Code of

Ordinances. Instead, the ordinances can now be accessed by the public at-will and without fees from the City's home page.

Amended Text: If approved, the section will read (in relevant part):

Section 3.17 Authentication and Recording; Codification

(b) Codification. All City ordinances having the force of law shall be codified. The general codification shall be adopted by the Council by ordinance and shall be published online in loose leaf form and shall include this Charter and any amendments thereto. The official copy of the City Code in the office of the City Secretary shall be kept up to date and properly indexed. It shall not be necessary to repeat in this codification any technical codes adopted by reference. Copies of the City Code shall be available to the public digitally without charge through the City's website furnished to City offices, placed in libraries and public offices for free public reference and made otherwise available for purchase by the public at a reasonable price fixed by the Council. Amendments to the City Code shall also be made available for purchase by the public as they become available.

Prop. F: Shall Section 5.02 of the Charter be amended to conform with state law by stating that the term of office of municipal court judges shall be provided for by ordinance?

Explanation: State law states that the city council shall provide by ordinance for the term of office of its municipal judges. The term must be for a definite term of two or four years. Tex. Gov't Code § 30.00006(d). The Bastrop Code of Ordinances provides for a two-year term. The current Charter provision states that the term is three years.

Amended Text: If approved, the section will read (in relevant part):

Section 5.02 - Judge of the Municipal Court.

The Municipal Court shall be presided over by a Judge(s). The Judge(s) shall be nominated by the Mayor and appointed by the Council for a term <u>provided by ordinance</u> of three (3) years to run concurrently with the term of the office of the Mayor, or for the portion of such unexpired term as may remain at the time of the appointment.

Prop. G: Shall Section 10.04 of the Charter be amended to conform with state law by requiring petitions calling for initiative or referendum elections to comply with the Texas Election Code?

Explanation: Texas Election Code Ch. 277 states that once petitions can't be amended or supplemented (with certain exceptions) after they are filed. The current language is inconsistent with state law.

Amended Text: If approved, the section will read (in relevant part):

Section 10.04 Filing, Examination and Certification of Petitions
All papers comprising a petition for initiative or referendum shall be assembled and filed with the City Secretary as one instrument.... A petition may be amended or supplemented in compliance with the Texas Election Code at any time within ten (10) days after a notice of insufficiency has been sent by the City Secretary, by filing a supplementary petition. In such event, the same procedures shall then be followed by the City Secretary and Council as in the case of the original petition for the same purpose.

Prop. H: Shall Section 10.08 of the Charter be amended to conform with state law by requiring petitions calling for recall elections to comply with the Texas Election Code?

Explanation: Texas Election Code Ch. 277 states petitions can't be amended or supplemented (with certain exceptions) after they are filed. The current language is inconsistent with state law.

Amended Text: If approved, the section will read (in relevant part):

Section 10.08 - Recall Election.

All papers comprising a recall petition shall be assembled and filed with the City Secretary. Within thirty (30) days after the petition is filed, the City Secretary shall determine its sufficiency and, if found to be sufficient, shall certify this fact to the Council at its next regular meeting. A petition may be amended or supplemented in compliance with the Texas Election Code. If a recall petition is found to be insufficient, it may be amended within ten (10) days after notice of such insufficiency by the City Secretary, by filing a supplementary petition.

Prop. I: Shall Section 12.01 of the Charter be amended to provide that the number of Planning and Zoning commissioners shall be established by ordinance?

Explanation: State law does not specify the membership of a Planning and Zoning Commission; thus, it is a matter of local preference. The current size of the P&Z under the Charter is 9. This amendment removes reference to the size of the P&Z from the Charter and allows the City Council to set the size of the P&Z by ordinance.

Amended Text: If approved, the section will read (in relevant part):

Section 12.01 - Planning and Zoning Commission.

There shall be established a Planning and Zoning Commission which shall consist of nine (9) residents, serving staggered three-year terms.

Any vacancy on the Commission shall be filled by the Council for the remainder of the unexpired term in question. Members of the Commission shall serve without compensation and may be removed by the Council at its sole discretion. The Commission shall annually elect a Chair and a Vice Chair from among its

membership. A majority of members shall constitute a quorum. The Commission shall keep minutes of its proceedings and such minutes shall be of public record.

Prop. J: Shall Sections 14.03 and 14.04 of the Charter be repealed in their entirety as outdated, transitional provisions that are now irrelevant?

Explanation: These provisions are surplus language included as part of the 2010 Charter amendments as an explanation regarding the implementation of that collection of modifications, which included increasing terms of office from 2 to 3 years. They no longer have any relevance to the current Charter and will not affect any future amendments.

Section 14.03 - Submission of Charter Amendment to Election.

The City Council, in preparing these Charter Amendments, finds and declares that it is impracticable to segregate each subject so that the voter may vote "yes" or "no" on the same, for the reason that the Charter is so constructed that in order to enable it to properly function it is necessary that it should be amended as set forth on the seven (7) separate ballots presented. For this reason, the City Council directs that the ballot provisions related to these Charter Amendments be voted upon as set forth on the seven (7) ballot propositions presented, and that these amendments shall be submitted to the qualified voters of the City at an election to be held on the 2nd day of November, 2010. The various Charter Amendments approved by a majority of the qualified voters, voting at this election, shall become the Amended Charter of the City of Bastrop on the date the Council enters an order in the records of the City declaring that the various approved Charter Amendments are adopted and the Home Rule Charter is, thus, Amended to include the ballot changes approved by the voters of the City of Bastrop. No amendments to the Charter are intended nor shall same be made other than those specifically approved by the voters in the upcoming election, and as noted herein.

Section 14.04 - Transitional Elections/Staggered Terms.
In order to provide for a smooth transition from the former two-year terms for all Council Members to the three-year staggered terms set forth in Charter Section 3.02, the following transitional election rules shall be applied.

- (1) Staggering Terms. At the first Council meeting following the approval by the electorate of three year terms of office pursuant to the Amended Charter, then sitting Council Members, including the Mayor, shall draw lots to determine which Council places and/or Mayoral position shall be subject to a transitional length term of office, in order to provide for staggering of terms, the objective being that as stated in Section 3.02; specifically that each year, two (2) Council places, including the Mayoral position, shall be up for election for 3 year terms of office.
- (2) Implementation of Staggered Terms. No City Council Member shall be required to draw lots that would result in a transitional term of less than two years or exceeding four years to accomplish the staggering of terms as set forth herein.

(3) Deadline for Accomplishing Staggering Terms. The City Council shall accomplish staggering the terms of office for all Council Member places and the Mayoral position on or before the General Election that will occur in 2015.

Prop. K: Shall the Charter be amended throughout to replace gender -specific language with gender-neutral terminology?

Explanation: The Charter is replete with gender-specific terms, including:

• his/her,

• him,

• him/her

Amended Text: If approved, the gender-specific wording listed above will be replaced with they, their, or theirs, as appropriate in context.

Prop. L: Shall Section 4.01 be amended to allow the City Manager to reside in the City Limits and the 1-mile extra-territorial jurisdiction?

Explanation: State law does not dictate where the City Manager must reside; instead that is prescribed in the City Charter.

Amended Text: If approved, the text shall read as follows:

Section 4.01 Appointment, Qualifications and Compensation of the City Manager

The Council shall appoint a City Manager for an indefinite term, who shall be the chief administrative officer of the City. The City Manager shall be chosen by the Council by a majority vote of its entire membership and solely on the basis of executive and administrative training, experience, ability and character and without regard to political consideration. The City Manager need not be a resident of the City at the time of appointment but shall reside within the City limits or within the 1-mile extraterritorial jurisdiction while in office.

Prop. M: Shall section 3.08 be amended to allow the Mayor or 2 council members to appoint to boards and commissions subject to confirmation of the city council?

Explanation: The city charter prescribes that the Mayor appoint board and commission members, and the council confirm.

Amended Text: If approved, the text shall read as follows:

Section 3.08 Mayor and Mayor Pro Tem

The Mayor shall preside over the meetings of the Council and perform such other duties consistent with the office as may be imposed on the Mayor by this Charter and all

ordinances and resolutions passed in pursuance thereof. The Mayor may not vote, except in elections, to break a tie and as otherwise provided in this Charter. The Mayor shall have no veto power. The Mayor or two (2) councilmembers shall appoint members to all City boards and commissions, subject to confirmation by the Council.

Conclusion

This explanation is provided by the City of Bastrop as *educational material*, *only*. While the City Council voted in favor of calling the Special Election to place these propositions before the voters, the City of Bastrop as an entity does not advocate for or against passage of any particular item.

 - (3) an honorary or salutary recognition of a public official, public employee, or other citizen, except that a discussion regarding a change in the status of a person's public office or public employment is not an honorary or salutary recognition for purposes of this subdivision;
 - (4) a reminder about an upcoming event organized or sponsored by the governing body;
 - (5) information regarding a social, ceremonial, or community event organized or sponsored by an entity other than the governing body that was attended or is scheduled to be attended by a member of the governing body or an official or employee of the political subdivision; and
 - (6) announcements involving an imminent threat to the public health and safety of people in the political subdivision that has arisen after the posting of the agenda.

In April of 2023 our Victim Services coordinator became aware of a program known as *Projectbeloved.org.* This program offers a soft, emotionally safe remodel of victim interview rooms for different organizations throughout the country. Project Beloved is a non-profit organization committed to affirming life and supporting survivors of sexual violence. It was founded by Tracy Matheson after her daughter Molly was raped and murdered in 2017. Tracy and others made it their mission to assist in the improvement of conditions in which victims and victims' family members are cared for. This remodel does not require any modifications such as mechanical, electrical, and plumbing. The remodel is aesthetic in nature.

FISCAL IMPACT:

The project is completely funded by donations and has no adverse impact on the city's budget.

BACKGROUND:

The applicant has applied for a Zoning Concept Scheme for Valverde North property. The proposal is to place P5 Core zoning to appropriately incorporate multi-family.

The multifamily development is part of the larger Valverde development. Valverde North consists of 82 multifamily units located within 41 buildings, associated parking, and is on the northeastern side of the overall development. The buildings on the north will be consistent with the multifamily development directly south of this site.

LAND USE:

The existing land use is classified as P3 – Neighborhood per the Developers agreement. Low density residential areas. Planting is naturalistic and setbacks vary from relatively deep to shallow. The roads and blocks may be irregular to accommodate natural conditions.

Place Type P5 – Core is defined in the code as a higher density mixture of building types that accommodate commercial, retail, offices, row houses, and apartments. It has a tight network of streets, with wide sidewalks, steady street tree plantings, and buildings set close to the sidewalks. P5 is a highly walkable area. A continuous line of buildings is critical to define the public frontage and allow for visible activity along the street edge.

<u>Drainage</u>

A Zoning Concept Scheme must be accompanied by a Drainage Plan to ensure that the proposed development is feasible. A Final Drainage Plan has been reviewed and approved by the City Engineer. The site includes a detention pond in the natural flow of the land in the northwest corner of the tract in the neighboring parcel where they will be utilizing the detention pond within the single-family section. The maximum impervious cover allowed per the Development Agreement is 70%. This development proposes 62.1% coverage.

Utilities

Water service (domestic and fire) will be provided by the City of Bastrop via water line extensions provided by the developer from the existing water tank on the south side of SH 71. These lines will be designed according to the City's construction standards, as well as the Texas Commission on Environmental Quality's (TCEQ) requirements.

Wastewater collection and treatment will also be provided by the City of Bastrop via the line extension being installed along FM 969 to the existing 24-inch line by Bear Hunter Drive.

Electric service provided by Bluebonnet Electric.

Traffic Impact and Streets

From FM 969 the main access for the northern lot of Valverde will be Valverde Avenue, a major multimodal 80' ROW street. There are two entrances/exits into the Valverde North parcel. The internal streets are 55.5' in width and include parallel street parking. All streets and alleys are proposed to be for public use. Sidewalks will also be built within the development along the public streets.

POLICY EXPLANATION:



Texas Local Government Code

Sec. 211.006. PROCEDURES GOVERNING ADOPTION OF ZONING REGULATIONS AND DISTRICT BOUNDARIES. (a) The governing body of a municipality wishing to exercise the authority relating to zoning regulations and zoning district boundaries shall establish procedures for adopting and enforcing the regulations and boundaries. A regulation or boundary is not effective until after a public hearing on the matter at which parties in interest and citizens have an opportunity to be heard. Before the 15th day before the date of the hearing, notice of the time and place of the hearing must be published in an official newspaper or a newspaper of general circulation in the municipality.

(c) If the governing body of a home-rule municipality conducts a hearing under Subsection (a), the governing body may, by a two-thirds vote, prescribe the type of notice to be given of the time and place of the public hearing. Notice requirements prescribed under this subsection are in addition to the publication of notice required by Subsection (a).

The public meeting was noticed in the newspaper on 04/10/2024, Zoning Change signs were visibly placed in the front of the property on 04/11/2024 and notice was sent to property owners within 200 feet of the property boundary on 04/04/2024. Notice of the meeting was posted at least 72 hours in advance.

- (d) If a proposed change to a regulation or boundary is protested in accordance with this subsection, the proposed change must receive, in order to take effect, the affirmative vote of at least three-fourths of all members of the governing body. The protest must be written and signed by the owners of at least 20 percent of either:
 - (1) the area of the lots or land covered by the proposed change; or
 - (2) the area of the lots or land immediately adjoining the area covered by the proposed change and extending 200 feet from that area.
- (e) In computing the percentage of land area under Subsection (d), the area of streets and alleys shall be included.

At the time of this report, no protest has been received.

(f) The governing body by ordinance may provide that the affirmative vote of at least three-fourths of all its members is required to overrule a recommendation of the municipality's zoning commission that a proposed change to a regulation or boundary be denied.

If the Planning & Zoning Commission makes a unanimous recommendation of the denial of the zoning request, the City Council must have a minimum vote of three-fourths majority to approve the zoning request.

Compliance with 2036 Comprehensive Plan:

The Neighborhood Residential character area is for single family residential subdivision development, associated amenities such as parks, trails, open spaces, and public uses such as schools, fire stations, and more. Although individual developments may exhibit common features including home size, lot size, setbacks, impervious surface coverage, etc., the character area supports variations of these spatial and aesthetics characteristics, subject to appropriate transitions in form, scale, and density between blocks or adjacent developments. In some instances, transitions between developments and adjacent character areas may include higher density housing types or neighborhood oriented commercial uses of limited scale.

While the future land use map calls for this area to be single family residential, the surrounding area including the lot to the south is consistent with the higher density allowed thus matching the existing environment and the overall developer's agreement.

RECOMMENDATION:

Hold a public hearing and consider action on a recommendation for the Valverde North Zoning Concept Scheme, changing the zoning of 6.218 acres out of the Nancy Blakey Survey, Abstract Number 98, located west of FM 969, within the City of Bastrop from P3 Residential to P5 Core, as shown on Attachment 1.

- WHEREAS, the City of Bastrop, Texas (City) is a Home-Rule City acting under its Charter adopted by the electorate pursuant to Article XI, Section 5 of the Texas Constitution and Chapter 9 of the Texas Local Government Code; and
- WHEREAS, on or about November 03, 2023, Megan Reynolds (BGE) submitted a request for zoning modifications for a property located west of FM 969, within the City limits of Bastrop, Texas described as being 6.218 +/- acres of land out of the Nancy Blakey survey, Abstract number 98, more commonly known as Valverde North ("Property"); and
- **WHEREAS**, the City Staff has reviewed the request for zoning modifications, and finds it to be justifiable based upon the Future Land Use Designation for this Property; and
- **WHEREAS**, City Council has reviewed the request for zoning modifications, and finds the request to be reasonable and proper under the circumstances; and
- WHEREAS, in accordance with Texas Local Government Code Chapter 211, public notice was given, and a public hearing was held before the City of Bastrop Planning and Zoning Commission (P&Z) on April 25, 2024 and a recommendation was made to approve the zoning change; and
- **WHEREAS,** in accordance with Texas Local Government Code Chapter 211, public notice was given, and a public hearing was held before the City Council regarding the requested zoning modification; and
- WHEREAS, Texas Local Government Code Section 51.001 provides the City general authority to adopt an Ordinance or police regulations that are for good government, peace, or order of the City and are necessary or proper for carrying out a power granted by law to the City; and

WHEREAS, after consideration of public input received at the hearing, the information provided by the Applicants, and all other information presented, City Council finds that it is necessary and proper to enact this Ordinance.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BASTROP, TEXAS THAT:

- **Section 1:** The foregoing recitals are incorporated into this Ordinance by reference as findings of fact as if expressly set forth herein.
- Section 2: The Property, 6.218 +/- acres of land out of the Nancy Blakey survey, Abstract number 98, more commonly known as Valverde North, more particularly shown and described in Exhibit A which is attached and incorporated herein, is hereby rezoned from P3 Neighborhood to P5 Core. The City Manager is hereby authorized to promptly note the zoning change on the official Zoning Map of the City of Bastrop, Texas.
- **Section 3:** All ordinances, resolutions, or parts thereof, that are in conflict or inconsistent with any provision of this Ordinance are hereby repealed to the extent of such conflict, and the provisions of this Ordinance shall be and remain controlling as to the matters regulated, herein.
- **Section 4:** If any provision of this Ordinance or the application thereof to any person or circumstance is held invalid, that invalidity or the unenforceability will not affect any other provisions or applications of this Ordinance that can be given effect without the invalid provision.
- **Section 5:** It is hereby officially found and determined that the meeting at which this Ordinance was passed was open to the public, and that public notice of the time, place, and purpose of said meeting was given as required by the Open Meetings Act, Texas Government Code, Chapter 551.
- **Section 6:** This Ordinance shall be effective immediately upon passage and publication.



EXHIBIT A

License to Encroach Agreement

LICENSE TO ENCROACH AGREEMENT

THE STATE OF TEXAS \$

COUNTY OF BASTROP \$

This is a License Agreement between the City of Bastrop, acting by and through the City Manager (hereinafter "City") and Curtis Zavodny (hereinafter "Licensee") for the use of a certain Public Utility Easement located adjacent to 1615 Cedar Street, Bastrop, TX, also known as Zavodny Food Court (hereinafter "Agreement"), with such encroachments into the Public Utility Easement being described and depicted in this Agreement. Collectively, City and Licensee will be referred to as the "Parties."

RECITALS

The Parties acknowledge and agree on the following:

- 1. The property where the Zavodny Food Court and where the Public Utility Easement is located is shown on Exhibit A (hereinafter "Property"), which is attached and incorporated herein.
- 2. The encroachment in the Public Utility Easement is located adjacent to the parcel on which Licensee conducts activities which is shown more accurately on Exhibit B, which is attached and incorporated herein.
- 3. It is in the best interests of City and Utility Providers to have access to the existing and future infrastructure while allowing for encroachment of private property into the public utility easement.
- 4. The City finds that this Agreement will have negligible negative impacts on the public's use of the Public Utility Easement for the allowed encroachments.
- 5. This Agreement is supported by full and adequate consideration.

TERMS OF THE AGREEMENT

In consideration of the recitals and mutual covenants contained in this Agreement, the Parties agree to the following terms:

ARTICLE 1

PREMISES AND PRIVILEGES

For and in consideration of the terms, conditions, and covenants of this Agreement to be performed by Licensee, all of which Licensee accepts, City authorizes and permits Licensee to have the non-exclusive use of the public utility easement for the encroachment as shown in Exhibit B. The herein described privileges are transferable and shall convey with the sale of the property for the term of the agreement described in Article 2. Licensee accepts the condition of the Property as is, where is, and in its condition as of the effective date of this Agreement with no expectation that City will incur any expense in connection with the Property.

ARTICLE 2

TERM

The term of this Agreement shall be for a period of one year, beginning on the effective date of this Agreement. Unless and until the Agreement is terminated, this Agreement will renew itself automatically on each anniversary of the Agreement for an additional one-year term.

A. The City may terminate this agreement without cause. The City shall give written notice of the termination of the Agreement to Licensee in accordance with Article 7 below, which termination shall become effective on the date specified in the written notice.

ARTICLE 3

OBLIGATIONS OF LICENSEE

In addition to any other obligations imposed by this Agreement, Licensee accepts and will perform the following obligations:

- 1. Licensee shall not deny access to utility or telecommunication providers.
- 2. Licensee shall neither construct nor permit any buildings, structures, or improvements other than those listed in this Agreement without approval of the City of Bastrop in writing.
- 3. Licensee shall maintain and upkeep the Property, including that infrastructure that is encroaching in the Public Utility Easement, or remove those encroaching items if the items are not maintained or kept in good working order.
- 4. Licensee agrees all future work within the public utility easement will require a request through the permit process and approval by the City Manager
- 5. Licensee acknowledges that City may desire to repair, repave, or otherwise improve the public utility easement. In this event, Licensee shall allow the City access for such period of time as is necessary. The City also retains the right to access the property for all other rights incidental to and necessary in connection with any utility lines or facilities that may be located on or under the Property.

ARTICLE 4

NOT A CONVEYANCE OF REAL PROPERTY INTEREST

The Parties agree and acknowledge that this Agreement is not a conveyance or transfer of any tenancy, leasehold, or ownership interest of any kind in the Public Utility Easement.

ARTICLE 5

NO LIABILITY FOR CITY

The Parties agree that City shall have no liability for any losses or damages, direct or consequential, resulting from the loss of anything on the Property, real or personal, whether by theft, vandalism, negligence, act of God, or some other event or occurrence.

ARTICLE 6

NO ASSIGNMENT

Licensee shall not assign this Agreement without the prior written consent of the City.

ARTICLE 7

TERMINATION

This Agreement shall terminate upon the occurrence of any of the following:

- 1. Either the City or the Licensee may terminate this Agreement without cause by submitting 30 (thirty) days' written notice of such to the other Party.
- 2. Licensee defaults in the performance of its obligations under this Agreement, if such default continues for a period of ten (10) days after written notice to Licensee by City of the default.

Upon termination of this Agreement, Licensee shall remove all things placed within the public utility easement by Licensee or its agents, servants, or employees. Licensee shall restore the public utility easement as nearly as practical to its condition prior to the initial execution of this Agreement.

The failure of City to declare this Agreement in default shall not operate to bar or waive the right of City to terminate this Agreement because of any subsequent violation of the Agreement.

ARTICLE 8

MISCELLANEOUS GENERAL PROVISIONS

- A. <u>Attorney's Fees</u>. In any action brought for the enforcement of the obligations in this Agreement, the prevailing party shall be entitled to recover interest and reasonable attorney's fees.
- B. <u>Misrepresentation</u>. All terms and conditions with respect to this Agreement are expressly contained in this document. Licensee agrees that no representative or agent of the City has made any representation or promise with respect to this Agreement not expressly contained in the Agreement.
- C. <u>Paragraph Headings</u>. The paragraph headings are for convenience and reference and are not intended to define or limit the scope of any provision of this Agreement.
- D. <u>Notices</u>. Notices that are sent pursuant to any provision of this Agreement, at a minimum, shall be sent to the following:

Zavodny Food Court 1615 Cedar Street Bastrop, TX 78602

- E. <u>Choice of Law and Venue</u>. This Agreement is made and entered into by the Parties in Bastrop, Bastrop County, Texas, and is intended to be performed in Bastrop. This Agreement shall be construed in accordance with the laws of the State of Texas and the venue of any suits arising from this Agreement shall be Bastrop County, Texas.
- F. <u>Entire Agreement Amendment</u>: This Agreement including all exhibits constitutes the full and entire understanding and agreement between the Parties and supersedes any prior or contemporaneous written or oral agreements between the Parties. This Agreement may not be amended except by a written instrument signed by both Parties.
- G. <u>Rights and Remedies Cumulative</u>: The rights and remedies provided by this Agreement are cumulative, and the use of any one right or remedy by either Party shall not preclude or waive its right to use any or all other remedies. The rights and remedies provided in this Agreement are given in addition to any other rights the Parties may have by law, statute, ordinance, or otherwise.
- H. <u>Agreement Approval</u>: Each Party represents and warrants that all necessary approvals for this Agreement have been obtained, and the persons whose signatures appear below have the authority necessary to execute this Agreement on behalf of the Parties indicated.
- I. <u>Originals</u>: This Agreement may be executed in multiple or duplicate originals. A duplicate original or copy of this Agreement is as fully enforceable as an Original, whether the document is "hard copy" or electronic. This Agreement may be signed and a pdf copy of the document transmitted electronically which shall then constitute an original signature on the document.
- J. <u>Effective Date</u>: The effective date of this Agreement shall be on the date last signed by a Party.



WHEREAS, the Bastrop Economic Development Corporation ("BEDC") is a public instrumentality and non-profit industrial development corporation duly established and operating under Texas Local Government Code, Chapters 501 and 505, et seq., as amended, known as the Development Corporation Act of 1979 (the "Act"), and is acting with the approval of the governing body of the City of Bastrop, Texas (the "City"); and

WHEREAS, the BEDC was initially created by the voters of the City of Bastrop on January 21, 1995, with the adoption of a one-half cent sales and use tax ("sales tax") to be used for the purposes of economic development; and

WHEREAS, the original BEDC budget for Fiscal Year 2024 ("FY 2024") adopted by the City Council of the City of Bastrop on September 19, 2023, included sales tax revenues in the amount of \$4,458,090 anticipated from the one-half cent sales tax; and

WHEREAS, on November 7, 2023, City of Bastrop voters passed a proposition to reallocate a portion of the one-half cent sales tax toward street maintenance, thereby leaving the BEDC with revenues from a one-eighth cent sales tax; and

WHEREAS, the FY 2024 Annual Budget must be amended to account for this reduction in revenues; and

WHEREAS, it is hereby officially found and determined that the meeting at which this Resolution was passed was open to the public, and public notice of the time, place and purpose at which it was read was given in accordance with Chapter 551, Texas Government Code.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE BASTROP ECONOMIC DEVELOPMENT CORPORATION THAT:

SECTION 1. The Board hereby finds that all of the recitals above are true and correct and are incorporated herein as if restated in full.

SECTION 2. The Board approves an amendment to the FY 2024 Annual Budget reducing budgeted revenues ("Budget Amendment").

SECTION 3. The Board recommends and requests that the Budget Amendment approved hereby by the BEDC be considered and approved by the City of Bastrop City Council for the purposes stated herein.

This budget amendment reduces the following expenditures: personnel expenditures due to fewer employees; supplies and materials, maintenance and repairs, and occupancy to align with the reduction in staff; contractual services as the Blakey Lane project was reduced by \$330,000 and South to Lovers Lane project (\$2,950,000) was eliminated, engineering fees (\$15,000) reduced due to no further projects in place, and a reduction of Main Street support by \$25,000; marketing & advertising was reduced to more align with prior year spending; and capital outlay

was reduced by \$769,912 to remove the industrial park infrastructure but to include potential Auctronic site ready conditions.

NOTE: The decrease in expenditures is greater than the sales tax reduction which increases the available fund balance to \$3,586,132.

ARTIST AGREEMENT

between the

City of Bastrop & Robin Luck

This Artist Agreement ("Agreement") is made and entered into by and between the **City of Bastrop**, **Texas** ("City"), a municipal corporation and **Robin Luck** ("Artist"). The City and the Artist may be referred to herein singularly as the Party and together as the Parties.

RECITALS

- **WHEREAS**, the City issued a "Call to Artists" requesting proposals for original works of art depicting native or migratory birds of Central Texas in furtherance of the City's 2023 Bastrop Bird Junction, *Birds of Bastrop* (Attachment A); and
- WHEREAS, the City has determined that, once installed, the sculptures located in the City's historic district will contribute to the vitality and attractiveness of the urban streetscape, promote art and culture, and improve the touristic appeal of the City; and
- WHEREAS, the Artist submitted a proposal (Attachment B), depicting an original freestanding sculpture ("Artwork"), which was selected by the City and shall be incorporated into this Agreement; and
- **WHEREAS**, the City Council has the authority to enter into contracts such as this Agreement pursuant to Article II, Section 2.01 of the Bastrop Home Rule Charter.

NOW THEREFORE, in consideration of the mutual benefits described in this Agreement, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the City and the Artist agree as follows:

- 1. Scope of Work. The Artist agrees to design and create the Artwork consistent with the proposal (Attachment B). The Artist agrees to transport and install the Artwork with due care, in a good and workmanlike manner. The Artwork shall be of high-quality materials and fabrication.
- **2. Location.** The Artist agrees to install the completed work at the Bastrop Convention and Exhibit Center, located at Hwy 95 and Chestnut Street, Bastrop, Texas 78602, on the cement pad. (as shall be clearly demarcated by City staff).
- **3. Time of Completion.** The Artist agrees to commence creation of the Artwork upon receipt by the Artist of a written Notice to Proceed from the City. The Artist agrees to fully install the finished Artwork by **September 2024**. The time for completion may be extended by the City in writing if the Artist provides the City written notice that the Artist has incurred delays in the design, fabrication, and installation of the Artwork due to circumstances unforeseen by the Artist at the time of the signing of this Agreement.

4. Contract Sum. The City agrees to pay the Artist twenty-five thousand dollars (\$50,000) for the design, fabrication, transportation, and installation of the Artwork. The City shall pay the Artist fifty percent (50%), that being twenty-five thousand, (\$25,000), upon execution of this Agreement to assist Artist with supplies and fabrication of the Artwork. The City will pay the Artist the remaining fifty percent (50%), that being twenty-five thousand, (\$25,000) upon installation. Together, the two payments specified above shall be full and final compensation for all work performed and/or services rendered under this Agreement.

5. Artist's Work.

- a. The Artist agrees and acknowledges that they are an independent contractor. Nothing herein shall be construed as making the Artist an officer, employee, or agent of the City. The City has no right to supervise, direct, or control the Artist or the Artist's officers or employees in the means, methods, or details of the work to be performed by Artist.
- **b.** The Artist agrees and acknowledges that they are solely responsible for the design, materials, equipment, and processes necessary to complete the Artwork, including its transportation and installation.
- **c.** The Artist agrees to utilize materials that are safe, durable, and suitable for the outdoor exhibition of the Artwork.
- **d.** The Artist is solely responsible for installation of the artwork on the site and for protecting their artwork during the installation process. The Artist agrees to use best efforts to safeguard City personnel and members of the public from injury or loss in connection with the installation.
- **e.** The Artist must obtain City approval and coordination prior to blocking or altering pedestrian or vehicular traffic as may be necessary to install the Artwork.
- f. The Artist represents and warrants that the Artwork will be creatively unique and original. The Artist warrants and agrees that the Artwork, and its display or exhibition, will not violate any third-party rights. The Artist agrees that the City is not responsible for any third-party infringement of intellectual property rights.
- **g.** The Artwork may not contain advertisements; however, the Artist may discretely incorporate their signature and/or logo (trademark or service mark) into the design.

102

6. Ownership of Work.

- **a.** The Artist agrees that upon installation of the Artwork the City will obtain ownership of the Artwork.
- **b.** It is understood that the Artwork may be photographed by the public and that the City cannot and will not attempt to limit or control the public's use of those photographs or depictions. The Artist warrants and agrees that reproductions of the Artwork will not violate any third-party rights.
- c. In the event the City requires reproductions of the Artwork for commercial purposes, a separate licensing agreement may be executed between the Artist and the City. For purposes of this Agreement, the term "commercial" shall mean a use or purpose that results in direct monetary gain to the City above and beyond the administrative costs of producing, processing, and vending the commercial images.
- **d.** The City warrants and agrees that all representations of the Artwork by the City shall credit the Artist.
- e. The City reserves the right to relocate the Artwork to another site deemed suitable by the City (in its sole discretion), including storage as may be appropriate. Nothing herein shall be construed to obligate the City to display or exhibit the Artwork at a particular location in perpetuity.

7. Guarantee of Workmanship & Maintenance.

- **a.** For a period of 1 (one) year following the installation of the Artwork, the Artist agrees to replace or correct any material defects in the Artwork, whether caused by defects or failure in the design, workmanship, or materials used in the Artwork. In the event the City asks the Artist to repair damage to the art caused by vandalism, collision, or other unforeseeable environmental damage, the City shall reimburse the Artist for the reasonable material and labor costs for repairs.
- **b.** The City may, at its sole option, perform care, maintenance, and repair of the Artwork as it deems necessary. In conjunction therewith, the Artist may assist with any advice relating to the care of the Artwork.
- **c.** Notwithstanding the above, the City shall have no obligation to repair or maintain the Artwork whether due to normal wear and tear, gradual deterioration, reaction or contamination, acts of nature or vandalism, or any other cause, and may remove or repaint over the Artwork at any time.

103

- 8. Indemnity, Hold-Harmless & Release.
 - a. The Artist shall indemnify and hold harmless the City, and its officers, agents, and employees, from and against all claims, damages, losses, expenses, and legal fees including attorney's fees arising out of or related to the Artist's performance under this Agreement, whether to person or property and whether or not the claim, damage, or loss was known, unknown, foreseeable, or unforeseeable to the Parties. This includes the design, fabrication, transportation, and installation of the Artwork.
 - b. In regards to the installation of the Artwork by the Artist, the Artist recognizes and understands that there is an inherent danger in working near and around public streets, utility structures, and pedestrian pathways. The Artist further understands that while remote, there is a possibility during installation an injury or harm to the Artist could occur, the extent of which harm or injury is unknown. The Artist is specifically advised to use appropriate safety gear (e.g., gloves, hard-hats, traffic cones, etc.) when working on the installation. In the event of any injury or harm to the Artist as a result of their work on the installation, whether bodily injury or property damage, the Artist hereby releases, in full, the City, its officers, agents, affiliates, and employees from all present and future claims, causes of action, or demands that the Artist now has or may hereafter accrue in any way related to or arising out of the Agreement and the Artist's work whether known, unknown, foreseen, or unforeseen.
- 9. **Termination.** The parties agree that this Agreement may be terminated by the *City*, at any time prior to installation, with or without cause, upon written notice to the Artist by the City. In the event of termination by the City, unless the termination was related to misconduct or default by the Artist, the City shall compensate the Artist for all the reasonable expenses, services, and materials performed or acquired by the Artist up to the date of the termination (not to exceed the total stated compensation under this Agreement). The parties agree that this Agreement may be terminated by the *Artist*, at any time prior to installation, with or without cause, upon written notice to the City and reimbursement (in full) of any payments made to the Artist by the City.
- 10. Breach. The parties agree that it shall be a breach of this Agreement for either party to fail to fulfill its obligations as stated herein. The obligations created by this Agreement may be enforced civilly in Bastrop County Court. Prior to seeking judicial remedies, the non-breaching party shall first send the other party written notification of the act or omission constituting breach and provide thirty (30) days to cure.
- **11. Severability.** If a court finds or rules that any segment of this Agreement is invalid, unlawful, or otherwise unenforceable, that segment shall be severed, and the remainder of the Agreement shall continue to be binding on the parties.

- **12.** Conflicting Provisions. If there is a conflict between a provision in any Additional Agreement Documents and a provision in the remainder of this Agreement, the latter controls.
- **13. Law Governing & Venue.** This Agreement is governed by the law of the *State of Texas* and a lawsuit may only be prosecuted on this Agreement in a court of competent jurisdiction located in or having jurisdiction in *Bastrop County, Texas*.
- **14. Integrated Agreement.** This Agreement contains all of the terms, considerations, understandings, and promises of the Parties. It should read as a whole and its terms can only be modified by an instrument in writing signed by both Parties. All attachments referenced herein are hereby incorporated into this Agreement.
- **15. Effective Date:** This Agreement shall be effective as of the date of final execution by the parties.







A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BASTROP, TEXAS APPROVING EXPENDITURE OF CITY FUNDS FOR MAYOR LYLE NELSON TO ATTEND AN EVENT, FUNCTION, AND/OR CONVENTION; PROVIDING FOR EXECUTION OF ALL NECESSARY DOCUMENTS; PROVIDING FOR REPEALER; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, pursuant to Texas Local Government Code Section 51.001, the City of Bastrop ("City") has general authority to adopt an ordinance, resolution, or police regulation that is for the good government, peace, or order of the City and is necessary or proper for carrying out a power granted by law to the City; and

WHEREAS, the City Council passed Resolution No. R-2024-49 approving the policy of the City of Bastrop stating no city funds shall be expended for the mayor's attendance at any event, function, or convention without prior approval of the City Council; and

WHEREAS, the City finds that adoption of this Resolution is in the interest of the general health, safety, welfare, and morals of the community.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BASTROP, TEXAS, THAT:

<u>Section 1.</u> All of the above premises are hereby found to be true and correct legislative and factual findings of the City Council of the City of Bastrop, Texas, and are hereby approved and incorporated into the body of this Resolution as if copied in their entirety.

<u>Section 5.</u> Severability: Should any of the clauses, sentences, paragraphs, sections, or parts of this Resolution be deemed invalid, unconstitutional, or unenforceable by a court of law or administrative agency with jurisdiction over the matter, such action shall not be construed to affect any other valid portion of this Resolution.

Section 6. Effective Date: This Resolution shall take effect upon the date of final passage noted below.

<u>Section 7.</u> **Proper Notice & Meeting:** It is hereby officially found and determined that the meeting at which this Resolution was passed was open to the public, and that public notice of the time, place, and purpose of said meeting was given as required by the Open Meetings Act, Texas Government Code, Chapter 551.
