BACKGROUND/HISTORY:

Texas Parks and Wildlife grant program deadline is August 1st. Discussions with TPWL has yielded the potential to qualify for a grant of \$750,000 that can be used for the design and/or development of outdoor activities such as the course. The match would come from the proposed \$15M borrow for park facilities which includes \$10M for the bridge rehabilitation and other associated improvements throughout the City. The amount allocated to this potential project from the bond is \$600,000.

BACKGROUND/HISTORY:

The historic German Casino, formerly located at the intersection of Fayette and Farm Streets, collapsed in 2024. Since the collapse, a local nonprofit organization has taken the initiative to collect and preserve bricks and other salvageable materials from the site with the long-term goal of reconstructing a community gathering space that honors and showcases the historical significance of the original structure.

Through this proposed grant and partnership with the nonprofit, the City would begin the initial planning process and pursue a feasibility study to explore the potential reconstruction of the German Casino as a cultural and historical asset for the community.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BASTROP, TEXAS, AUTHORIZING THE CITY MANAGER TO SUBMIT A GRANT APPLICATION TO THE LOWER COLORADO RIVER AUTHORITY (LCRA) IN THE AMOUNT OF \$100,000.00 FOR THE CREATION OF AN EDUCATIONAL FACILITY HIGHLIGHTING THE HISTORIC GERMAN CASINO; AUTHORIZING THE CITY MANAGER TO ACT ON BEHALF OF THE CITY IN ALL MATTERS RELATED TO THE APPLICATION; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the historic German Casino, formerly located at the intersection of Fayette and Farm Streets, was a notable cultural and community structure that collapsed in 2024; and

WHEREAS, a local nonprofit organization has since undertaken efforts to collect and preserve bricks and other salvageable materials from the site with the goal of reconstructing a facility that pays tribute to the original structure and its historical significance; and

WHEREAS, the City of Bastrop supports the preservation of local history and the creation of cultural and educational opportunities for the community; and

WHEREAS, the Lower Colorado River Authority (LCRA) provides funding for community development and educational initiatives through its grant programs; and

WHEREAS, the City of Bastrop desires to partner with the nonprofit organization to pursue a feasibility study and preliminary planning for the development of an educational facility that highlights the history of the German Casino; and

WHEREAS, the requested grant funding in the amount of \$100,000.00 would support these initial efforts and align with the City's goals for historical preservation and community enrichment.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BASTROP, TEXAS:

SECTION 1. The City Council hereby authorizes the City Manager to submit a grant application to the Lower Colorado River Authority (LCRA) in the amount of \$100,000.00 to support the creation of an educational facility highlighting the historic German Casino.

SECTION 2. The City Manager is further authorized to take all necessary actions, including execution of related documents, in connection with the grant application and administration, should the grant be awarded.

Bastrop Independent School District (BISD) is currently constructing a public safety facility and related improvements near Lover's Lane. As part of this project, BISD has requested that the City waive the associated building permit fees.

While requesting this waiver for the public safety facility, BISD continues to pay inspection fees for its other ongoing construction projects throughout the district. This ongoing partnership has generated positive revenue for the City and reflects the collaborative relationship between BISD and the City of Bastrop.

WHEREAS, Bastrop Independent School District (BISD) is constructing a public safety facility and associated improvements near Lover's Lane to support the safety, education, and well-being of students and staff; and

WHEREAS, BISD has requested a waiver of building permit fees for this project; and

WHEREAS, BISD continues to pay inspection fees for other projects within the City of Bastrop, generating positive revenue and demonstrating a productive partnership with the City; and

WHEREAS, the City Council finds that waiving the building permit fees for this particular facility is in the public interest and reflects the City's ongoing support for educational and safety initiatives;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BASTROP, TEXAS:

<u>Section 1.</u> The City Council hereby authorizes the waiver of building permit fees for the Bastrop Independent School District's public safety facility and associated improvements located off Lover's Lane.

<u>Section 2.</u> This waiver applies only to building permit fees and does not extend to other regulatory or third-party fees that may be required by law.

<u>Section 3</u>. Should any provision of this Resolution be found to be invalid or unenforceable by a court of competent jurisdiction, such invalidity shall not affect the remaining provisions, which shall remain in full force and effect.

<u>Section 4.</u> This Resolution shall take effect immediately upon its passage.

WHEREAS, Austin Water, a department of the City of Austin, provides regional water education and outreach programs that promote water conservation, watershed protection, environmental sustainability, and public awareness; and

WHEREAS, Austin Water has requested use of a City-owned site in Bastrop for the purpose of conducting outdoor environmental education programming for students and the general public; and

WHEREAS, the City of Bastrop supports educational partnerships and regional collaboration that provide accurate and up-to-date information on water resource management and conservation; and

WHEREAS, the use of the site will be coordinated with City staff to ensure alignment with public access requirements, safety protocols, and overall City operations;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BASTROP, TEXAS:

<u>Section 1.</u> The City Council hereby authorizes Austin Water to utilize a designated Cityowned site in Bastrop for educational programming purposes, including but not limited to water education, environmental sustainability instruction, and public outreach events.

<u>Section 2.</u> Austin Water shall coordinate all activities with the City Manager or their designee to ensure compliance with applicable City policies, public safety standards, and scheduling requirements.

<u>Section 3.</u> This Resolution shall take effect immediately upon its passage.
