MINUTES OF BASTROP CULTURAL ARTS COMMISSION

October 4, 2022

1. **CALL TO ORDER:** 1:00 p.m. and with quorum in attendance, Maria called the meeting to order.

2. **CITIZEN COMMENTS:** None

6. **WORKSHOP**
