CALL TO ORDER: 1:00 p.m. and with quorum in attendance, Maria called the meeting to order.

- 1. **CITIZENS COMMENTS:** : Kaye stated that Sylvia Carrillo, the city manager would like a mural at river walk and would like us to put out an artist call. TX Dot has approved it. Kaye asked to be put on on for a workshop for next meeting.
