<u>4A: Main Street Manager Report:</u> 1 new business, Sage and Co. opened at 913 Main Street. Attended Texas Downtown Association Annual Conference on November 1-4 in San Marcos. Conference explored topics of successful redevelopment projects and programs, revitalization and small business grants, and also offered networking opportunities. BEDC report presentation was October 17th. Report detailed the MSAB's project for FY 2022 and projects for FY2023. Also highlighted how the \$50,000 BEDC funds were budgeted for the current fiscal year along with programming and events. Parks and Recreation Master Plan Committee is asking for

one ambassador from MSAB to help plan how parks will connect the downtown space.

<u>4B. Design Committee Report</u>: Planters and plants have been installed. A lot of trash has been collected from planters but hopefully trashcan installation will help diminish the issue. Art crosswalk installation was rescheduled due to weather. Recycling cans and benches were delivered last week and should be installed soon.

Help needed with passing out bags and ballot boxes. Band will be playing by museum. December 10th is Lost Pines Christmas with parade happening at 6:00p. Window decorating for downtown businesses, hoping to close streets all day.
