The bill that was passed was the malpractice reform New Mexico has lost many of their doctors and now that this bill was passed the hope is to get doctors to come back and work for New Mexico. Another bill that was passed was Compact Licensure Bill. Also, HB61 was passed to go after the bad people that are committing crime after officers this is a felony now. The mining sculpture money was approved through culture affairs, the sculpture is going to be 10 feet high and 18 feet wide. Ramos can not wait to see this go up in Bayard to recognize the miners that go out a risk there lives to produce copper. Bayard received one million dollars. \$250,000 for restrooms at the little league and \$750,000 to road maintenance and drainage. Ramos thanked everyone who went to Santa Fe for legislative session.

Representative Luis Terrazas spoke on the legislative update.

("AGREEMENT" OR "LOAN/GRANT AGREEMENT") BY AND BETWEEN THE NEW MEXICO FINANCE AUTHORITY ("NMFA," OR "LENDER/GRANTOR") AND THE CITY OF BAYARD, GRANT COUNTY, NEW MEXICO ("BORROWER/GRANTEE"), IN THE TOTAL AMOUNT OF ONE MILLION TWO HUNDRED TEN THOUSAND DOLLARS (\$1,210,000), EVIDENCING AN OBLIGATION OF THE BORROWER/GRANTEE TO UTILIZE THE LOAN/GRANT AMOUNT SOLELY FOR THE PURPOSE OF FINANCING THE COSTS OF CONSTRUCTION OF WASTEWATER IMPROVEMENTS INCLUDING A NEW GRAVITY SEWER MAIN AND A NEW FORCE MAIN FROM THE NEW LIFT STATION FOR CONNECTION TO THE MANHOLES LOCATED ALONG OAK STREET, AND SOLELY IN THE MANNER DESCRIBED IN THE LOAN/GRANT AGREEMENT; PROVIDING FOR THE PLEDGE AND PAYMENT OF THE ADMINISTRATIVE FEE, INTEREST AND LOAN AMOUNT OF TWO HUNDRED FORTY-TWO THOUSAND DOLLARS (\$242,000) SOLELY FROM THE REVENUES RECEIVED FROM THE BORROWER/GRANTEE'S ORDINANCE NO. 7-84 ADOPTED ON JULY 16, 1984 WITH AN EFFECTIVE OF JANUARY 1, 1985, IMPOSING A ONE-FOURTH OF ONE PERCENT (0.25%) INCREMENT WHICH TAXES HAVE BEEN DE-EARMARKED AND ARE NOW ENFORCEABLE UNDER NMSA 1978, § 7-19D-9, AS AMENDED, AND ACCEPTANCE OF A GRANT AMOUNT OF NINE HUNDRED SIXTY-EIGHT THOUSAND DOLLARS (\$968,000); CERTIFYING THAT THE LOAN/GRANT AMOUNT, TOGETHER WITH OTHER FUNDS AVAILABLE TO THE BORROWER/GRANTEE, IS SUFFICIENT TO COMPLETE THE PROJECT; APPROVING THE FORM OF AND OTHER DETAILS CONCERNING THE LOAN/GRANT AGREEMENT; RATIFYING ACTIONS HERETOFORE TAKEN; REPEALING ALL ACTION INCONSISTENT WITH THIS RESOLUTION; AND AUTHORIZING THE TAKING OF OTHER ACTIONS IN CONNECTION WITH THE EXECUTION AND DELIVERY OF THE LOAN/GRANT AGREEMENT.

**WHEREAS**, the New Mexico Department of Transportation is soliciting applications for the Department’s Fiscal Year 2027 Transportation Project Fund; and

**WHEREAS**, the purpose of the Transportation Project Fund is to assist local and tribal governments with the following: (1) environmental and other studies; (2) planning; (3) design; (4) construction; and (5) acquisition of rights of way necessary for the development of transportation infrastructure, which includes highways, streets, roadways, bridges, crossing structures, electric vehicle chargers, and parking facilities, including all areas for vehicular, transit, bicycle or pedestrian use for travel, ingress, egress and parking; and

**WHEREAS**, having reviewed and considered the regulations and the application covering administration and use of said funds; and

**WHEREAS**, having determined that Survey and Design of Royal Street Roadway, ADA and Drainage Improvements to consist of Survey, Geotechnical Investigation, Drainage Analysis, Environmental Certification and Project Drainage qualifies for grant funding; and

**WHEREAS**, in official session that the City of Bayard determines, resolves, and orders as follows:

That the project Survey and Design of Royal Street Roadway, ADA and Drainage Improvements to consist of Survey, Geotechnical Investigation, Drainage Analysis, Environmental Certification and Project Drainage has a priority standing.

**WHEREAS**, the City of Bayard qualifies for the Match Waiver because the City of Bayard has a limited tax base, which limits the funding for meeting the proportional 5% matching share; and a fund exists in the NMDOT appropriated by the New

Mexico State Legislature for Public Entities in need of "hardship" match money and the City of Bayard requests participation in this Match Waiver Program; and

**Financial Overview and Expenditure Increases**

City Clerk-Treasurer Martha Salas opened the workshop by reviewing the third-quarter financial report with the Council. Following this review, Clerk-Treasurer Salas detailed several projected cost increases for Fiscal Year 2027. Key budgetary pressures include rising fees for dispatch services provided by Grant County, as well as an increase in the city's contribution to the Mining District senior lunch program for Bayard's portion. Furthermore, insurance premiums are expected to rise significantly, with health insurance projected to increase by 15% and other coverage—including property, vehicle, liabilities, and workers' compensation—expected to rise by 10%.

**Public Safety and Infrastructure Costs**

The Council also addressed the necessity of replacing the radio systems for public safety departments. To manage this expense, Councilor Medina suggested utilizing Law Enforcement and Fire Protection funds, which would alleviate the burden on the general budget. Additional inflationary pressures were noted regarding the rising costs of fuel, utilities, and materials required for various infrastructure projects.

## Employee Compensation and Benefits

During the discussion on employee raises, the Council weighed the fact that the city currently covers 100% of health insurance premiums for all employees. Because the 15% insurance hike represents a cost of over \$72,000 per year to the city, the Council determined that a \$0.50 per hour raise for all employees would be a reasonable and sustainable increase for the upcoming fiscal year.

## Utility Rates and CPI Adjustments

To help offset these rising expenses, Clerk-Treasurer Salas recommended an increase in utility rates. Under the current ordinance-approved Consumer Price Index (CPI) increases, the minimum utility bill was calculated to rise from \$112.67 to \$117.97, representing a total increase of \$5.05. The specific CPI figures provided were 4.7% for Water and Sewer, 4.8% for Garbage and Trash, and 4.6% for Wastewater. Councilor Medina requested that the Council consider a more uniform approach; subsequently, the Council reached a consensus directing Clerk-Treasurer Salas to budget a flat 4% increase across all utilities.

#### Training and Site Visit – May 5, 2026

On May 5, 2026, Paul Muñoz, Armando Fletcher, and I attended a training session at the Bayard Community Center provided by the New Mexico Rural Water Association (NMRWA). The training, led by Britany Coriz, focused on operator responsibilities and the Consumer Confidence Report (CCR).

Following the training, Ms. Coriz visited the wastewater treatment plant, where we provided her with a full walkthrough of the facility.

#### Equipment Issue – Bar Screen Alarm (May 12, 2026)

On May 12, 2026, at approximately 3:30 PM, the bar screen system triggered an alarm that stopped the rake. After resetting the alarm, the issue reoccurred approximately one hour later. An electrician was contacted, and after initial troubleshooting attempts, it was determined that an on-site visit was necessary.

Matt Dement responded and conducted further diagnostics. It was determined that the issue originates within the control panel. The problem has been temporarily resolved; however, additional troubleshooting will be required to implement a permanent fix.

#### Meter Evaluation – May 11, 2026

On May 11, 2026, a representative from Yukon visited the site to evaluate the facility's meters and provide a quote for calibration services.

#### Stantec Scoping Meeting – May 13, 2026

On May 13, 2026, a scoping meeting was held with Stantec. The City will move forward with the development of a Preliminary Engineering Report (PER) to establish a comprehensive plan for the wastewater treatment plant.

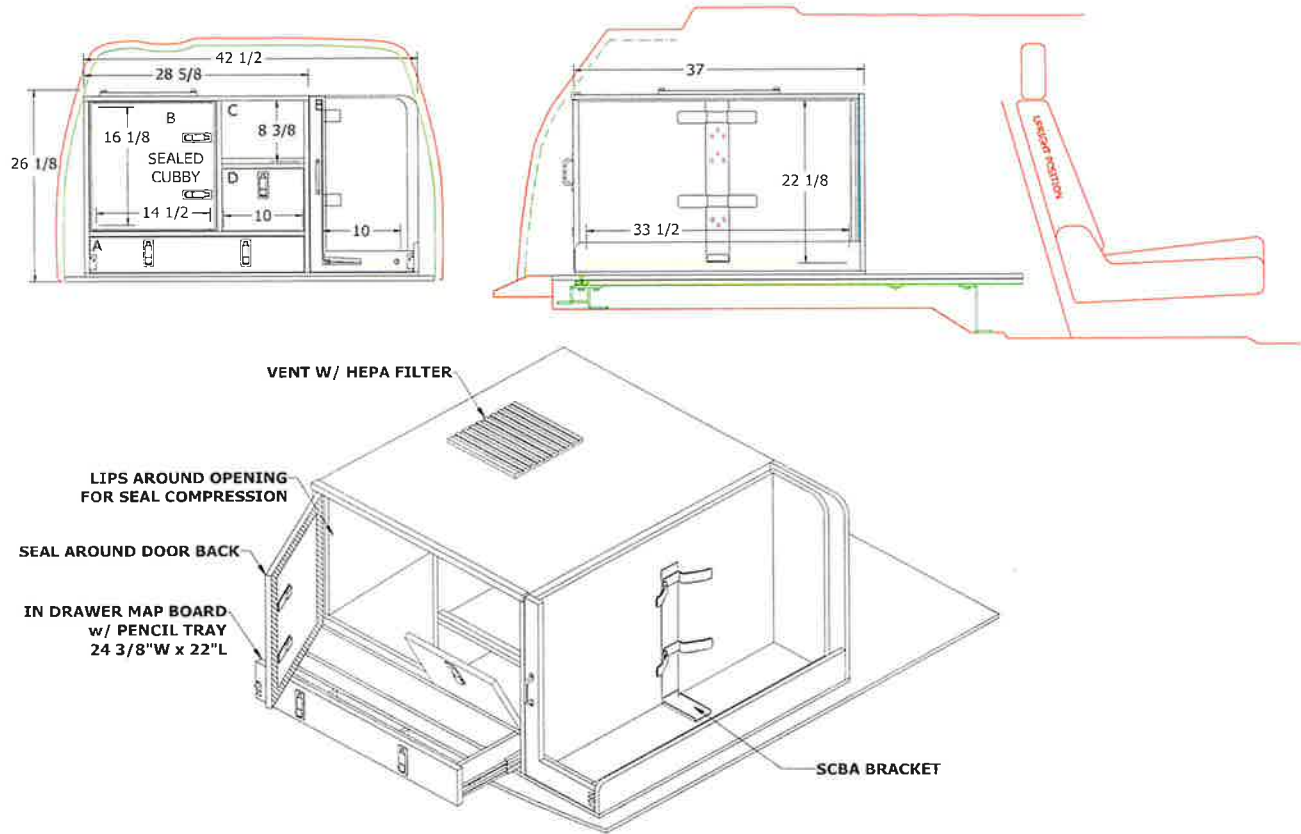

RESOLVED, Entity’s John L. **PLANNING FUNDING AGREEMENT  
BETWEEN THE STATE OF NEW MEXICO  
INTERSTATE STREAM COMMISSION  
AND THE CITY OF BAYARD**

**THIS AGREEMENT** is made and entered into by and between the New Mexico Interstate Stream Commission, 407 Galisteo Street, Santa Fe, New Mexico, 87501 (“NMISC” or “Commission”) and the City of Bayard (“Bayard”). Collectively, the Commission and Bayard are referred to as the “Parties.”

**RECITALS**

**WHEREAS**, pursuant to NMSA 1978, § 72-14-3, the NMISC is authorized to investigate water supply, to develop, to conserve, to protect and to do all other things necessary to protect, conserve and develop the water and stream systems of this state; and

**WHEREAS**, in the 2004 Arizona Water Settlements Act, Pub. L. 108-451, (“AWSA”) the Congress of the United States appropriated funds to be administered by the NMISC to finance water utilization projects to meet water supply demands in the Southwest Water Planning Region of New Mexico, as determined by the NMISC; and

**WHEREAS**, in the New Mexico Unit Fund Act, NMSA 1978, § 72-14-45, the New Mexico Legislature created the New Mexico Unit Fund in the State Treasury, directed money in the New Mexico Unit Fund to “be used to pay the costs of water utilization projects to meet water supply demands in the southwest water planning region of New Mexico that encompasses Catron, Grant, Hidalgo and Luna counties,” and directed the Water Trust Board (“WTB”) to evaluate and recommend proposed projects to the Commission for final funding determinations; and

**WHEREAS**, on September 24, 2024, the Commission approved the 2024 New Mexico Unit Fund Pilot Cycle Policy to develop with the WTB an application and evaluation process to fund planning and design phases of water utilization projects that meet water supply demands (“Pilot Cycle I”); and

**WHEREAS**, in one of its two Pilot Cycle I applications, Bayard proposed developing an asset management plan aimed at improving the City’s decision-making to increase the efficiency and reliability of its potable water distribution system (“Project”); and

**WHEREAS**, following the Pilot Cycle I application process, the Water Trust Board evaluated proposed planning and design projects and on August 27, 2025, recommended certain planning and design projects for the Commission’s approval, including the Project proposed by Bayard; and

**WHEREAS**, on October 16, 2025, the Commission approved the planning and design projects recommended by the WTB for funding under Pilot Cycle I, including the Project proposed by Bayard, and allocated up to \$223,210 for use towards the Project (“Allocated Amount”); and

**WHEREAS**, in accordance with the Commission’s approval of the Allocated Amount and terms of this agreement, the NMISC will provide funds to Bayard for the Project on a reimbursement basis.

**NOW, THEREFORE**, in consideration of the mutual benefits, covenants and obligations contained herein, the Parties hereby agree as follows:

### **AGREEMENT**

#### **ARTICLE I. PROJECT DESCRIPTION, FUNDING AMOUNT, SPENDING DEADLINE AND TERM**

- A. Project Description. Bayard shall complete an asset management plan including but not limited to, document digitization, GIS development, asset information system creation, risk and criticality assessment, and long-term financial and capital planning as provided in more detail in Exhibit A, Scope of Work and Project Budget, attached and incorporated by reference. The Project will help establish a risk-based asset management framework that assists Bayard in planning to proactively manage its water utilization infrastructure, to increase the efficiency and reliability of its potable water distribution system, and to align water distribution system improvements to support regionalization efforts.
- B. Funding Amount. Total reimbursements for the Project shall not exceed \$223,210 (“Funding Amount”) pursuant to the Project Budget set forth in Exhibit A. Any alteration, modification, or change to the Project Budget, described in Exhibit A, must receive prior written approval by the NMISC.
- C. Spending Deadline. The Parties agree that the Funding Amount must be expended, as defined in Article IV of this Agreement, before June 30, 2027. That date is referred to throughout the remainder of this Agreement as the “Spending Deadline.” On the Spending Deadline, any part of the Funding Amount not expended will no longer be available to Bayard under this Agreement, and any expenditures made after the Spending Deadline shall not be reimbursed. On the Spending Deadline, Bayard will have 60 calendar days to submit a Final Report, pursuant to Article V of this Agreement, and the final Request for Reimbursement, pursuant to Article II of this Agreement.
- D. Term. This Agreement shall be effective as of the date of execution by the last signatory (“Effective Date”). It shall terminate 110 calendar days after the Spending Deadline, unless sooner terminated by the Parties, as provided herein.

## **ARTICLE II. REQUESTS FOR REIMBURSEMENT PROCEDURES AND DEADLINES**

- A. **Request for Reimbursement Procedure.** Within 60 calendar days of the Effective Date of this Agreement, the NMISC will issue a Notice to Proceed (“NTP”) to Bayard. Upon the issuance of this NTP, the NMISC will reimburse Bayard in accordance with the limitations and procedures outlined in this Agreement. Bayard shall request reimbursement for activities under this Agreement by submitting to the NMISC representative a Request for Reimbursement. Requests for Reimbursement are subject to the following procedure:
- i. Bayard must submit to the NMISC a signed electronic copy for each Request for Reimbursement using the form attached to this Agreement as Exhibit B, Request for Reimbursement.
  - ii. Each Request for Reimbursement shall contain proof of payment by Bayard, or proof of liabilities incurred by Bayard, in the form of copies of invoices and a certification by Bayard’s representative as designated in Article VI herein. Invoices must include the Purchase Order Number, an invoice number, and the remittance address matching the address in the NMISC’s SHARE system. The certification must state that the expenditures are valid liabilities incurred by Bayard, for services rendered by a third party or goods received for the implementation of the Project.
  - iii. Requests for Reimbursement shall be submitted by Bayard to the NMISC within 30 calendar days of the date each respective invoice is paid or received by Bayard.
  - iv. Obligated but unpaid invoices received by Bayard from third-party contractors or vendors may be reimbursed if the invoices comply with the provisions of this Agreement.
    - i. Bayard shall make payment to those contractors or vendors within five business days from the date of receiving reimbursement from the NMISC or in a shorter period than the NMISC may prescribe in writing.
    - ii. Bayard is required to certify to the NMISC proof of payment to the third-party contractor or vendor within five business days from the date the NMISC reimburses Bayard.
  - v. Upon receipt of a Request for Reimbursement from Bayard, the NMISC Representative will review the Request for Reimbursement and any attached documentation for completeness and compliance with this Agreement. If any information is unclear or missing, the NMISC Representative will communicate in writing with Bayard regarding the unclear or missing information. Upon notification of incompleteness, Bayard shall have five business days to submit to the NMISC a corrected Request for Reimbursement or necessary supplemental documentation.
  - vi. Bayard shall provide necessary supporting documentation, which may include Bayard’s third-party contracts or agreements for implementing the Project, as requested by the NMISC.
  - vii. Each Request for Reimbursement must be approved for reimbursement by the NMISC Representative identified in Article VI. Upon approval for reimbursement by the NMISC Representative, the NMISC shall release reimbursement funds to Bayard.
  - viii. Approval of the final Request for Reimbursement is contingent upon the submission and approval of a Final Report for the Project, pursuant to Article V of this Agreement.

The NMISC may approve the final Request for Reimbursement after the date of termination of this Agreement.

- ix. The terms and conditions of this Article shall survive the termination of this Agreement.

B. End-of-Fiscal-Year Requests for Reimbursement. For work completed by June 30<sup>th</sup> of any given year, Bayard must submit all invoices by July 15<sup>th</sup> of that same year in order to be reimbursed due to New Mexico fiscal year deadlines. Any invoice covering expenses incurred prior to June 30<sup>th</sup> but received by the NMISC after July 15<sup>th</sup> may not be reimbursed.

C. Limitations on Reimbursement Processing. Bayard's failure to abide by the requirements set forth in Article II may result in the denial of its Request for Reimbursement or in delays in processing Requests for Reimbursement. The NMISC has the right to reject a Request for Reimbursement for the Project unless and until it is satisfied that the expenditures in the Request for Reimbursement are for permissible purposes within the meaning of the Project Description, set forth in Exhibit A, and that Bayard is otherwise in compliance with this Agreement. The NMISC's ability to reject any Request for Reimbursement is in addition to, and not in lieu of, any other legal or equitable remedy available to the NMISC due to any violation of this Agreement by Bayard.

### **ARTICLE III. LIMITATION ON THE NMISC'S OBLIGATION TO MAKE REIMBURSEMENTS TO Bayard**

- A. The disbursement of any and all of the Funding Amount is expressly conditioned upon the following:
  - i. Bayard's expenditures shall be made in accordance with the Scope of Work and Project Budget, set forth in Exhibit A.
  - ii. Bayard's Requests for Reimbursement and submittal of supporting documentation are timely and in accordance with the procedures set forth in this Agreement.
  - iii. The Funding Amount must be spent in accordance with all applicable laws, regulations, policies, and guidelines, including, but not limited to, the New Mexico Procurement Code, NMSA 1978, § 13-1-21 et. seq., or any local procurement ordinance, where applicable. The Project's expenditures and liabilities must be accounted for in accordance with the State's Model Accounting Practices, as amended from time to time.
  - iv. The Project must provide a public benefit above and beyond any incidental benefit to private entities in accordance with applicable law, including, but not limited to, Article IX, Section 14 of the Constitution of the State of New Mexico.
  - v. The Funding Amount shall not be used to purchase capital assets. For the purposes of this Agreement, "capital assets" are defined as "assets of a long-term character that are intended to continue to be held or used, including land, buildings, machinery, furniture and equipment."
  - vi. The total amount to be reimbursed by the NMISC to Bayard shall not exceed the Funding Amount under any circumstances. Any expenditure that is not included in the Project Budget, provided in Exhibit A, shall not be reimbursed from the Funding Amount.

- vii. The NMISC assumes no obligation to provide additional funding or support to Bayard beyond the terms of this Agreement. In the event that funding in excess of the Funding Amount is necessary to complete the Project, Bayard expressly commits to securing all additional funding that may be necessary to complete the Project.
- viii. Any NMISC reimbursement, inspection, review, and approval of the Project or any part of the Project, including the work conducted pursuant to the Project Description, Project plans or designs, Quarterly and Final Reports, or approval of any Reimbursement Requests are only for purposes of compliance with the terms of this Agreement. NMISC reimbursement, inspection, review and approval shall not be interpreted as a warranty or guarantee of any kind. Bayard is and shall remain responsible for the completion and success of the Project. Reimbursement, inspection, review or approval by the NMISC or NMISC employees does not relieve Bayard, or any professional engineer hired by Bayard, of all responsibility for the overall integrity of the Project, adequacy of the design, safety, or compliance with all applicable laws and regulations. This provision shall survive termination of this Agreement.
- ix. The Parties agree that the State of New Mexico and its agencies, including the NMISC and its employees, are not in any manner responsible for the planning, design, operation, maintenance, management, replacement, construction, or supervision of any aspect or part of the Project. This provision shall survive termination of this Agreement.

#### **ARTICLE IV. EXPENDITURE OF FUNDS**

The Funding Amount must be expended on or before the Spending Deadline or, if applicable, by the date of Early Termination of this Agreement in order to be eligible for reimbursement under this Agreement. For purposes of this Agreement, funds are expended, and an expenditure has occurred as of the date that a particular quantity of goods are delivered and received, or title to a particular quantity of goods or property is transferred, or as of the date particular services are rendered to Bayard. For purposes of this Agreement, it is not sufficient for Bayard to merely encumber the Funding Amount for future expenditure on its books on or before the Project's Spending Deadline or Early Termination Date. For purposes of this Agreement, an encumbrance of funds pursuant to a contract or purchase order with a third party does not qualify as an expenditure.

#### **ARTICLE V. REPORTS**

- A. **Quarterly Reports.** In order that the NMISC staff may adequately monitor Project activity and process reimbursements to Bayard, Bayard shall prepare and submit to the NMISC Quarterly Reports for the Project. The Quarterly Report shall be submitted on a form prescribed by the NMISC, attached hereto as Exhibit C.

The Quarterly Report shall be due quarterly, beginning with the first full quarter following the Effective Date of this Agreement and ending with the submission of a Final Report for the Project. The Quarterly Report shall be submitted to the NMISC no later than seven calendar days following the last day of the quarter. The NMISC may, in its sole discretion, change the schedule by which Quarterly Reports are submitted. In the event the NMISC changes the

reporting schedule, the NMISC shall provide a minimum of 30 calendar days written notice of the change in reporting schedule.

- B. Final Report. Within 30 calendar days of the date of completion of the Project or the Spending Deadline, whichever comes first, Bayard shall prepare and submit a Final Report for the Project to the NMISC. The Final Report shall be submitted on a form prescribed by the NMISC, attached hereto as Exhibit D, and shall contain supplemental information as the NMISC may request, which may include final, stamped construction documents. The NMISC shall review the report and request any clarifications or changes within 30 calendar days. The NMISC may approve the Final Report after the date of termination of this Agreement. The final Request for Reimbursement shall not be approved until the Final Report is approved by the NMISC.
- C. Requests for Additional Information. During the term of this Agreement, and during the period of time for which Bayard must retain records pursuant to this Agreement, the NMISC may (i) request such additional information regarding the Project as it deems necessary and (ii) conduct, at reasonable times and upon reasonable notice, on-site inspections of the Project. Bayard shall respond to such requests for additional information within a reasonable period of time, as established by the NMISC. Requests made pursuant to this subparagraph are in addition to, and not in lieu of, the quarterly and final reporting described in this Article V.

#### **ARTICLE VI. NOTICE PROVISIONS; DESIGNATED REPRESENTATIVES**

- A. The Parties agree that they shall send all notices related to this Agreement to the persons named below by regular mail or email. In the case of mailings, notices shall be deemed to have been given and received upon the date of the receiving Party's actual receipt or five calendar days after mailing, whichever occurs first. In the case of email transmissions, the notice shall be deemed to have been given and received on the date reflected on the delivery receipt of the e-mail.
- B. The Parties hereby designate the persons listed below as their official representatives concerning all matters related to this Agreement including, but not limited to, notices, reports, requests for reimbursement, and special conditions, if applicable:

- C. Any Party may change its designated representative upon written notice to all other Parties to this Agreement.

### **ARTICLE VII. EARLY TERMINATION**

- A. Circumstances of Early Termination. The NMISC may terminate this Agreement before the expiration of the Agreement based on the Completion of the Project, Complete Expenditure of the Funding Amount, and/or Violation of this Agreement. Early Termination hereunder includes:
- i. Termination due to completion of the Project before the Spending Deadline;
  - ii. Termination due to expenditure of the Funding Amount approved by the Commission before the Spending Deadline;
  - iii. Termination for violation of the terms of this Agreement;
  - iv. Termination for suspected mishandling of public funds, including but not limited to, fraud, waste, abuse and conflicts of interest; or
  - v. Termination upon mutual agreement of the Parties.
- B. Limitation on the NMISC's Obligation to Make Disbursements in the Event of Early Termination. In the event of Early Termination of this Agreement by any Party, the NMISC's sole obligation to reimburse Bayard is expressly conditioned upon the limitations set forth in this Agreement.
- C. Early Termination Due to Non-Appropriation. The funds provided by the NMISC to perform this Agreement reside in the New Mexico Treasury. While these funds were not appropriated to the Treasury by the New Mexico Legislature, the Legislature, may, in its discretion, appropriate, un-appropriate or withdraw authorization for the expenditure of these funds. If the Legislature un-appropriates funds that the NMISC has earmarked for this Agreement, or withdraws authorization for the expenditure of these funds, the NMISC shall have the sole discretion to terminate this Agreement prior to the Spending Deadline, as of the effective date of the un-appropriation of the funds. The NMISC's decision as to whether sufficient appropriations or authorizations are available shall be accepted by Bayard and shall be final.
- D. Early Termination Waiver of Contract Rights. Bayard hereby waives any rights to assess an impairment of contract claim or a breach of contract claim against the NMISC or the State of New Mexico in the event of Early Termination of this Agreement pursuant to this Article of the Agreement.

## **ARTICLE VIII. SUSPENSION OF NEW OR FURTHER OBLIGATIONS**

- A. **Suspension.** The NMISC, in its sole and absolute discretion, may provide written notice to Bayard to suspend incurring any new or further obligations and costs that could be reimbursed by the NMISC pursuant to this Agreement (“Suspension”). Upon receipt of such written notice:
- i. Bayard shall immediately suspend entering new or further written obligations with third parties;
  - ii. Bayard shall immediately suspend the incurrence of costs that could be reimbursable pursuant to this Agreement; and
  - iii. the NMISC may suspend issuance of any new or further NTPs under this Agreement in its sole discretion.
- B. In the event of Suspension of this Agreement, NMISC’s sole and absolute obligation to reimburse Bayard is expressly conditioned upon the limitations set forth in Article III herein.
- C. **Lifting of Suspension.** Suspension of new or further obligations and incurrence of costs under this Agreement shall remain in effect unless or until the date Bayard receives written notice given by NMISC informing Bayard that the Suspension has been lifted or that the Agreement has been Early Terminated in accordance with Article VII herein. If the Suspension is lifted, NMISC will consider further requests for reimbursement.
- D. **Corrective Action Plan in the Event of Suspension.** In the event of Suspension of this Agreement, the NMISC may, but is not obligated to, require Bayard to develop and implement a written corrective action plan to remedy the grounds for the Suspension.
- i. Such a corrective action plan must be approved by NMISC and be signed by Bayard.
  - ii. Failure to sign a corrective action plan or meet the terms and deadlines set forth in the signed corrective action plan is hereby deemed a violation of the terms of this Agreement for purposes of Early Termination, Article VII.
  - iii. A corrective action plan shall be in addition to, and not in lieu of, any other equitable or legal remedy authorized hereunder or at law, including but not limited to Early Termination.

## **ARTICLE IX. PROJECT CONDITIONS AND RESTRICTIONS**

- A. The following general conditions and restrictions shall apply to the Project:
- i. The Funding Amount must be spent in accordance with all applicable laws, regulations, policies, and guidelines, including, but not limited to, the New Mexico Procurement Code, NMSA 1978, Section 13-1-21 *et. seq.*, or any local procurement ordinance, where applicable.
  - ii. The Project’s expenditures and liabilities must be accounted for in accordance with the State’s Model Accounting Practices, as amended from time to time.

- iii. The Project may benefit private entities only in accordance with applicable law, including, but not limited to, Article IX, Section 14 of the Constitution of the State of New Mexico, the “Anti-Donation Clause.”
- iv. Bayard shall comply with all applicable federal and state laws, rules, and regulations pertaining to civil rights and equal employment opportunity. In accordance with all such laws, rules, and regulations, Bayard agrees to assure that no person shall, on the grounds of race, color, national origin, sex, sexual preference, age, or handicap, be excluded from participation in the Project, use of the Project, employment with Bayard, or otherwise be denied benefits/subject to discrimination for any activity performed under this Agreement.
- v. Where NMISC, in its sole and absolute discretion, determines Bayard has failed to comply with the conditions and restrictions described in this Article, Bayard agrees to take appropriate steps to correct any deficiencies immediately. Bayard’s failure to implement such appropriate steps within a reasonable time, but no longer than 30 calendar days after notice from NMISC, constitutes a breach of this Agreement and grounds for Early Termination.

## **ARTICLE X: REPRESENTATIONS AND WARRANTIES**

### A. Reliance by NMISC.

- i. Bayard expressly acknowledges that the NMISC relies on the representations and warranties made by Bayard in this Agreement. Bayard acknowledges that such representations and warranties are a material inducement for the NMISC to enter into this Agreement and provide the Funding Amount.
- ii. Bayard shall ensure all representations and warranties provided herein are true, accurate, and complete as of the date of the Effective Date and shall remain so throughout the Term of this Agreement. Bayard is responsible for promptly notifying the NMISC in writing of any changes or inaccuracies in the representations and warranties contained herein.

### B. Bayard hereby represents and warrants the following:

- i. Bayard is recognized as a political subdivision of the state pursuant to NMSA 1978, Chapter 6, and has the legal authority to receive and expend the Funding Amount.
- ii. This Agreement has been duly authorized by Bayard. Bayard’s governing body has duly adopted or passed as an official act, a resolution, motion, or similar action authorizing the person identified as the official representative of Bayard to sign this Agreement, sign Requests for Reimbursement, and Quarterly and Final Reports pursuant to this Agreement. Once executed by Bayard, this Agreement shall constitute a binding obligation on Bayard, enforceable according to its terms.
- iii. This Agreement and Bayard’s obligations hereunder do not conflict with any federal or state law, ordinance or resolution applicable to Bayard, Bayard’s charter, if applicable, or any judgment or decree to which Bayard is subject.
- iv. Bayard shall abide by New Mexico laws regarding conflicts of interest, governmental conduct, and whistleblower protection. Bayard specifically agrees that none of its officers or employees or its designees or agents, no member of the governing body, and no public official of Bayard who exercises any function or responsibility with respect

- to this Agreement, shall have any interest, direct or indirect, in any contract or subcontract, of the proceeds thereof, for work to be performed pursuant to this Agreement, during their tenure or for one year thereafter.
- v. No funds have been paid or will be paid, by or on behalf of Bayard, to any person for influencing or attempting to influence an officer or employee of the NMISC or any agency or body in connection with the awarding of any contract or work to a third party, and Bayard shall require certifying language prohibiting lobbying to be included in the award documents for all sub-awards, including sub-contracts, loans and cooperative agreements. All sub-recipients shall be required to certify accordingly.
  - vi. No funds have been paid, or will be paid, by or on behalf of Bayard, to spouses, children, parents, brothers and sisters of members of Bayard governing body otherwise defined as “immediate family members,” in accordance with NMSA 1978, Section 13-1-62.
- C. Consequences of False or Misleading Representations. If any representation or warranty made by Bayard is found to be false or misleading, the NMISC shall have the right to exercise any or all of the following remedies:
- i. Termination of Agreement: NMISC may terminate this Agreement immediately upon written notice to Bayard.
  - ii. Repayment of Funds: Bayard shall repay all Funding Amounts disbursed under this Agreement, upon demand by the NMISC.
  - iii. Other Remedies: NMISC may pursue any other remedies available at law or in equity.
- D. Survival of Representations and Warranties. The representations and warranties made by Bayard shall survive the Early Termination or expiration of this Agreement.

**ARTICLE XI. PROJECT RECORDS; STRICT ACCOUNTABILITY OF RECEIPTS  
AND DISBURSEMENTS**

- A. Bayard shall be strictly accountable for receipts and disbursements relating to the Funding Amount. Bayard shall follow Generally Accepted Accounting Principles and the State’s Model Accounting Practices, and, if feasible, maintain a separate bank account or fund with a separate organizational code, for the funds related to the Project, to ensure separate budgeting and accounting of the funds.
- B. For a period of six (6) years following the Project’s completion, Bayard shall maintain all Project-related records, including, but not limited to, all financial records, requests for proposals, invitations to bid, selection and award criteria, contracts and sub-contracts, advertisements, minutes of pertinent meetings, as well as records sufficient to fully account for the amount and disposition of the total funds from all sources budgeted for the Project, the purpose for which such funds were used, and any such other records as the NMISC shall prescribe.
- C. Bayard shall make all Project records available to the NMISC, the Department of Finance and Administration, and the New Mexico State Auditor upon request. With respect to the funds that are the subject of this Agreement, if the State Auditor finds that any or all of these funds

were improperly expended, Bayard may be required to return to the NMISC any and all amounts found to be improperly expended. The NMISC shall deposit all such amounts into the New Mexico Unit Fund.

### **ARTICLE XII. IMPROPERLY REIMBURSED FUNDS**

If the NMISC determines part or all of the Funding Amount was improperly reimbursed to Bayard, including but not limited to, funds reimbursed to Bayard based upon fraud, mismanagement, misrepresentation, misuse, violation of law by Bayard, or violation of this Agreement, after ten calendar days' notice to Bayard and the opportunity to return such funds to the NMISC, the NMISC may offset any funds otherwise due to Bayard from the State, until the Funding Amount is fully repaid. The NMISC shall deposit all such amounts into the New Mexico Unit Fund.

### **ARTICLE XIII. LIABILITY**

No Party shall be responsible for liability incurred as a result of another Party's acts or omissions in connection with this Agreement. Any liability alleged to have been incurred in connection with this Agreement is subject to the immunities and limitations of the New Mexico Tort Claims Act.

### **ARTICLE XIV. SCOPE OF AGREEMENT**

This Agreement constitutes the entire and exclusive agreement between Bayard and the NMISC concerning the subject matter. This Agreement supersedes any and all prior or contemporaneous agreements, understandings, discussions, communications, and representations, written or verbal between the Parties hereto with regard to the subject matter hereof.

### **ARTICLE XV. REQUIRED CLAUSES IN CONTRACTS FUNDED IN WHOLE OR IN PART BY THE FUNDING AMOUNT UNDER THIS AGREEMENT**

- A. **Non-Appropriations.** Bayard acknowledges and agrees that Bayard shall include the following "non-appropriations" clause in all contracts between Bayard and other parties that are (i) funded in whole or part by funds made available under this Agreement and (ii) entered into after the effective date of this Agreement. This non-appropriation clause will state:

"The terms of this Agreement are contingent upon sufficient appropriations and authorization being made by the Legislature of New Mexico and/or made available to the NMISC for the performance of this Agreement. If sufficient appropriations and authorization are not made by the Legislature and/or made available to the NMISC, Bayard may immediately terminate this Agreement by giving the contractor written notice of such termination. Bayard decision as to whether sufficient appropriations are available shall be accepted by the contractor and shall be final. The contractor hereby waives any rights to assert an impairment of contract claim or a breach of contract claim against Bayard or the

NMISC or the State of New Mexico in the event of immediate or Early Termination of this Agreement by Bayard due to lack of NMISC funds.”

- B. Termination. Bayard acknowledges and agrees that Bayard shall include the following termination clause in all contracts that are (i) funded in whole or part by funds made available under this Agreement and (ii) entered into after the effective date of this Agreement:

“This Agreement is funded in whole or in part by funds made available under a disbursement from the NMISC. Should the NMISC terminate the agreement with Bayard providing those funds before the scheduled termination date, Bayard may terminate this contract earlier than its scheduled termination date by providing the contractor written notice of such termination. In the event of termination pursuant to this paragraph, Bayard’s only liability shall be to pay the contractor for acceptable goods delivered and services rendered before the termination date.”

- C. Conflict of Interest. Bayard acknowledges and agrees that Bayard shall include the following termination clause in all contracts that are (i) funded in whole or part by funds made available under this Agreement and (ii) entered into after the effective date of this Agreement:

“The Parties shall abide by New Mexico laws regarding conflicts of interest, governmental conduct, and whistleblower protection. The Parties to this Agreement specifically acknowledge and affirm that no officer or employee of Bayard or its designees or agents, no member of Bayard’s governing body, and no public official of Bayard who exercises any function or responsibility with respect to this Agreement (all referred to hereinafter as “Public Official”), has any interest, direct or indirect, in this Agreement or any related subcontract and the work performed pursuant to this Agreement, during any Public Official’s tenure and for one year thereafter.”

## **ARTICLE XVI: COMPLIANCE WITH UNIFORM FUNDING CRITERIA**

- A. Throughout the term of this Agreement, Bayard shall:
- i. Submit all reports of annual audits and agreed-upon procedures required by § 12-6-3(A)-(B), NMSA 1978 by the due dates established in § 2.2.2 NMAC, reports of which must be a public record pursuant to § 12-6-5(A), NMSA 1978 within 45 days of delivery to the State Auditor;
  - ii. Have a duly adopted budget for the current fiscal year approved by its budgetary oversight agency (if any);
  - iii. Timely submit all required financial reports to its budgetary oversight agency (if any);
  - iv. Use accounting methods and procedures consistent with Generally Accepted Accounting Principles and the State’s Model Accounting Practices to expend the Appropriated Amount in accordance with applicable law and account for and safeguard the Funding Amount and assets acquired with the Funding Amount; and

- v. Affirmatively inform the NMISC if Bayard has failed to comply with the requirements of subparagraph A of this Article XVI.
- B. In the event Bayard fails to comply with the requirements of subparagraph A of this Article XVI, the NMISC may take one or more of the following actions:
- i. Suspend new or further obligations pursuant to Article VIII of this Agreement;
  - ii. Require Bayard to develop and implement a written corrective action plan pursuant to Article VIII of this Agreement to remedy the non-compliance;
  - iii. Impose special conditions to address the non-compliance by giving Bayard notice of such special conditions in accordance with Article VI of this Agreement;
    - i. The Parties agree that any special conditions imposed to address non-compliance shall be incorporated into this Agreement, through an exhibit to this Agreement identifying and listing those special conditions, upon notice to Bayard, without need for formal amendment of this Agreement;
    - ii. Special conditions shall be binding and effective and the exhibit shall be attached to this Agreement and incorporated by reference on the date that notice is deemed to have been given pursuant to Article VI; or
  - iv. Terminate this Agreement pursuant to Article VII of this Agreement.

### **ARTICLE XVII GENERAL PROVISIONS**

- A. **Assignment:** Bayard's rights and obligations under this Agreement are personal and may not be transferred or assigned without the prior written consent of the NMISC. Any attempt at assignment or transfer without such consent shall be void. Any assignment or transfer of Bayard's rights and obligations approved by the NMISC shall be subject to the provisions of this Agreement.
- B. **Binding Effect:** Except as otherwise provided, all provisions of this Agreement, including the benefits and burdens, shall extend to and be binding upon the Parties' respective successors and assigns.
- C. **Authority:** Each Party represents and warrants to the other that the execution and delivery of this Agreement and the performance of such Party's obligations have been duly authorized.
- D. **Captions and References:** The captions and headings in this Agreement are for the convenience of reference only and shall not be used to interpret, define, or limit its provisions. All references in this Agreement to sections (whether spelled out or using the § symbol), subsections, exhibits, or other attachments are references to sections, subsections, exhibits, or other attachments contained herein or incorporated as a part hereof, unless otherwise noted.
- E. **Counterparts:** This Agreement may be executed in multiple, identical, original counterparts, each of which shall be deemed to be an original, but all of which, taken together, shall constitute the same agreement.
- F. **Digital Signatures:** If any signatory signs this agreement using a digital signature in accordance with the State Policies regarding the use of digital signatures, then any agreement or consent

to use digital signatures within the electronic system through which that signatory signed shall be incorporated into this Agreement by reference.

- G. **Modification:** Except as otherwise provided in this Agreement, any modification to this Agreement shall only be effective if agreed to in a formal amendment, properly executed and approved in accordance with applicable New Mexico law and State fiscal policies and rules. Modifications permitted under this Agreement, other than Agreement amendments, shall conform to the policies issued by the State.
- H. **Statutes, Regulations, Fiscal Rules, and Other Authority:** Any reference in this Agreement to a statute, regulation, policy, or other authority shall be interpreted to refer to such authority then current, as may have been changed or amended after the Effective Date of this Agreement.
- I. **External Terms and Conditions:** Notwithstanding anything to the contrary herein, the State shall not be subject to any provision included in any terms, conditions, or agreements appearing on Bayard's or a subcontractor's website or any provision incorporated into any click-through or online agreements related to the Work unless that provision is specifically referenced in this Agreement.
- J. **Severability:** The invalidity or unenforceability of any provision of this Agreement shall not affect the validity or enforceability of any other provision of this Agreement, which shall remain in full force and effect, provided that the Parties can continue to perform their obligations under this Agreement in accordance with its intent.
- K. **Survival of Certain Agreement Terms:** Any provision of this Agreement that imposes an obligation on a Party after the termination or expiration of this Agreement shall survive the termination or expiration of this Agreement and shall be enforceable by the other Party.
- L. **Third Party Beneficiaries:** Except for the Parties' respective successors and assigns described in this Agreement, it does not and is not intended to confer any rights or remedies upon any person or entity other than the Parties. Enforcement of this Agreement and all rights and obligations hereunder are reserved solely to the Parties. Any services or benefits that third parties receive as a result of this Agreement are incidental to this Agreement and do not create any rights for such third parties.
- M. **Waiver:** A Party's failure or delay in exercising any right, power, or privilege under this Agreement, whether explicit or by lack of enforcement, shall not operate as a waiver, nor shall any single or partial exercise of any right, power, or privilege preclude any other or further exercise of such right, power, or privilege. No waiver by a Party of any of its rights under this Agreement shall be effective unless express and in writing, and no effective waiver by a Party of any of its rights shall be effective to waive any other rights.
- N. **Standard and Manner of Performance:** Bayard shall perform its obligations under this Agreement in accordance with the highest standards of care, skill, and diligence in Bayard's industry, trade, or profession.

- O. Licenses, Permits, and Other Authorizations: Bayard shall secure, prior to the Effective Date, and maintain at all times during the term of this Agreement, at its sole expense, all licenses, certifications, permits, and other authorizations required to perform its obligations under this Agreement and shall ensure that all employees, agents, and subcontractors secure and maintain at all times during the term of their employment, agency or subcontractor, all license, certifications, permits and other authorizations required to perform their obligations in relation to this Agreement.
  
- P. Venue and Choice of Law: This Agreement shall be governed by and construed in accordance with the laws of the State of New Mexico, without regard to any conflict of law provisions. Any legal suit, action, or proceeding arising out of or related to this Agreement shall be instituted exclusively in the district courts located in Santa Fe, New Mexico. The Parties hereby irrevocably submit to the exclusive jurisdiction and venue of such courts in any such suit, action, or proceeding. The Parties waive any objection to the laying of the venue of any such suit, action, or proceeding in the district courts of Santa Fe, New Mexico, and irrevocably waive and agree not to plead or claim in any such court that any such suit, action, or proceeding brought in any such court has been brought in an inconvenient forum.
  
- Q. Publicity: Any Publicity regarding the subject matter of this Agreement must acknowledge the NMISC’s support for the project and be shared with the NMISC. For purposes of this agreement, “Publicity” means notices, informational pamphlets, press releases, email responses, research, reports, signs, and similar public notices prepared by or for Bayard or jointly with others.

**Develop an Asset Management Plan  
Funding Amount: \$223,210  
Entity: City of Bayard**

**Background**

The City of Bayard’s (City) potable water distribution system includes aging infrastructure with limited and inconsistent documentation of asset age, condition, and service history. Like many small municipalities, the City faces constrained financial resources and incomplete data, which limits its ability to proactively plan maintenance, rehabilitation, and replacement activities. Current decision making is therefore largely reactive, increasing the risk of unplanned failures and inefficient use of available funds. These conditions highlight the need for targeted upgrades to both the physical water system and the supporting asset management framework to improve reliability, prioritize investments, and support the long-term sustainability of the City’s potable water services. Bayard is also a member of the Grant County Water Commission. The AMP help support the City’s implementation of, the Grant County Water Regionalization Plan by identifying City system improvements needed to integrate regional supply and by aligning renewal priorities and project sequencing with regional milestones. This coordination will help avoid duplicative investment and ensure the City’s capital and operational strategies remain consistent with the long-term regional approach to supply, redundancy, and resiliency.

**Project Objective**

The project objective is to develop an Asset Management Plan (AMP) that will help support the City’s sound decision making to increase the efficiency and reliability of the City’s potable water distribution system.

**Project Summary**

The City is undertaking a project to develop an AMP aimed at improving decision making to increase the efficiency and reliability of its potable water distribution system. The Project involves comprehensive tasks including, but not limited to, GIS development, asset information system creation, risk and criticality assessment, and long-term financial and capital planning to ensure sustainable infrastructure management.

## Scope of Work

All tasks within the project scope follow the AM Kan Work framework.

### 1. Task 1 Project Management and Coordination

#### 1.1. Project Charter

A formalized plan outlining the project's scope, objectives, timeline, roles and responsibilities, and communication protocols. This document will serve as the foundation for effective coordination and oversight throughout the project lifecycle.

#### 1.2. Project Communication and Coordination

Regularly scheduled updates detailing project status, milestones achieved, schedule and budget updates, challenges encountered, and corrective actions taken to keep the project on track.

#### Task 1 Deliverables

- Project Charter
- Quarterly Progress Reports
- Monthly Meeting agendas and minutes

### 2. Task 2 Asset Information System Development

Develop an asset information system to document and manage asset data in a logically standardized manner. GIS will be used as the asset repository, but the asset information system will help define how the GIS captures information about assets, specifically the asset hierarchy and unique naming system.

#### 2.1. Asset Definition

Develop an asset definition aligned with the A.M. Kan methodology, which establishes a clear and consistent understanding of what constitutes an asset within the City's potable water distribution system. Establish a shared definition and classification framework for both linear and vertical assets. The definition will be integrated into the City's modified GIS-based geodatabase to standardize how assets are identified, categorized, and recorded across the system.

#### 2.2. Establish Asset Hierarchy

Create an asset hierarchy and ID numbering system by organizing all assets into logical levels based on ISO 14224. Once the hierarchy is set, each asset is assigned a unique ID that follows the same structure to keep identification simple, consistent, and easy to maintain. If necessary, develop an asset ID standard, and assign it to the assets.

### 2.3. Asset Condition

Document the condition of assets, drawing from available maintenance history, City staff knowledge, and field observations where applicable. Data will be compiled into the asset inventory in a standardized format. In cases where condition information is unavailable, determine which condition assessments can be completed (e.g., for vertical assets) internally and which assessments should be performed by external contractors for linear assets.

#### Task 2 Deliverables:

- Asset information system Technical Memo (documenting sections 2.1 to 2.3)

### 3. Task 3 GIS Development and Deployment

Strengthen the City's GIS system to serve as the accurate, complete, and authoritative digital representation of the potable water distribution network.

#### 3.1. Geodatabase design

Using the existing GIS that the City has along with current industry best practices, create a centralized, Esri-based geodatabase that will form the foundation of the City's asset management system. This database will incorporate industry-standard Esri Water Model components, allowing the City to utilize Esri applications and tools effectively. The geodatabase will include structured tables, domains, and relationships that support asset attributes, condition assessments, maintenance history, and long-term performance tracking. A draft version will be presented to City staff during a workshop for review and refinement before finalization.

#### 3.2. Data edits

Perform industry-standard GIS data edits to prepare the geodatabase for use as the authoritative asset record. These edits include adding missing appurtenances (valves, tees, crosses, bends), splitting mains at appropriate junctions, replacing mains with hydrant laterals where needed, and assigning a unique asset identification system to each mapped asset. The edits will primarily be based off fixed asset registers, client markups, Google Street View, and other desktop mapping exercises.

Validate edits, confirm installation years, resolve uncertainties, and refine asset locations. Prepare 11"×17" PDF maps for redlining, corrections, and maintain synchronization between spatial and attribute data throughout the process.

Acquire any missing information through collection of new field data, construction plans, as-built drawings, system maps, redline drawings, spreadsheets, or other documentation so that GIS reflects the best available asset data. Gaps in information will be supplemented by GPS field technicians utilizing sub foot accurate GPS locations.

### 3.3. ArcGIS Online Configuration

Procure, configure, and administer an Esri Architecture, Engineering, and Construction (AEC) ArcGIS Project Delivery Site and Organizational Subscription. This will include developing and providing access to a shared ArcGIS Online secure collaboration site that will enable access to City, contractor, sub consultants and public where appropriate. This site will be setup upon project kickoff and be maintained for an initial period of (2) two years. After (2) years of expiration, a determination will be made by the City to continue the subscription or roll the content into City's ArcGIS environment. If the City has an existing ArcGIS Online account in place, this will negate the need for a new ArcGIS Organization account and will simply add additional user accounts if needed to view and maintain assets for the duration of the project and afterwards.

Set up the Esri AEC ArcGIS Project Delivery Site and Organization Account with user roles and privileges and developing three customized field collection applications for hydrant inspections, leak documentation, and valve exercising. Configure an office-focused ArcGIS Online Asset Viewer that allows visualization of assets and perform querying, filtering, measurements, exports, and basic reporting. Provide two Esri AEC ArcGIS Project Delivery Online training sessions held after GIS data edits are complete to equip City staff with the skills needed to confidently use both the field and office applications. Training will be recorded and made available for future staff to utilize.

#### Task 3 Deliverables

- Draft and final geodatabase design
- Geodatabase schema documentation
- Updated GIS datasets with applied edits
- Finalized asset ID assignments
- Configured ArcGIS Online Organization Account

## **4. Task 4: Asset Management Plan Development**

Develop a comprehensive, A.M. KAN WORK-aligned Asset Management Plan (AMP) for the City's potable water system. Building upon the GIS-based asset inventory developed under Tasks 2 and Task 3, the AMP will provide a structured, risk-informed, and financially sustainable framework to support long-term infrastructure decision-making. The AMP will integrate levels of service, performance measurement, condition assessment, risk prioritization, lifecycle strategies, implementation and improvement, and financial planning into a single, defensible planning document suitable for Council adoption.

### 4.1. Levels of Service (LOS) Framework

Work with City staff to define clear Levels of Service (LOS) that set expectations for potable water system performance and guide AMP decisions on performance tracking, risk, and investments.

#### 4.2. Key Performance Indicators (KPIs) and Performance measures

Based on the approved LOS framework, develop a set of Key Performance Indicators (KPIs) and performance measures to quantify service delivery. These will be structured into:

- **Customer-centric measures**, such as service reliability, pressure consistency, service interruptions, and water quality compliance.
- **Technical-centric measures**, such as main break frequency, response times, unaccounted-for water, and system redundancy.

Where data is available, the contractor will assess current system performance against established targets. If required data is unavailable, contractor will identify the data gaps and provide recommendations regarding what performance information should be collected to enable future monitoring. The KPI framework will support tying future capital and operational investments directly to the maintenance or improvement of defined service outcomes.

#### 4.3. Condition & Performance Evaluation

Evaluate overall asset condition and system performance trends using available inspection data, maintenance records, break history, and operational information. Where detailed condition data is limited, apply industry-informed deterioration information and proxy indicators to establish baseline condition estimates. The evaluation will include analysis of break frequency trends, material performance, age distribution, and potential environmental stressors. This assessment will help identify systemic vulnerabilities within the network and inform both near-term corrective actions and long-term renewal planning.

#### 4.4. Risk & Criticality Assessment

Develop and apply a structured risk methodology, using a likelihood-of-failure and consequence-of-failure framework. Likelihood will be informed by, for example, asset age, material, soil, break history, and available condition data. Consequence criteria will be developed collaboratively with the City and may include impacts on public health and safety, regulatory compliance, and customer impact, and financial exposure.

Facilitate a discussion to define risk thresholds and overall risk appetite, ensuring alignment between asset risk tolerance and investment planning. A risk matrix will be developed, and risk scores will be calculated for asset classes or individual assets, as appropriate based on available data.

#### 4.5. Lifecycle Management Strategies

Develop lifecycle management strategies for major water asset classes, including distribution mains, valves, hydrants, tanks, and pump stations. For each asset class, define appropriate maintenance approaches, as well as rehabilitation and replacement triggers.

4.6. Long-Term Capital Plan

Building upon the validated asset inventory developed under Task 2, and informed by the condition assessment, risk prioritization, and lifecycle strategies developed in previous tasks, Prepare a long-term capital plan for the City’s potable water system. This plan in relation to the Grant County Regional Water Project acts as a coordinated, external “driver” project that will influence (and potentially reduce, defer, or reshape) Bayard’s local capital needs. The capital plan will typically cover, for example, a 20-year planning horizon and will identify rehabilitation and replacement needs based on risk prioritization and expected useful life.

4.7. Financial Strategy

Following the development of the long-term capital plan, prepare a financial strategy that evaluates the City’s ability to sustainably fund projected infrastructure needs. This strategy will bridge the gap between identified capital requirements and the City’s existing funding mechanisms, ensuring that long-term service objectives are financially achievable.

4.8. Implementation & Improvement Plan

To support an actionable AMP, develop a phased implementation of roadmap outlining short-term, mid-term, and long-term actions. These actions may include data improvement initiatives, inspection of program enhancements, policy updates, risk monitoring processes, and financial planning refinements.

4.9. AMP Documentation

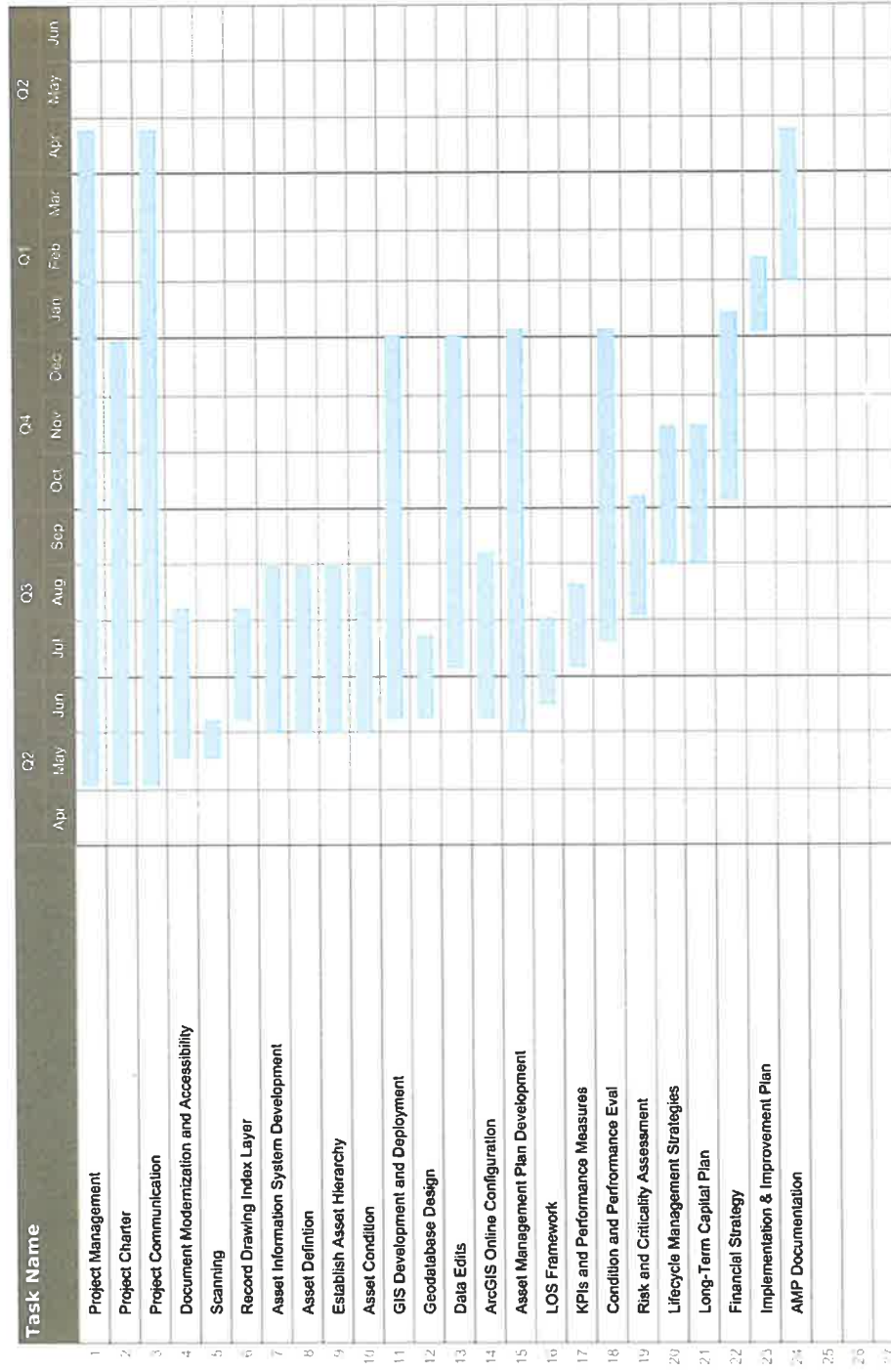

## BAYARD ORDINANCE 1-2026

**AN ORDINANCE AMENDING SECTION 16-70 OF THE CODE OF ORDINANCES OF THE CITY OF BAYARD, NEW MEXICO, TITLED "EMERGENCY ABATEMENT", WHICH AMENDMENT PROVIDES AN EXPEDITED REVIEW AND AUTHORIZATION PROCESS TO SWIFTLY AND ADEQUATELY ABATE A PUBLIC NUISANCE CREATING IMMINENT DANGER TO PUBLIC HEALTH, SAFETY, OR WELFARE.**

WHEREAS the prompt abatement of public nuisances for the protection of public health, safety, or welfare is a matter of local concern;

WHEREAS the abatement remedies provided in this amended Section 16-70 are directed at correcting an imminent danger to public health, safety, or welfare upon the property involved and not against any individual directly;

WHEREAS the amendment of Section 16-70 expedites the current review and approval process (in Ord. No. 2-2008, §2.32) for initiating an emergency abatement, yet ensures that the decision is accurate and correct based on reliable facts; and

WHEREAS amended Section 16-70 is not intended to authorize any act expressly prohibited by state law, nor to forbid any conduct expressly authorized by state law, and it is the intent of the Bayard City Council that the provisions of this amended Section 16-70 shall be construed to avoid any such direct and express conflict.

THEREFORE, be it ordained by the City Council of the City of Bayard, New Mexico, that Section 16-70 of the Bayard Municipal Code, is hereby amended to read as follows:

### **Sec. 16-70. -Emergency abatement.**

#### **a. Emergency abatement decision process:**

Notwithstanding any other provision in Chapter 16 of the Code of Ordinances of the City of Bayard, New Mexico, where either of the two following situations exist an officer of the Bayard department of public safety shall promptly notify the mayor of such condition:

- i. A public nuisance necessitates the dispatch of law enforcement, fire, or any other emergency services; or

- ii. The Bayard code enforcement officer or other officer of the Bayard department of public safety determines that conditions at a property constitute a public nuisance creating imminent danger to public health, safety, or welfare.
- (1) The mayor of the City of Bayard shall meet with the officer of the department of public safety and in consultation with the city attorney shall determine, based on the individualized facts and circumstances: first, that a public nuisance exists, and second, that the public health, safety, or welfare requires the removal of the nuisance immediately pursuant to the city's power to protect the health, safety, and welfare of its citizens. These written findings shall be maintained in the case file.
  - (2) If the mayor and city attorney agree a public nuisance poses imminent danger to health, safety, or welfare, the mayor shall order immediate abatement without notice. Nothing herein shall preclude the mayor, with the city attorney's advice, from obtaining an emergency administrative search warrant during the emergency abatement process.
  - (3) Notice to the property owner, as shown by the records in the office of the Grant County assessor, is not required.
  - (4) Abatement of an imminent danger is limited to actions needed to eliminate the hazard, such as, but not limited to, disconnecting utilities, securing structures, installing fencing, emergency property cleaning, and actions described in section 16-68.
  - (5) The city shall pay the cost and expense of such abatement from any appropriation made available for that purpose.
  - (6) Following the emergency abatement, within a reasonable time an officer of the Bayard department of public safety shall post on the premises a notice summarizing the abatement action taken.
  - (7) The city shall record a lien upon the affected property in the office of the grant county clerk for all the costs incurred by the city because of abating the dangerous nuisance. The city shall serve the recorded lien upon the property owner by personal service or by mailing, United States postal service, certified mail, return receipt.

**b. Emergency abatement decision for inhabited structures:**

- (1) Whenever an officer of the department of public safety finds that an occupied structure contains an imminent danger or health hazard and must be vacated, the officer shall

investigate whether the occupant is legally occupying the structure by requiring that person immediately produce written documentation of such legal occupancy.

- (2) If the occupant has not produced written documentation of legal occupancy within twenty-four (24) hours, the officer of the department of public safety shall request an emergency abatement decision from the mayor in consultation with the city attorney as provided above.
- (3) Upon concurrence by the mayor and the city attorney that the structure is a public nuisance and that public health, safety, or welfare requires the removal of the nuisance immediately, the mayor or designee shall notify the state building inspector requesting an immediate inspection to determine if such structure is unfit for human occupancy.
- (4) Upon notification of the state building inspector, the city shall provide written notice to the property owner or agent and to the occupant that the city notified the state building inspector and requested an immediate inspection.
- (5) Upon receiving a written report from the state building inspector that the structure is unfit for human occupancy, the mayor in consultation with the city attorney may authorize those measures necessary and sufficient to abate the imminent danger or health hazard, which measures may include an order to vacate the property and for it to remain vacant until reinspected for purpose of re-occupancy.
- (6) Pending the report of the state building inspector, nothing herein shall prevent the city from abating the danger through its emergency abatement process where such process does not require the legal occupants to permanently vacate the structure.
