05-05-2025: Make plant rounds and wash down clarifiers and run plant test and check N Hurley lift station, fill up chlorine barrel at wash water pump house, work on chlorine leak at rec plant, and air lance entrance work at bar screen.

05-06-2025: Make plant rounds and wash down clarifiers and run plant test and.

05-07-2025: Make plant rounds and collect all water sample, run all plant test and take water samples to silver UPS, check prices on boots for Sam Arellano at Ace Hardware, Tractor Supply, Circle Heart and fill up chlorine tank at wash water building.

The NM Summer Reading program we are hosting for the month of June from 9:30 – 1:30 pm is going great! We are serving 9 students in the program and have 3 literacy instructors and our assistant librarian, Wendy Spurgeon is serving as the Site Coordinator. We make a great team. Thanks to all the board members and community members who donated snacks for breakfast. Since the summer lunch program doesn't run on Fridays, we are providing sandwich lunches on Friday with a \$300 donation from Fight Like a Girl, a local non-profit, \$100 from Sarah Ortiz who is currently Miss New Mexico, and \$20 from Tim Gray, volunteer at Hurley Community Library. A big thank you to all of them. I also want to thank the Cobre Consolidated School District for providing Chromebooks to all the students and for providing bus transportation to the free summer lunch program so the kiddos and instructors didn't have to walk to the park by the Community Center. I am truly humbled by how our community has come together to make this program work at Bayard Public Library.

I applied for the LOR: Field Work grant and we will find out at the end of this month if we got the grant or not.

I am working on the Outdoor Equity Grant for up to \$40K with Luke from NM Wild. It is due by July 31. I have offers of letter of supports from NM Wild, Latino Outdoors, Nuestra Tierra and Continental Divide Trail Coalition.





A memorial to honor mine workers is one step closer to creation after the New Mexico legislature allocated \$350,000 to build the sculpture in Socorro on the New Mexico Tech campus. If the funding is approved by the governor, another \$70,000 will still need to be raised through donations. "It's important for the America miner," said Michael Pino, an organizer behind the project. "It's the only

national memorial in the United States. There are other memorials, but it's usually dedicated to tragedies."

The American Mine Worker Memorial is a project that Pino has been working on for six years. Twice before he's been close to securing funding from the legislature, with the help of Senator Gerald Ortiz y Pino, who has sponsored the memorial all three times.

"Former miners, retired miners brought the idea to us and they made a compelling case," said Ortiz y Pino.

He points out that mining for resources like gold, uranium and copper has played a big role in New Mexico's history.

"It really impressed me that they wanted to have a memorial for the men, many of whom spent their lives in that field, and for their families who supported them in that field," said Ortiz y Pino. The first time, \$420,000 was allocated four years ago. But that funding couldn't be correctly funneled through New Mexico Tech and went back to the state's general fund, said Michael Pino. The second

time was just last year, when the legislature allocated \$150,000 to build the memorial. Gov. Michell Lujan Grisham vetoed the item, and funding for the memorial again slipped away.

Pino took the veto well, especially for someone so passionate about a project.

"If she vetoed it last year, it was probably for a darn good reason. I have nothing but respect for the governor and her staff."

Still, he wasn't ready to give up on the dream of honoring American miners with a memorial that he believes could boost local tourism and encourage visitors to historic mines in the area, including places like Magdalena, Silver City and Carlsbad. The memorial would be located on the New Mexico Tech campus near the Mineral Museum, adding to a spot that is already a draw for those interested in mining history and geology.


"We decided to go back and try one more time because of the importance of the sculpture itself, and we were able to get \$350,000, but we are waiting for approval from the governor."

The Miners

The memorial would honor miners from different backgrounds and commemorate the contributions the American mine worker has made to society.

The sculpture would be formed from museum-quality bronze and include eight figures to represent the progress of mining history. The figures, a mule and seven people, would be based on real miners. Alan Noris, a local mining engineer and manager, would be one of the miners represented.

"Alan died from COVID a year and a half ago," said Pino. "Alan was alongside me when we first started this, and I promised him that I would put him on that sculpture, and I'm not going to go back on my word. He has three children also that are following the project."



Benny Zamora from Magdalena will serve as inspiration for a figure in the memorial.

Another figure would be based on New Mexico mine owner Benny Zamora from Magdalena, who has also been a supporter of the project from the beginning, and unfortunately also passed away last year. "We have one woman on there with a child, representing the women who fought for their husbands in mining, and so she's going to represent those women."

West Virginia miner Gregory "Action" Jackson, who was an active Mine Workers of America Union member in Logan County, West Virginia, will be used as a model to represent the Black miners of West Virginia. Pino said a striking photo of Jackson that was taken some years ago had been found to base the figure on, but first the miner in the image needed to be identified.

When he was finally located, Jackson was excited to be part of the project.

"We let him know about what was going on, and he said that he was over the moon over it," Pino said. Silver City miner Fidel Hinojosa will also be represented.

Kelly miner Richard Michael McAlexander will represent miners with a Scottish and Irish background. McAlexander was a federal mine inspector and Pino's uncle. Pino's grandfather was also a miner at the Kelly Mine.

Pino still needs to find a Native American miner who can be used as a model for the memorial to represent Native American miners.

A piece of smithsonite would be embedded into the sculpture. Magdalena is well-known for the smithsonite mined there. The memorial would be lit 24/7 with green energy.

If the funding is secured, New Mexico's Office of Cultural Affairs will oversee a bidding process to pick the artist who will create the memorial.

A renowned New Mexico bronze sculptor is already interested in the project and has created the artist's rendering used to promote the memorial: Reynaldo "Sonny" Rivera. The Albuquerque sculptor's work has been featured in museums and galleries and can be found in public spaces. He's created statues that commemorate school desegregation and Rudolfo Anaya's "Bless Me Ultima," and sculptures of Juan de Onate that sparked controversies in Albuquerque and Santa Fe.

If the memorial can move forward, Rivera will have to bid for the project just like any other interested New Mexico artist, but Pino is hopeful that Rivera will be chosen.

"It's all coming together, and I believe it should make a difference for the Socorro economy and for the entire county of Socorro."

That is if the funding isn't vetoed once again.

"Six or seven of us set aside some of our allocation for this project and it would be a shame for the governor to veto it again," said Ortiz y Pino. "I just hope that it goes through this time."

"It would be advantageous for everyone who wants the sculpture to call the governor's office and tell her that they support it," said Pino.

# New Mexico Safe Haven for Infants Act – Statutory Summary & Fire Department Requirements

# § 24-22-2. Definitions

"Surrender safety device" means an environmentally controlled incubator device that is:

- 1. Designed to keep an infant in a secure and safe environment with sufficient oxygen and at a comfortable temperature for at least three hours;
- 2. Capable of being attached to a building in a manner that allows a person to access an infant within the device from inside the building;
- 3. Equipped with a transparent door through which an infant is visible and may be retrieved from inside the building;
- 4. Equipped with a safety alarm to immediately notify the operator of the device that an infant is secured within the device.

# § 24-22-3. Leaving an Infant

- A. A person may leave an infant (90 days old or younger, unharmed) with staff, a first responder, or inside a surrender safety device without fear of criminal prosecution.
- B. Staff may ask—but not require—identifying or medical information.
- C. Consent for medical care is presumed for surrendered infants.

### § 24-22-4. Safe Haven Site Procedures

- A. Safe haven sites shall accept infants delivered to them or found in the safety device.
- B. Procedures must be developed with CYFD for receiving infants and providing necessary medical care.
- C. Information about adoption or reunification may be provided.
- D. Sites must inquire (but not require) tribal affiliation.
- E. CYFD must be immediately informed of any infant surrender.

# § 24-22-5. CYFD Responsibilities

- A. CYFD takes emergency custody upon notification.
- B. Abuse/neglect investigation is immediately initiated.
- C. Tribal ICWA notification is required if applicable.

- D. Medicaid enrollment must be presumptively started.
- E. Family outreach must be attempted.

# § 24-22-9 to 10. Surrender Safety Device Requirements

- A. Devices may be installed at 24/7 staffed safe haven locations.
- B. Devices must:
- Be securely affixed and viewable from inside the fire station;
- Be clearly visible to staff;
- Include climate control, transparent retrieval door, and safety alarm systems;
- Provide clear instructions and posted warnings (e.g., "No infants over 90 days");
- Undergo regular monitoring, maintenance, and monthly inspections;
- Be sealed and marked "UNSAFE—DO NOT USE" if defects are found, until reinspected by CYFD.
- C. Operators must notify CYFD 40 days before installation or repair and obtain inspection approval and decals.

# § 24-22-8. Immunity

All compliant actions by providers, staff, and site operators are shielded from criminal and civil liability under the Act, excluding negligence in medical care.

# New Mexico Fire Department-Specific Requirements

- 1. Fire stations must be certified by the State Fire Marshal as safe haven sites.
- 2. A licensed EMS provider (EMT, AEMT, or Paramedic) must be on-duty 24/7 at the station.
- 3. Surrender devices must be climate-controlled and installed to allow internal viewing and external anonymous access.
- 4. Devices must have an alarm system that alerts staff immediately when activated.
- 5. Instructions must be posted clearly, including warnings about age restrictions and legal immunity for the surrendering individual.
- 6. Devices must be inspected regularly by CYFD and sealed off if found unsafe.
- 7. Medical personnel must retrieve the infant, initiate care, and notify CYFD immediately.

# Stage Two Fire Restrictions Effective Immediately

Pursuant to the authority vested in the City of Bayard and in alignment with state regulations, the following fire restrictions are hereby enacted to mitigate the risk of wildfires and ensure public safety.

# **Prohibited Activities:**

- 1. <u>Charcoal briquettes and outdoor burning appliances</u>: Use is prohibited on all public and private property within the City of Bayard.
- 2. <u>UL/FM-approved gas pellet cooking devices</u>: Permitted but must be attended by a competent adult at all times during use.
- 3. <u>Fireworks (sale and use)</u>: <u>Prohibited.</u> All aerial devices, missile-type rockets, helicopters, spinners, stick-type rockets, and ground-based noise-producing devices. Possession or ignition within city limits is a citable offense.
- 4. <u>Campfires and fire pits:</u> Any open-flame fire, including those in designated pits or recreational fire features, is strictly prohibited.
- 5. <u>Use of combustion-powered equipment (e.g., chainsaws, mowers, trimmers):</u> Allowed only if the equipment is equipped with a properly installed, operational spark arrestor and used with extreme caution.
- 6. <u>Welding and open-flame operations:</u> Permitted only with a valid permit issued by the Fire Chief. All permits are automatically suspended during red flag warnings, high wind advisories, or fire weather watches as issued by the National Weather Service.

# **Enforcement and Penalties:**

Violations of these fire restrictions are punishable by:

- Fines: Up to \$300.00 per violation
- Imprisonment: Up to 90 days, or both fine and imprisonment

# **Declaration of Stage 2 Fire Restrictions Due to Drought Conditions**

Pursuant to the authority vested in the Office of the Fire Chief under City of Bayard Municipal Code Sec. 18-32, and in accordance with public safety responsibilities outlined under New Mexico State Fire Prevention and Public Safety statutes, the City of Bayard hereby enacts Stage 2 Fire Restrictions, effective immediately.

This action is necessitated by extreme drought conditions that elevate the risk of wildfire to a critical level. The following restrictions are now mandatory within the municipal boundaries of the City of Bayard and shall remain in effect until such time as conditions improve and this order is formally rescinded by the Fire Chief.

# **Prohibited or Regulated Activities**

- **4.** Campfires and fire pits: Any open-flame fire, including those in designated pits or recreational fire features, is strictly prohibited.

### ORDINANCE 2 -2025

### ANNEXATION ORDINANCE

AN ORDINANCE PROVIDING FOR THE ANNEXATION OF CERTAIN LAND, CONTIGUOUS TO THE CITY OF BAYARD WHEREIN WILL EXIST GOVERNMENTAL SERVICES AS PROVIDED BY THE GOVERNING BODY OF THE CITY OF BAYARD.

BE IT ORDAINED BY THE CITY OF BAYARD, NEW MEXICO, AS FOLLOWS:

Section 1. The City of Bayard hereby acknowledges receipt of the petition entitled "Petition to Annex Territory for the use of Governmental Services" (hereafter "petition" and finds that the petition complies with NMCA (1978) 3-7-17-(A) in that:

- a. Petition describes territory that is contiguous to the City of Bayard
- b. Petition has been signed by the owners of a majority of the number of acres in the contiguous territory;
- c. Petition was accompanied by a map and land description, entitled "Plat of Survey of Foy Land Tract", that shows the external boundary of the territory proposed to be annexed.

Section 2. This Ordinance incorporates the land description that is attached to the petition. See Exhibit 1.

Section 3. The City of Bayard hereby accepts the aforementioned petition and consents to the annexation of the land described therein.

Section 4. A copy of this ordinance and a copy of the plat of annexed territory shall be filed in the office of Grant County Clerk.

Section 5. The Bayard City Clerk shall send copies of this ordinance and the plat of territory annexed by this ordinance to the Secretary of Finance and Administration and to the Secretary of Taxation and Revenue.

Section 6. The annexation of said land shall not be construed to violate or extinguish any preexisting right of way, easements, licenses, or other covenants running with the annexed land.

Section 7. If any section, paragraph, sentence, clause, word or phrase of this ordinance is for any reason held to be invalid or unenforceable by any court or competent jurisdiction, such decision shall not affect the validity of the remaining provisions of this ordinance.

Section 8. This ordinance shall be effective upon its filing with the Grant County Clerk.

# **PETITION TO ANNEX TERRITORY**

- C. All Declarations of Candidacy shall be filed in the Office of the County Clerk on August 26, 2025, between the hours of 9:00 a.m. and 5:00 p.m.
- D. All Declaration of Candidacy for write-in candidates shall be filed in the Office of the County Clerk on September 2, 2025, between the hours of 9:00 a.m. and 5:00 p.m.
