Bayard Community Garden & Greenhouse Training Center Proposal

PROJECT OBJECTIVES

NCFC and the Frontier Food Hub seek to develop a dynamic training greenhouse and community garden center in the heart of the Mining District that will serve to enhance food security, provide educational opportunities, create jobs, and foster community engagement while promoting sustainable and traditional agricultural practices in Bayard and surrounding areas.

OUR ASK

In order to make this project a success we respectfully request:

- A 15 year lease for the 1 acre plot off Central Avenue in Bayard, adjacent to the fire station.
- A nominal lease rate of \$1 per year
- The city's formal support for the Community Garden and Greenhouse Training Center Project
- Use of city water source for drip and hand irrigation of trees, garden beds and greenhouse.

MAINTENANCE

NCFC commits to comprehensive property stewardship, including weekly landscaping, daily security checks, and monthly beautification efforts. We'll collaborate with local partners like the Bayard Beautification Committee and will organize local volunteers for ongoing maintenance, ensuring a safe, clean, and visually appealing community asset.

FUNDING

NCFC will work with several funders to bring this project to life including USDA, NMDA and numerous private foundations.

COMMUNITY PARTNERS

We will work with several community partners including the Commons, Gila Resources Information Project, Sembrando Salud and others.

PROJECT BENEFITS

- Studies show Community Gardens can increase property value by up to 9.5% within 5 years of launch
- Crime Reduction
- Youth engagement
- Community event and gathering space
- Increased physical activity and mental wellbeing

ECONOMIC IMPACT

- Estimated \$300,000 in project infrastructure spending over 3 years
- Will create 1-2 new jobs and incubate new small business

CONTACTINEO

Sec. 42-152. - Intent.

The intent of this zone is to recognize the existing mixed housing types and site development patterns of the city. This zone will allow only one single-family dwelling unit per lot. Single-family dwellings may include site built houses, manufactured houses, and mobile homes as defined in this chapter.

(Ord. No. 12-2009, ch. 10(intro. ¶), 9-14-2009)

Sec. 42-153. - Permissive uses.

The following shall be the permissive uses in the RM zoning district:

- (1) One single-family dwelling unit per lot;
- (2) Accessory uses and structures.

(Ord. No. 12-2009, § 10.1, 9-14-2009)

Sec. 42-154. - Conditional uses.

The following shall be the conditional uses in the RM zoning district:

- (1) Home occupations, (see division 8 of article VI of this chapter);
- (2) Public buildings and utility distribution structures, provided they are fenced and appropriately landscaped;
- (3) Day care or child care services as regulated by state department of human services;
- (4) Churches and related facilities, on a minimum of one-half acre, along a collector or arterial street;
- (5) Public and private schools, on a minimum of one acre;
- (6) Public parks provided a public hearing is held;
- (7) Travel trailer used as a dwelling unit during construction of a permanent dwelling unit on the same premises, provided a building permit has been issued by the construction industries division and such use does not exceed a period of 12 months;
- (8) Telecommunication towers will conform to the standards under the R1 zone section 42-131(8).

Sec. 42-155. - District standards.

The following standards apply to all land uses within this zoning district:

(1) Minimum lot size shall be 5,000 square feet.

- Item 1.
- (2) All structures shall be located with a front yard setback of no less than 20 feet and with side yard setback of no less than seven feet and with a rear yard setback of no less than 20 feet.
- (3) Accessory structures may be located five feet from the side or rear property line.
- (4) Minimum of two off-street parking spaces per dwelling unit.
