Shawna Burkhart commended the Public Works Director, Assistant Public Works Director, and Wesley Davis for clearing the water mains broken and road projects.

ITEMS / COMMENTS FROM THE MAYOR AND COUNCIL MEMBERS

Mayor Pro Tem Finlay likes what Public Works has done, Mayor Pro Tem Finlay added that the Rice Festival parade was well attended and that the Police Department looked professional and thanked the Fire Department for their assistance. Councilman Folse stated that he would like an app to track citizen requests. Councilman Folse asked everyone to be careful driving tonight. Councilwoman Sitz stated that she would like to see people working on Highway 35 and 60. Mayor Nelson thanked the road and bridge department for fixing 50 potholes in two days with the new equipment. Councilman Westmoreland asked Mayor Nelson if there have been any updates on the railroad tracks on 35 and Mayor Nelson responded that he has had no response from the Railroad other than it should be done by the end on the year.

Councilman Flores thanked staff for the Public Works Facebook posting. Councilman Flores also addressed some comments on Facebook regarding his pigs and read a statement in regards to new legislation for "right to farm". Councilman Westmoreland stated that he received emails and texts and wants to set the record straight that he was not notified of Councilman Flores' pigs being brought back into the city limits. Councilman Westmoreland played a recording of public comments made by Councilman Flores during past council meeting. Councilman Flores stated that he never asked Council to change their mind and that this is State legislature. Mayor Pro Tem Finlay requested 100% clarification from the attorney and that his vote is still firm and does not want pigs.

Mark Flash, IT Manager, requested Council to declare property as salvage. Mr. Flash stated that the equipment was unusable and had no value and has an e-waste provider to pick up at no charge. Councilman Flores asked if hard drives have been removed and Mr. Flash stated yes.

Motion made by Councilwoman Sitz to approve a declaration of data processing materials and equipment as salvage property and authorize staff to dispose of said salvage property through the use of an e-waste salvage provider, Seconded by Mayor Pro Tem Finlay. Voting Yea: Mayor Nelson, Mayor Pro Tem Finlay, Councilman Flores, Councilman Folse, Councilman Westmoreland, Councilwoman Sitz. Motion carried.

3. Grants ~ Discuss, consider, and or approve various equipment to be funded by the American Rescue Plan Funds and authorize staff to proceed with procurement.

Krystal Mason, Assistant Public Works Director, presented stating that the paver was added. Shawna Burkhart, City Manager, added that she had asked a Commissioner regarding sharing equipment. All four commissioners share equipment and have a lot of projects, so unlikely they can share with the City. Councilman Folse asked if prioritized, what would be taken off and Ms. Mason replied the pneumatic roller. Councilman Westmoreland asked how much is left in ARPA funds and Ms. Burkhart replied she did not have that information readily available. Council asked that the pneumatic roller be brought back to council if funding available.

Motion made by Councilman Folse to approve various equipment to be funded by the American Rescue Plan Funds and authorize staff to proceed with procurement with exception of the pneumatic roller. Seconded by Councilman Westmoreland. Voting Yea: Mayor Nelson, Mayor Pro Tem Finlay, Councilman Flores, Councilman Folse, Councilman Westmoreland, Councilwoman Sitz. Motion carried.

4. Agreement ~ Discuss, consider, and/or approve a Professional Services Agreement between the City of Bay City, Texas and LSPS Solutions, LLC for conducting Phase 2 of a study of the City of Bay City's water system service lines and preparing a service line inventory to comply with the U.S. EPA Revised Lead and Copper Rule, budgeted in Fiscal Year 2024 Capital Improvement Plan.

Herb Blomquist, Public Works Director, stated that the service line inventory was necessary to comply with a unfunded legislative mandate but the project is in budget. City will be able to identify many lines while at site repairs.

Motion made by Councilwoman Sitz to **a**pprove a Professional Services Agreement between the City of Bay City, Texas and LSPS Solutions, LLC, Seconded by Councilman Westmoreland.

Voting Yea: Mayor Nelson, Mayor Pro Tem Finlay, Councilman Flores, Councilman Folse, Councilman Westmoreland, Councilwoman Sitz. Motion carried.

ORDINANCE NO.

AN ORDINANCE REGULATING THE USE OF GOLF CARTS, NEIGHBORHOOD VEHICLES, AND OTHER TYPES OF RECREATIONAL OFF-HIGHWAY VEHICLES BY ADDING A NEW ARTICLE VII TO CHAPTER 110 OF THE CITY OF BAY CITY CODE OF ORDINANCES; PROVIDING FOR CODIFICATION; FIXING A PENALTY FOR FAILURE TO COMPLY WITH SUCH ORDINANCE; REPEALING ANY CONFLICTING ORDINANCES; AND SETTING AN EFFECTIVE DATE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BAY CITY, TEXAS.

<u>SECTION 1.</u> Chapter 110 of the City of Bay City Code of Ordinances is hereby created to add new Article VII., Golf Carts, Neighborhood Electric Vehicles and other Types of Recreational Off-Highway Vehicles, as described below.

SECTION 2. Sections 110.235-110.299 are reserved.

<u>SECTION 3</u>. The following sections are added to Article VII.:

Sec. 110.300. Definitions.

These terms shall have the following meanings:

All-terrain vehicle means a motor vehicle that is:

- 1. Equipped with a seat or seats for the use of:
 - a. The rider; and
 - b. A passenger(s), if the motor vehicle is designed by the manufacturer to transport a passenger(s);
- 2. Designed to propel itself with three or more tires in contact with the ground;
- 3. Designed by the manufacturer for off-highway use; and,
- 4. Not designed by the manufacturer primarily for farming or lawn care;

City means the City of Bay City, Texas.

Daytime means the period beginning one-half hour before sunrise and ending one-half hour after sunset.

Driver's license means an authorization issued by the Department of Public Safety for operation of a motor vehicle. The term includes a temporary license or instruction permit and an occupational license.



Golf cart shall have the meaning assigned by Texas Transportation Code § 502.001, as amended, which currently defines it as a motor vehicle designed by the manufacturer primarily for transporting persons on a golf course. It must have a minimum of four wheels and have an attainable top speed not greater than 25 miles per hour on a paved level surface and be manufactured primarily for transporting persons on a golf course and in compliance with those federal motor vehicle safety standards for low-speed vehicles. The term "Golf cart" shall not include those motorized conveyances commonly referred to as All-terrain vehicles ("ATVs"), off-road vehicles (also known as "ROVs"), four-wheelers, mules, gators, and design-altered Golf carts which have been altered to allow them to travel at a speed greater than 25 miles per hour.

Neighborhood vehicle (NV) (includes low speed vehicles "LSV") means a vehicle that can attain a maximum speed of 35 miles per hour on a paved level surface and otherwise complies with the definition of a "Neighborhood Electric Vehicle" as defined by Tex. Transp. Code §551.301 or with Federal Motor Vehicle Safety Standard No. 500; Low-Speed Vehicles (Effective Sept. 5, 2017). This standard specifies requirements for lowspeed vehicles. A low-speed vehicle is a gasoline or electric powered four-wheeled motor vehicle, other than a truck, whose attainable speed is more than 32 km/h (20 mph) and not more than 40 km/h (25 mph). The standard requires ten specific items of safety equipment. [Not listed. See Texas Transportation Code § 551.301] ** Has a normal maximum speed of 20—25 mph (LSV) or 20—35 mph (NEV). The term "Neighborhood vehicle" shall not include those motorized conveyances commonly referred to as All-terrain vehicles ("ATVs"), off-road vehicles (also known as "ROVs"), four-wheelers, mules, or gators.

Nighttime means the period beginning one-half hour after sunset and ending one-half hour before sunrise.

Operate shall mean driving.

Operator means any person driving and having physical control over the motor vehicle.

Park or *Parking* means the standing or stopping of a vehicle, whether occupied or not, other than temporarily for the purpose of and while actually engaged in loading or unloading merchandise or passengers.

Parking area means those areas accessible to the public by motor vehicular traffic and which are designated for temporary Parking of motor vehicles, usually in places referred to as Parking lots.

Recreational off-highway vehicle means a motor vehicle that is:

- 1. Equipped with a seat or seats for the use of:
 - a. The rider; and
 - b. A passenger or passengers, if the vehicle is designed by the manufacturer to transport a passenger or passengers;


- 2. Designed to propel itself with four or more tires in contact with the ground;
- 3. Designed by the manufacturer for off-highway use by the Operator only; and
- 4. Not designed by the manufacturer primarily for farming or lawn care.

Street means a public roadway in the City of Bay City, Texas by whatever name (e.g., road, alley, avenue, highway, route, boulevard, etc.) that is open to vehicular traffic.

Sec. 110.301. Limited operation.

- A. Golf carts and NV's are permitted to be Operated on:
 - 1. Streets where the posted speed limit is 35 miles per hour or less,
 - 2. A Parking area as defined by this article.
- B. The operation of a Golf cart shall be prohibited on any Street in the state highway system, regardless of the speed limit. The state highway system includes, but is not limited to, Hwy 35, 7th Street, Hwy 60, and Avenue F.
- C. Other Streets where golf carts are prohibited:
 - Nichols Road/FM 2668 from 7th Street/Hwy 35 to Hwy 60
 - 6th Street between Hwy 60 and Nichols/FM 2668
- D. A Golf cart may not be driven across intersections where the cross Street has a posted speed limit of more than 35 miles per hour.
- E. Nighttime driving of Golf carts is prohibited. Golf carts may only be driven during the Daytime.
- F. An NV may drive across intersections where the cross-Street has a posted speed limit of more than 35 miles per hour, even if the cross-Street is otherwise a prohibited Street under this article.
- G. Notwithstanding anything in this section 110.301 to the contrary, Golf Carts and Neighborhood Vehicles may be operated on public streets for activities related to parades permitted under this chapter and events organized or sponsored by the City of Bay City.

H. The operation of a Golf Cart shall be prohibited on any public sidewalk, pedestrian walkway, playground, public park, school ground, or other public recreational areas except on designated roadways or parking within these areas.



Sec. 110.302. Required equipment—Golf cart.

- A. A Golf Cart Operated under this article must be equipped, at a minimum, with the following equipment as mandated by the Texas Transportation Code §551.404(b), as amended, and/or required by the City to Operate on permitted locations:
 - 1. Operational headlamps;
 - 2. Operational tail lamps;
 - 3. Side reflectors;
 - 4. Operational Parking brake; and
 - 5. Rearview mirror(s).
 - 6. Turn signals;
 - 7. Horn;
 - 8. Brake lights;
 - 9. Seat belts;
 - 10. A safety-orange flag on a six-foot fiberglass whip pole; and
 - 11. Windshield
- B. A Golf cart that is Operated at a speed of not more than 25 miles per hour shall display a "slow-moving-vehicle emblem" as defined by Texas Transportation Code § 547.703.
- C. Equipment, and its installation and maintenance, must meet standards provided by the Texas Transportation Code, as amended.

Sec. 110.303. Required equipment—Neighborhood vehicle.

- A. A Neighborhood vehicle (NV), whether gasoline- or electric-powered must be equipped with the following equipment as mandated by Texas Transportation Code § 551.301, as amended, and/or required by the City, to Operate on permitted locations:
 - 1. Operational headlamps;
 - 2. Operational tail lamps;
 - 3. Side reflectors;
 - 4. Operational Parking brake;
 - 5. Rearview mirror(s);
 - 6. Turn signals;
 - 7. Horn;

- 8. Brake lights;
- 9. Seat belts;
- 10. Windshield; and
- 11. Vehicle identification number.
- B. Equipment, and its installation and maintenance, must meet standards provided by the Texas Transportation Code, as amended.

Sec. 110.304. Operator regulations.

- A. All Operators of Golf carts or NVs shall:
 - 1. Be licensed to Operate a motor vehicle as provided by Texas Transportation Code § 521.021, as amended, and carry a valid Driver's license as provided by Texas Transportation Code § 521.025, and all state law Driver's license permissions and restrictions shall apply to the operation of a Golf cart or NV;
 - 2. Abide by all state and local traffic regulations applicable to vehicular traffic;
 - 3. Not Operate or park on a sidewalk or hike and bike trails at any time;
 - 4. Not use the vehicle to pull any object or person at any time;
 - 5. Not exceed the seating capacity of the vehicle as designed by the manufacturer;
 - 6. Remain seated at all times while the vehicle is in motion, and ensure the same for passengers. Passengers can be issued a citation for not remaining seated while vehicle is moving;
 - 7. Drivers and all riders must be restrained in a seat belt at all times;
 - 8. Maintain financial responsibility as defined in Texas Transportation Code § 601.051; and
 - 9. Not intentionally or knowingly allow an unlicensed Operator to Operate the vehicle.
 - 10. Use headlights at any time the Golf Cart or Neighborhood Vehicle is in operation.

Sec. 110.305. All-terrain vehicles, Recreational off-highway vehicles.

It shall be unlawful for a person to Operate an ATV or ROV on a Public Street or location except as provided by state law and this section. A person may only drive across a public Street or highway that is not an interstate or limited-access highway, if done so in accordance with state law. (See Texas Transportation Code § 663.037, as amended.)

Sec. 110.306. Penalties.

Only warning citations may be issued for the first 60 days following the effective date of this article so that an educational effort by the City may be conducted to inform the public about the importance and requirements of this article. In addition to traffic violations for which the owner or driver of the Golf cart or NV may be subject to pursuant to state law, any person who violates this article shall be guilty of a misdemeanor punishable by a fine of up to \$500.00. Each day's violations shall constitute a separate and distinct offense. Any prior conviction under this article will count towards a second and third charge regardless of when it occurred.

<u>SECTION 4.</u> It is the intention of the City Council that this ordinance shall become a part of the Code of the City of Bay City, Texas, and it may be renumbered and codified therein accordingly, in the manner approved by the City Attorney.

<u>SECTION 5.</u> Failure to comply with any provision of this ordinance shall be punished by a fine not to exceed Five Hundred and No/100 (\$500.00) per day that said person is in violation of this Ordinance.

<u>SECTION 6.</u> If any part of this ordinance is, or should be held invalid for any reason, then that fact shall not invalidate the entire ordinance, but the balance thereof shall remain in full force and effect.

<u>SECTION 7.</u> All ordinances or parts of ordinances in conflict herewith are hereby repealed.

<u>SECTION 8.</u> The City Secretary shall publish this Ordinance as required by City Charter.

<u>SECTION 9.</u> This ordinance shall become effective upon the final passage date shown below.

Executive Summary of Item:

The Drinking Water State Revolving Fund, authorized by the Safe Water Drinking Act, provides low-cost financial assistance for planning, acquisition, design, and construction of water infrastructure. Eligible applicants for the DWSRF include publicly and privately-owned community water systems, including nonprofit water supply corporations and non-profit non-community public water systems.

The City of Bay City was awarded \$21,300,000 in funding from the Texas Water Development Board (TWDB) to make critical improvements to the City's water systems. These improvements will include upgrades to our existing water plants, water distribution system, and a new water plant. \$12,000,000 is allocated to Water Treatment Plant improvements.

Two proposals were received for the Water Treatment Plant Project which were in turn checked for accuracy and compliance with contract documents. Using the Competitive Sealed Proposal (CSP) process the two proposals were evaluated for Cost, Offeror's experience with similar projects, Offeror's key personnel experience, Offeror's major subcontractors experience, and approach and contract schedule. Through the CSP process, the evaluation committee determined LEM Construction submitted the best value proposal for the project. As a result of the contractor selection process, it is City staff's recommendation to move forward with LEM Construction to negotiate a contract for the East Water Treatment Plant project.

Dear Mr. Blomquist:

This letter serves as Garver's recommendation to proceed with LEM Construction for the Bay City North and East Water Treatment Plant (WTP) Project. This recommendation is based on the completed evaluation of the Competitive Sealed Proposal (CSP) process.

Proposals were received for the "Bay City North and East WTP Improvements" project on August 31st, 2023. A total of two (2) proposals were received on the project. The proposals have been checked for accuracy and for compliance with the contract documents. Using the CSP process, the two proposals were evaluated based on Cost, Offerors' experience with similar projects, Offerors' key personal experience, Offerors' major subcontractors experience, and the Offerors' approach and project schedule. A tabulation of the cost portion of the proposals received is enclosed with this letter, along with the overall evaluation conducted by the City's scoring team.

During the CSP evaluation, cost scoring was based upon the Overall Project Adjusted Base Proposal values indicated in the attached Proposal Tabulation. For this evaluation and Adjusted Base Proposal, none of the original Proposal Alternates were accepted. Thus, the evaluated pricing for LEM was \$21,382,250.00.

Garver recommends further adjustments (cost reductions) to this evaluated pricing during proposal negotiations. First, Garver recommends that the City ultimately include the removal of the North WTP scope from the project (including acceptance of LEM's Proposal Alternate N-5). Pricing for this alternate was provided by both offerors on October 12, 2023, and LEM indicated an overall pricing reduction of \$9,966,750. Additionally, further reductions are warranted of the Cash and Contingency Allowances specifically associated with the North WTP construction (Cash Allowance No. 1 for \$50,000 for the electrical service to the North WTP site; Contingency Allowance No. 3 for \$75,000 for the North WTP Utility Relocation). Finally, LEM has proposed additional cost mitigation items (such as generator modifications, aluminum conduits, piping embedment detail modifications, etc.) that the City and Garver may further evaluate and accept. Pricing has been provided on some items previously, and additional value engineering ideas may yield further reductions.

In summary, the anticipated contract value is \$11,008,500 or lower, pending further negotiations for cost mitigation and value engineering. Prior to issuance of the Notice of Award, Garver anticipates the

development of Change Order No. 1 (CO1) to formally modify the Contract Documents with the post-Proposal period modifications to the project scope. This Change Order would be provided as part of the Notice of Award to LEM for authorization as part of the Agreement.

Through the CSP process, the evaluation committee determined that LEM Construction submitted the best value proposal for the project.

BACKGROUND: The American Rescue Plan (ARP) Act of 2021 – the latest COVID-19 stimulus package - became law on March 11, 2021. (1.9 trillion economic stimulus bill)

The City of Bay City received \$4,353,513.57 from the US Treasury as allocated in the American Rescue Plan (ARP) Act.

ARPA requires **<u>OBLIGATION</u>** of all funds by 12-31-2024 and all projects are to be **<u>COMPLETED</u>** by 12-31-2026.

FINANCIAL IMPACT: The list below is an estimate only and due to inflation, the cost may be higher.

RECOMMENDATION: On October 31, 2023, City Council approved the procurement of the paver, smooth drum roller and sheep foot roller for in-house road rehab projects. Recommend City Council approve staff to begin the federal procurement process for the pneumatic roller (through competitive bidding since >\$50,000).

Notice of Intent- CO SERIES 2024A (CWSRF)

BACKGROUND: The Clean Water State Revolving Fund, authorized by the Clean Water Act, provides low-cost financial assistance for planning, acquisition, design, and construction of wastewater, reuse, and stormwater infrastructure. The City was approved by the Texas Water Development Board (TWDB) for financial assistance to make critical improvements to the City's wastewater systems. These improvements will include upgrades to our existing wastewater treatment plant, wastewater lift stations, and wastewater collection system.

The resolution attached serves as a notice of intent to issue debt. The maximum principal amount will not exceed \$7,124,000. This is the 4th and final issue that will occur during the project period. This bond will fund the following:

- Infrastructure improvements including the planning, acquisition, design, and construction of the City's wastewater treatment plant, lift stations, and sewer lines
- Professional services related to the projects listed above

WHEREAS, the City of Bay City, Texas (the "City") is pursuing financial assistance from the Texas Water Development Board (the "TWDB") under the Clean Water State Revolving Fund; and

WHEREAS, the City Council of the City (the "City Council") deems it advisable to issue certificates of obligation (the "Certificates") of the City in accordance with the notice hereinafter set forth in order to evidence a loan from the TWDB; and

WHEREAS, it is hereby found and determined that the meeting at which this resolution is considered is open to the public as required by law, and public notice of the time, place and purpose of said meeting was given as required by Chapter 551, Texas Government Code, as amended; NOW, THEREFORE

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BAY CITY, TEXAS THAT:

<u>Section 1.</u> The findings, determinations, definitions and recitations set out in the preamble to this resolution are found to be true and correct and are hereby adopted by City Council and made a part hereof for all purposes.

<u>Section 2.</u> The City Secretary is hereby authorized and directed to cause to be published in the manner required by law and in substantially the form attached hereto as <u>Exhibit</u> <u>A</u>, a notice of the City's intention to issue the Certificates (the "Notice").

<u>Section 3.</u> The Notice shall be published once a week for two (2) consecutive weeks in a newspaper that is of general circulation in the City, the date of the first publication to be at least forty-six (46) days before the date tentatively set in the Notice for the passage of the ordinance authorizing the issuance of the Certificates. In addition, the Notice shall be posted continuously on the City's website for at least forty-five (45) days before the date tentatively set in the Notice for the passage of the ordinance authorizing the issuance of the Certificates.

<u>Section 4.</u> For the purposes of the Notice, the City hereby designates as self-supporting those public securities listed in the attached <u>Exhibit B</u>, the debt service on which the City currently

pays from sources other than ad valorem tax collections. The City plans to continue to pay these public securities based on this practice; however, there is no guarantee this practice will continue in future years.

Section 5. For purposes of section 1.150-2(d) of the Treasury Regulations, to the extent that an official intent to reimburse has not previously been adopted by the City, this Notice serves as the City's official declaration of intent to reimburse itself from proceeds of the Certificates in the maximum principal amount and for expenditures paid in connection with the projects, each as set forth in Exhibit A hereof. Any such reimbursement will only be made (i) for an original expenditure paid no earlier than 60 days prior to the date hereof and (ii) not later than 18 months after the later of (A) the date the original expenditure is paid or (B) the date the project to which such expenditure relates is placed in service or abandoned, but in no event more than three years after the original expenditure is paid.

<u>Section 6.</u> The City hereby authorizes the City's financial advisor, USCA Municipal Advisors, LLC, bond counsel, Bracewell LLP, and engineer, Garver LLC, to proceed with the necessary arrangements for the sale of the Certificates and the receipt of financial assistance from the TWDB.

<u>Section 7.</u> The Mayor, City Manager, Finance Director, Director of Public Works, City Secretary, and other officers and agents of the City are hereby authorized and directed to do any and all things necessary or desirable to carry out the provisions of this resolution.

<u>Section 8.</u> This resolution shall take effect immediately upon its passage.

Section 9. The notice and agenda relating to this meeting and heretofore posted by the City Secretary, and the posting thereof, are hereby authorized, approved, and ratified.

EXECUTIVE SUMMARY

Notice of Intent- CO SERIES 2024D (DWSRF)

BACKGROUND: The Drinking Water State Revolving Fund, authorized by the Safe Drinking Water Act, provides low-cost financial assistance for planning, acquisition, design, and construction of water infrastructure. The City of Bay City was approved by the Texas Water Development Board (TWDB) for financial assistance to make critical improvements to the City's water systems. These improvements will address arsenic mitigation and water capacity.

The resolution attached serves as a notice of intent to issue debt. The maximum principal amount will not exceed \$11,910,000. This bond will fund the following:

- Arsenic removal and water plant improvements
- Water Mains & related infrastructure to reduce water loss

RECOMMENDATION: Staff recommends City Council approve the resolution as presented.

WHEREAS, the City of Bay City, Texas (the "City") is pursuing financial assistance from the Texas Water Development Board (the "TWDB") under the Drinking Water State Revolving Fund; and

WHEREAS, the City Council of the City (the "City Council") deems it advisable to issue certificates of obligation (the "Certificates") of the City in accordance with the notice hereinafter set forth in order to evidence a loan from the TWDB; and

WHEREAS, it is hereby found and determined that the meeting at which this resolution is considered is open to the public as required by law, and public notice of the time, place and purpose of said meeting was given as required by Chapter 551, Texas Government Code, as amended; NOW, THEREFORE

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BAY CITY, TEXAS THAT:

<u>Section 1.</u> The findings, determinations, definitions and recitations set out in the preamble to this resolution are found to be true and correct and are hereby adopted by City Council and made a part hereof for all purposes.

<u>Section 2.</u> The City Secretary is hereby authorized and directed to cause to be published in the manner required by law and in substantially the form attached hereto as <u>Exhibit</u> <u>A</u>, a notice of the City's intention to issue the Certificates (the "Notice").

<u>Section 3.</u> The Notice shall be published once a week for two (2) consecutive weeks in a newspaper that is of general circulation in the City, the date of the first publication to be at least forty-six (46) days before the date tentatively set in the Notice for the passage of the ordinance authorizing the issuance of the Certificates. In addition, the Notice shall be posted continuously on the City's website for at least forty-five (45) days before the date tentatively set in the Notice for the passage of the ordinance authorizing the issuance of the Certificates.

Section 4. For the purposes of the Notice, the City hereby designates as self-supporting those public securities listed in the attached <u>Exhibit B</u>, the debt service on which the City currently

pays from sources other than ad valorem tax collections. The City plans to continue to pay these public securities based on this practice; however, there is no guarantee this practice will continue in future years.

Section 5. For purposes of section 1.150-2(d) of the Treasury Regulations, to the extent that an official intent to reimburse has not previously been adopted by the City, this Notice serves as the City's official declaration of intent to reimburse itself from proceeds of the Certificates in the maximum principal amount and for expenditures paid in connection with the projects, each as set forth in Exhibit A hereof. Any such reimbursement will only be made (i) for an original expenditure paid no earlier than 60 days prior to the date hereof and (ii) not later than 18 months after the later of (A) the date the original expenditure is paid or (B) the date the project to which such expenditure relates is placed in service or abandoned, but in no event more than three years after the original expenditure is paid.

<u>Section 6.</u> The City hereby authorizes the City's financial advisor, USCA Municipal Advisors, LLC, bond counsel, Bracewell LLP, and engineer, Garver LLC, to proceed with the necessary arrangements for the sale of the Certificates and the receipt of financial assistance from the TWDB.

<u>Section 7.</u> The Mayor, City Manager, Finance Director, Director of Public Works, City Secretary, and other officers and agents of the City are hereby authorized and directed to do any and all things necessary or desirable to carry out the provisions of this resolution.

<u>Section 8.</u> This resolution shall take effect immediately upon its passage.

Section 9. The notice and agenda relating to this meeting and heretofore posted by the City Secretary, and the posting thereof, are hereby authorized, approved, and ratified.

NOTICE IS HEREBY GIVEN that the City Council of the City of Bay City, Texas (the "City"), will meet at City Hall, 1901 5th Street, Bay City, Texas 77414 at 6:00 p.m. on the 9th day of January, 2024, which is the time and place tentatively set for the passage of an ordinance and such other action as may be deemed necessary to authorize the issuance of the City's Combination Tax and Surplus Revenue Certificates of Obligation, Series 2024D (DWSRF), in the maximum aggregate principal amount not to exceed \$11,910,000, payable from ad valorem taxes and from a pledge of a lien on the surplus revenues of the City's water and sewer system, bearing interest at any rate or rates not to exceed the maximum interest rate now or hereafter authorized by law, as shall be determined within the discretion of the City Council of the City at the time of issuance of the certificates of obligation, and maturing over a period not to exceed forty (40) years from the date of issuance, for the purposes of evidencing the indebtedness of the City for all or part of the costs of improvements to and the equipment of the City's water system, including the planning, acquisition, design, construction, and equipment of (i) arsenic removal and water plant improvements, (ii) elevated storage tanks, (iii) water mains and related infrastructure, and (iv) the costs of professional services related thereto. The Certificates are being issued to evidence the receipt of financial assistance from the Texas Water Development Board under the Drinking Water State Revolving Fund. The estimated combined principal and interest required to pay the Certificates on time and in full is \$19,127,233. Such estimate is provided for illustrative purposes only and is based on an assumed interest rate of approximately 3.50%. Market conditions affecting interest rates vary based on a number of factors beyond the control of the City, and the City cannot and does not guarantee a particular interest rate associated with the Certificates. As of the date of this notice, the aggregate principal amount outstanding of tax-supported debt obligations of the City (excluding public securities secured by an ad valorem tax but designated by the City as self-supporting in Resolution No. R-2023-23, dated November 14, 2023, which resolution is available from the City upon request) is \$8,690,050. Based on the City's expectations, as of the date of this notice, the combined principal and interest required to pay all of the outstanding tax-supported debt obligations of the City (excluding public securities secured by an ad valorem tax but designated by the City as self-supporting) on time and in full is \$10,485.247. The Texas Water Development Board has issued a commitment for financial assistance related to the project in a maximum total amount of \$15,000,000, which includes the Certificates, the City's proposed Tax and Revenue Certificates of Obligation, Series 2024C (for which the City is separately providing notice under Resolution No. R-2023-22) and up to \$500,000 in principal forgiveness.
