

RE: Fee Schedule



It is best practice to periodically review the fee schedule to ensure the City is recouping the cost of providing services in areas for which fees apply. The services for which a city imposes a user or regulatory fee typically derive from an individual person or entity's action, request, or behavior, Therefore, except in cases where there is an overwhelming public benefit generated by a city's involvement in the individual action, a fee for service ensures that the individual bears most, if not all, of the cost incurred by the City to provide that service.

Ongoing review and adjustment of fees provides multiple benefits, including:

- Increasing the availability of General Fund revenues to be used for services and activities available to all Bel Aire residents and businesses, such as public safety services.
- Keeping pace with the general cost inflation.
- Providing fee payers, city staff, and city policymakers with a pattern of consistency that provides information for forecasting and decision-making purposes.

DISCUSSION:

Staff has recommended several changes to the current fee schedule. The following document shows "current fee", "proposed change" and "reason for change" to direct the workshop discussion. Most major changes have data and comparative statistics embedded in each section.

↑ 2.1.5, 2.1.6 and 2.1.7: By City Code, a Solicitor License and a Peddlers License are to be issued for a 30-day period and Transient Merchant License for 90 days. The proposed change aligns city code with our fee structure. The charge of \$15 per person is for the required background check.

A Vendor and Peddler are similar in the fact they go door to door for sales. A Peddler has the product with them, and a Solicitor takes orders. A Transient Merchant sets up space somewhere and customers come to them. Due to zoning, transient merchants are very rare. A flat fee plus per person fee is charged as you might have a business with multiple salespeople. For example, a Solar Sales Company may have a dozen salespeople. A flat fee is charged for the company and the per person fee covers the background check process. Each individual person receives a permit to keep on their person while soliciting sales. Background checks are valid for one year which is helpful for business such as a door-to-door meat salesperson who may apply for a 30 day permit a few times each year.

Salary Comparison

The Public Policy and Management Center (PPMC) completed an analysis of salaries for 30 positions on behalf of the Local Government Network (LGN). This study included matching position titles, classifications, and requirements and then comparing the designated salaries across each identified position.

Sixteen cities and counties shared their salary information for comparison. Those participating were: Abilene, Andover, Bel Aire, Butler County, Derby, Goddard, Halstead, Haysville, Herrington, Reno County, Sedgwick, Sedgwick County, Sterling, South Hutchinson, Valley Center, and Wichita. The average salaries at the minimum, midpoint, and maximum pay for each position were calculated.

In addition, the positions were matched in CompAnalyst. CompAnalyst market data is a "state-of-the-art process for benchmarking and analyzing jobs that builds on the professional industry standards employed by compensation analysists" (Salary.com). The CompAnalyst data is comprised of surveys that are paid for, versus self-reported data, which is subjective. Information in CompAnalyst is updated in real time to ensure that the most up-to-date data is available to users. The system not only matches jobs, but also creates hybrid positions to align closely with the duties outlined in position descriptions. CompAnalyst system also allows users to apply scopes to the data being extracted. Through this system, the PPMC was able to pull data from the geographic locations and place a governmental industry filter to the data. This narrows information in order to provide the most accurate wage data on each position description.

Finally, given the differences across the participating cities and counties in population size, each position was reviewed for salary range at each the minimum, midpoint, and maximum. This information will allow communities to compare where their salaries fall within the specified range.
