PUBLIC HEARING OF PROPOSED ORDINANCES

Ordinance No. 2022-O-2 AMENDING ARTICLE 15, FLOOD DAMAGE PREVENTION, OF THE BELLBROOK ZONING CODE (Harding)

Mr. Harding read the Ordinance Title and a synopsis of the contents.

Mayor Schweller opened the public hearing. Mr. Schommer explained the Ordinance makes changes to the National Flood Insurance Program Map and Article 15 of the Zoning Code. He noted the addresses listed as modified for the map were all either reduced from 100 year flood plain to 500 year flood plain or removed all together. He added the changes to the map can make changes to insurance and encouraged anyone with changes or located on the map to verify through ODNR or contacting City Hall for assistance in interpreting.

Hearing no further discussion or comments, Mayor Schweller closed the public hearing.

INTRODUCTIONS OF ORDINANCES

Ordinance 2022-O-3 AMENDING ORDINANCE 2022-O-1 BY MAKING SUPPLEMENTAL APPROPRIATIONS FOR EXPENSES OF THE CITY OF BELLBROOK FOR THE PERIOD BEGINNING JANUARY 1, 2022 AND ENDING DECEMBER 31, 2022 AND DECLARING AN EMERGENCY (Cyphers)

Mrs. Cyphers read the Ordinance title and a synopsis of the contents.

Mr. Schommer explained the purpose of the ordinance is for an increase to the budget for health insurance refunds and an adjustment from fire fund to capital for the purchase of the new medic. He noted the Ordinance is written to be considered for adoption at the introduction.

Mr. Schommer explained in 2018 the City agreed to accept acreage of open green space in accordance to the Development Agreement with Highview Terrace. The Park District is interested in acquiring the land, and they are the appropriate entity to own and make use of the land.

Resolution 2022-R-9 AUTHORIZING THE CITY MANAGER TO ENTER INTO AN AGREEMENT WITH CORE & MAIN FOR THE PURCHASE OF FIRE HYDRANTS (Schweller)

Mayor Schweller read the Resolution.

Mr. Schommer noted the CIP included purchase of fire hydrants as part of the replacement and maintenance program. He added that although the purchase is under the purchasing threshold required for bidding or Council approval, the internal practice is to quote and bring to Council purchases of \$25,000 or higher. Of the quotes received, Core & Main was the lowest and best.

Mr. Harding asked if there were delays in shipping the items. Mr. Schommer deferred to Mr. Pasley who indicated they are about 6 months out, and that time frame did not cause an issue.

A motion to adopt Resolution 2022-R-9.

Resolution 2022-R-10 AUTHORIZING THE CITY MANAGER TO PURCHASE A MEDIC UNIT FOR USE BY THE FIRE DEPARTMENT THROUGH THE OHIO COOPERATIVE PURCHASING PROGRAM, AND WAIVING THE COMPETITIVE BIDDING REQUIREMENTS (Greenwood)

Mr. Greenwood read the Resolution.

Mr. Schommer explained this purchase was included in the 2022 CIP. Once the quotes came back from the State bid, the price was higher than originally planned in the CIP; however, delivery is expected 15 to 18 months out and the funds would not be expended until then.

Mr. Greenwood commented the Fire Department has taken this purchase very seriously and several members of the department worked hard to figure out the best piece of equipment needed.


