<u>Commercial Water Rates</u> - The Town Manager asked Council for direction on how they'd like to handle the matter of multiple bills for businesses sharing one water meter. He noted a memo from the Town Attorney was included in Council's packets. The Town Attorney supported a revision to Town Code to address this issue. The consensus of Council was to have staff present a formal ordinance at the March Council meeting at which time they could authorize the Town Manager to advertise a Public Hearing to be held at the April meeting.

<u>Bowling Green Police Department Policy and Procedure Manual</u> - The Police Chief asked that Council act on approving the draft Bowling Green Police Department Policy and Procedure Manual he presented. The Town Attorney recommended against approving the Manual before reading it. She stated she would review the Manual and return her recommendations to Council.
