## **PUBLIC HEARINGS:**

**ZP 2018-010 for 221 N. Main Street -** At 7:01 P.M. the Mayor opened the Public Hearing for ZP 2018-010 An application by Bowling Green Properties, LLC for a Special Use Permit to allow for residential mixed use in a B-1 zoning at 221 N. Main Street.

The Mayor noted an ad for Public Hearing had been run in the Free Lance Star newspaper on August 21 and August 28, 2018. He invited the public to speak on this matter. The Mayor called a second and third time for public comment. Hearing none, he closed the Public Hearing at 7:02 P.M.

**Introduction of SERCAP Virginia State Manager -** The Town Manager introduced Andy Crocker of Southeast Rural Community Assistance Project, Inc (SERCAP). Mr. Crocker spoke about SERCAP's initiatives and how they are able to help the Town.

FY 2016-2017 Audit Presentation

Adam Davis of Davis and Associates presented the firms audit findings. He noted that the Town has a good focus on Internal Controls and that Personnel responsible for the accounting and finance functions within the Town are very experienced.

## **PUBLIC COMMENTS:**

Eddie Thomas, owner Doug's Septic Service – Mr. Thomas expressed his disagreement with being billed for dumping sewage at the Town's Waste Water Treatment Plant. He explained that he has been dumping at the plant for more than a year and that he has never received a bill. He stated he was told by staff at the Treatment Plant that sewage pumped from property in town was not subject to dumping fees. It was not until September 5, 2018 that he received a bill and it included dates as far back as January 2017. He asked that Council waive these fees and stated that he would have no issue with paying the fees moving forward.

The Mayor said that Council would consider the matter and contact him once a decision had been made.
