#### 1. Call to Order

Mayor Carson called the meeting to order at 6:30 p.m., and the Clerk confirmed the presence of a quorum. City Manager Rudometkin, Chief Grimm, Attorney Langley, Public Works Director Phil Price, and City Clerk Yolanda Quiceno were also present.

#### 2. Invocation and Pledge to Flag

Comm Smith gave the Invocation and led the Pledge to the Flag.

#### 3. Public Comments & Announcements

Mayor Carson opened for public comment.

• Former Commissioner Anthony Carugno, residing at 2372 Hoffner Avenue, shared safety and liability concerns regarding E-bikes and golf carts using sidewalks. He shared a personal incident where he was hit by an E-bike while blowing leaves on their sidewalk and narrowly avoided being hit by a car after falling into the street. He asked about liability procedures when a pedestrian is injured by an E-bike or golf cart, especially involving uninsured or underage drivers. He questioned what protections are in place for injured pedestrians. He further inquired about previously discussed plans for raised and lighted crosswalks for traffic calming and pedestrian safety, and expressed concern about visibility issues during sunrise due to sun glare. He requested updates on planned crosswalks at Hoffner Avenue, Dorian, and the corner of Trentwood & Daetwyler.

With no further comments, Mayor Carson closed the public comments.

#### 4. Presentations

#### Appeal of CE 25-0432: 1612 Idaho Avenue

City Manager Rudometkin gave a summary of the Code Violation issued to the homeowner of 1616 Idaho Avenue. Michael Litchfield gave testimony and addressed the council regarding a recent parking violation. He explained that due to ongoing construction near their home and contractor vehicles occupying nearby space, they were unable to maneuver their boat trailer into the driveway safely and had to park it temporarily on the street. He said he is a new resident and obtained a decal after the fact; however, he acknowledged understanding and support for the parking signage and regulations, which help maintain resident-only access. He appeared before the council to request understanding and forgiveness as a first-time homeowner, unfamiliar with the entire process and parking limitations at the time.

The council then discussed the appeal for a \$150 parking fine. After discussion, Comm Bobrowski moved to waive the \$150 parking violation but kept the \$50 administrative fee. Comm Shuck seconded the motion, which passed 5:2 with Comm Lowell and Comm Smith, nay.

Mayor Carson noted that the courtesy will only be extended one time and that he should adhere to the parking rules.

#### 5. Consent Items

A. Approval of the City Council Meeting Minutes – September 30, 2025

Mayor Carson called for a motion to approve the consent items.

Comm Shuck moved to approve the consent item as presented.

#### 6. Unfinished Business

#### a. 3904 Arajo Condemnation Update

City Manager Rudometkin spoke on the ongoing concerns regarding the condition of a residential property being worked on by homeowner Ms. Lizer. He stated that Ms. Lizer has been attempting to secure funding for continued repairs but has faced delays. She had cleaned up the property in the past week, which was appreciated, though residents expressed a desire for more frequent maintenance. The roof has been repaired; however, Mr. Bernard reported that exterior wall damage is more extensive than expected, requiring reconstruction before painting can begin. Ms. Lizer said she can provide photos and plans to use annuity funds to help finance the ongoing work. She was unclear about how much she owed on her mortgage and unsure about the annuity fund disbursement for home repairs and was undecided whether to sell the home. CM Rudometkin emphasized to Ms. Lizer that the current state of the property is not sustainable, and it must either be fully repaired on an ongoing basis or potentially demolished.

The council discussed whether to proceed with demolition or assist Ms. Lizar with renovations. They agreed that the situation has been ongoing for far too long and that it is important to approach it with utmost care and consideration. The Council shared that they wouldn't want to see the homeowner spend their last resources trying to save a home that may be ultimately demolished. The Council discussed with the City Attorney finding an attorney or law firm that will offer pro-bono assistance to ensure Ms. Lizer will not be taken advantage of in the process. CM Rudometkin stated that he and the staff have visited the home and in their professional opinion, the house will need significant funds to make it habitable. The Council discussed with Ms. Lizer the consideration of seeking pro-bono legal assistance, as well as exploring the option of selling the house to someone who can remodel it and live in it without financial burden. A discussion ensued regarding the city's estimated cost of approximately \$20,000 to demolish the home or find a way to mitigate the situation. The Council discussed a 30-day extension with a timeline for the work plan moving forward.

After discussion, Commissioner Partin moved to grant 30 days for the city manager and attorney to work together with Ms. Lizer to explore a solution to resolve the issues with her property, including options for pro bono legal assistance. Commissioner Lance seconded the motion, which passed unanimously 7:0.

#### 7. New Business

#### a. Going Paperless in 2026

City Manager Rudometkin said the staff is recommending a trial phase and a paperless process for handling agenda packets, to be environmentally friendly and utilize iPads. A brief discussion ensued. Following the discussion, the Council reached a consensus to move forward with the recommendation and provide a copy of the agenda sheet only during sessions. Packets can be made available upon request.

#### 8. Attorneys' Report

Attorney Langley discussed the possibility of holding an executive session before the next council meeting to provide an update and answer questions regarding the Quevedo litigation. The proposed time for the session is 6:00 PM. The executive session would be limited to Council Members, the Mayor, Rick, the City Attorney, and would require the presence of a court reporter. All discussions must be transcribed and will remain exempt from public record until the case concludes. Members were reminded that everything said during the session is on record and must pertain strictly to the litigation; no other topics may be discussed. Of the two lawsuits filed, one has been dismissed entirely. A motion to dismiss the second case has been filed. Council was asked to confirm interest in holding the executive session at 6:00 PM before the next meeting.

After discussion, the Council reached a consensus to hold the Executive Session at 5:30 p.m. on October 21, 2025, following a Council meeting that starts at 6:30 p.m.

#### 9. City Manager's Report

City Manager Rudometkin gave an update on Hurricane Ian recovery efforts. He has been in ongoing discussions with KPMG regarding documentation requests; some concerns have been raised, but a resolution is expected in the coming weeks. A future workshop will be scheduled for a more in-depth discussion. He noted that he and the Mayor met with Commissioner Scott, who shared a copy of the new Orange County redistricting maps. Commissioner Mike Scott (District 6) discussed the redistricting process, briefly touching on annexation and fire services. Copies of the maps were provided for Council review. Members are encouraged to stop by the office to review and discuss them further.

#### 10. Chief's Report

Chief Grimm reported that staff met with FDOT and their consultant last Thursday regarding Hansel Road improvements, particularly near the school. While the city has limited jurisdiction, FDOT will conduct a traffic study starting in approximately two weeks. The study will evaluate options such as school zone designation, improved signage, lighted crosswalks, or traffic signals at

the Wallace intersection. He further added that the traffic flow around the school has improved this year, though peak times still see congestion. He shared dates of upcoming events:

- Oct 8: Annual PD Agency Training
- Oct 9: Homecoming Golf Cart Parade
- Oct 18: "Always Wear Your Seatbelt" 5K
- Oct 25: DEA Drug Take-Back Day
- Oct 25: Ducktoberfest
- Oct 29: "Boogie on the Bridge" City annual event with extended road closures from 3:30 PM through the evening. All event-related closures and updates will be shared via the city website, police department social media, and digital signage in advance

A full September report will be presented at the next meeting.

#### 11. Public Works Report

Phil Price, Public Works Director, gave an update on the Orange County force main installation project along Judge Road. The contractor anticipates completing main construction by mid-next week, with night work at the Conway/Judge intersection scheduled to begin around October 20. Lane closures will occur overnight from 9 PM to 5 AM.

Final site restoration, including sodding and cleanup, is expected to be completed by the second week of November. Minimal additional work remains near Arajo and at the lift station tie-in point. This is an Orange County project taking place within the city right-of-way. No permanent sidewalk improvements are included; however, some sections were temporarily removed to facilitate the installation of pipes. Public safety has been maintained, and overall traffic control (MOT) has been effective.

#### 12. Council Report

The council thanked staff, PD, and Public Works for their hard work and for moving projects forward. Comm Lowell thanked Lizary Simons, the City Hall Administrative Assistant, for her positive and disarming demeanor when helping residents and visitors. Comm Lance also commented on what a great job Lizary is doing. He also reported that the Daetwyler Shores Association has installed its playground equipment with the money from the BING Grant. It really looks good and is an asset to the neighborhood. Comm Smith reminded Council to attend the Tri-County meeting on October 16<sup>th</sup>.

Comm Vertolli announced that he will not be running for re-election for his district and welcomes the residents to apply.

#### 13. Adjournment

There being no further business, Mayor Carson called for a motion to adjourn the meeting, which passed unanimously at 8:15 pm.

We also proudly welcomed back Officer Mendez from his military service and brought Officer Ramos on board, two great additions to the Belle Isle PD team.

I want to thank our City Manager and all city staff for their hard work during the budget process. A special thank you goes out to the Budget Committee for their dedication and input, and especially to Tracey Richardson for once again putting together one of the most detailed and fiscally sound municipal budgets in the region. It's clear that we're in good hands, and I'm proud of how we continue to prioritize smart, responsible spending.

#### **Arrests and Notable Incidents**

#### September 1, 2025 – Verbal Dispute / Informational Report

At approximately 1945 hours, officers responded to a residence on Saint Partin Place in reference to a possible battery. Upon arrival, officers spoke with all involved parties, including two family members engaged in a verbal dispute during a personal belongings exchange. Conflicting statements were made, with one party reporting a history of familial tension and prior incidents. A visible black eye on one individual was attributed to a separate act by another family member not present at the time. Audio recordings were reviewed, and no physical altercation was evident. Fire rescue evaluated one party for precautionary reasons. Due to conflicting accounts and lack of probable cause, no charges were filed. The matter was documented for informational purposes only. All parties were advised accordingly, and the scene was cleared without further incident.

#### **September 1, 2025 – Domestic Violence Investigation (Ongoing)**

At approximately 1945 hours, officers responded to a residence on Saint Partin Place in reference to a possible battery. Upon arrival, officers contacted the involved parties outside the residence, and permission was granted to enter and speak with the alleged aggressor. An informational report had previously been generated for the initial incident with no crime established. During this contact, one individual disclosed an alleged incident from two weeks prior in which a family member reportedly threw her into a refrigerator, dragged her by the hair, and struck her head on the carpet multiple times, causing visible injuries including a black eye and laceration. She also alleged a history of abuse, including threats and intimidation by the same family member, and expressed fear of retaliation. Photographs of her injuries were taken, and a Domestic Violence Lethality Assessment determined the situation to be potentially lethal. She was advised of her rights under Marsy's Law, provided domestic violence resources, and signed a declaration of prosecution while declining an authorization for release of confidential information. Efforts were made to contact the other family member for a statement; the following day, the family member came to the police department and stated the incident was an attempt to stop further battery against himself. This case remains ongoing and under investigation.

#### September 1 – Injunction Violation and Suspect Evasion

On September 1, 2025, officers responded to a report of an injunction violation at a residence on Flowertree Road. The suspect had an active temporary injunction prohibiting him from being within 500 feet of the location. Upon arrival, officers observed a male matching the suspect's general description but using evasive behavior. After being granted entry to the home, a thorough search was conducted with negative results. However, a review of body-worn camera footage and a positive ID by a supervising officer confirmed that the initial male encountered was the respondent listed in the injunction. A warrant was authored by a responding officer for multiple charges, including Burglary, Aggravated Stalking After Injunction, and Violation of Injunction. The investigation is ongoing under case number BI25-0654.

#### September 2 – Burglary and Domestic Violence Injunction Violation

On September 2, 2025, at approximately 10:43 p.m., officers were dispatched to the same Flowertree Road residence regarding a burglary in progress. The victim reported that the same respondent from the prior day had unlawfully entered the residence multiple times without consent, including cutting power to the home and making threatening statements to intimidate her. A Domestic Violence Lethality Assessment was conducted, revealing a high-risk situation due to threats involving weapons, physical control, and stalking behavior. The victim presented documentation confirming an active final injunction served on the suspect in July 2025. Based on the investigation, officers established probable cause for multiple felony charges. A warrant request was submitted for Burglary of a Dwelling, Aggravated Stalking after Injunction, and Violation of Injunction. Immediate arrest was deemed necessary due to escalating behavior and credible threats of harm.

#### September 2, 2025 – Cannabis and Paraphernalia Seized at Hotel

At approximately **2:43 AM**, an officer conducted an investigation at a hotel on McCoy Road in Belle Isle. During the encounter, 1.6 grams of suspected cannabis, a rolling tray, and a grinder were recovered and collected for destruction. The subject was not charged. The officer's issued body-worn camera was activated during the incident.

#### **September 2, 2025 – Narcotics Violation**

At approximately 7:07 PM, officers made contact with an individual near Hoffner Avenue and Cullen Lake Shore Drive. During the encounter, officers observed cannabis and related paraphernalia. A total of 2.6 grams of suspected cannabis, along with a grinder, rolling tray, and a jar with residue, were collected and submitted for destruction. The property was documented on the official receipt.

#### September 2, 2025 – Incident Involving Suspected Cannabis and Paraphernalia

At approximately 9:42 PM, an officer made contact with a subject at 1934 McCoy Road, within the Extended Stay Hotel. During the encounter, the odor of cannabis was detected. Further

investigation resulted in the seizure of a rolling tray with residue and 18.3 grams of suspected cannabis. The items were collected for destruction and logged under case number BI25-0653. A property receipt was completed, and the officer's issued body-worn camera was active during the encounter.

#### September 3 – Commercial Burglary at Duke Energy Substation

On September 3, 2025, at approximately 6:58 p.m., an officer responded to the Duke Energy Substation on McCoy Road regarding a delayed report of a commercial burglary. The reporting party, a representative of Duke Energy, advised that aerial surveillance detected the facility's main gate unsecured. Upon inspection, it was discovered that the gate lock had been cut and copper wiring was stolen from three separate storage spools located within the secured perimeter.

The theft is believed to have occurred sometime within the last three to four weeks. The stolen wiring included over 2,300 feet of copper wire with a total estimated value exceeding \$11,000. The damaged gate lock added an additional loss. Surveillance cameras were present on-site, and the company retained the SD cards for review. No physical evidence was able to be recovered from the scene due to the nature of the environment. A sworn statement was taken, and prosecution was requested. The case remains under investigation.

#### September 3 – Drug Arrest at Closed Business Arrest

At approximately 1:10 a.m., an officer observed a suspicious individual loitering in the parking lot of a closed business on Hoffner Avenue. Upon being noticed, the subject discarded an item and began walking away quickly. Officers noted the odor of cannabis, observed furtive movements, and attempted to detain the individual for investigation.

The subject was uncooperative and resisted efforts to detain him, leading to a brief struggle before he was placed in handcuffs with the assistance of additional responding units. The individual exhibited signs of stimulant use, including rapid speech, pacing, and physical indicators such as a pulsating carotid artery and constricted pupils.

A probable cause search of his bag revealed a THC vape pen, a makeshift smoking device, and a loose prescription amphetamine pill wrapped in a piece of notebook paper matching one found in his possession. A search of the area where the subject was initially seen revealed the discarded contraband.

The subject was charged with possession of amphetamine, possession of THC, tampering with evidence, possession of drug paraphernalia, and resisting an officer without violence. He was transported to the Orange County Jail without further incident. All evidence was submitted to the Belle Isle Police Department, and the individual's personal items were secured for safekeeping.

At approximately 11:47 p.m., officers responded to a well-being check at a residence on Lake Drive. A concerned acquaintance reported that the 61-year-old resident had not been seen since August 29, which was highly unusual. The reporting party, who had access to the home, allowed entry by police and Orange County Fire Rescue personnel.

Upon entry, the resident was found deceased in bed. He showed signs consistent with death by natural causes, including rigor mortis and lividity. No signs of trauma or foul play were present. The decedent was pronounced deceased by Orange County Fire Rescue at 12:02 a.m. on September 4.

No medical records or medications were located in the home, and there was no known next of kin at the time of the report. The Medical Examiner's Office was notified, and the decedent was transported for further examination under Case #25-1468.

#### September 5, 2025 – Suspicious Activity / Marijuana Destruction

An officer made contact with an individual near Judge Road and Conway Road at approximately 11:37 AM. During the interaction, the officer observed two rolled cigars containing a green leafy substance consistent with marijuana. The items were collected and later submitted for destruction in accordance with department policy. The individual was not arrested, and the case was documented under BI25-0660.

#### **September 5 – Arrest for Driving While License Revoked (HTO Status)**

At approximately 3:00 p.m., an officer on routine patrol conducted a traffic stop on a blue Nissan Juke traveling eastbound on Hoffner Avenue near Duban Avenue. A registration check revealed the registered owner's driver's license was revoked.

Upon contact, the driver confirmed knowledge of his revoked status and admitted he was working to pay outstanding tolls in hopes of reinstatement. Records showed the driver was designated as a Habitual Traffic Offender and had previously been cited for the same offense in July.

The driver was arrested for Operating a Motor Vehicle While License Revoked (Habitual Traffic Offender) under F.S.S. 322.34(5). The vehicle was towed from the scene, and the subject was transported to the BRC without incident.

#### **September 6 – Aggravated Battery (Stabbing Arrest)**

Officers responded to a stabbing incident at a local hotel on McCoy Road. Upon arrival, the victim was found with a stab wound to the lower back and was initially uncooperative, refusing to identify the suspect or pursue prosecution. The victim was treated on scene and transported to the hospital.

Through initial interviews and scene investigation, officers identified a group of individuals who had been drinking together in the parking lot prior to the incident. One subject was located with

minor injuries and initially denied any involvement. A second witness confirmed there was a physical altercation between the parties but did not directly observe the stabbing.

Later, the victim requested to amend his statement from the hospital and provided a full written and sworn account, identifying the individual who stabbed him and describing the circumstances. The suspect was re-interviewed but denied the stabbing. Based on the victim's new statement, supporting witness comments, visible injuries, and admissions of a physical altercation, officers established probable cause.

The suspect was arrested and charged with Aggravated Battery with a Deadly Weapon and transported to BRC without incident. The weapon used in the assault was not recovered.

#### September 6 – Domestic Battery and Child Neglect Arrest

Officers responded to a residence on Hawford Circle for a reported domestic disturbance involving multiple family members. The investigation revealed that during an argument, one adult forcibly grabbed another's wrist while taking a phone, causing visible bruising, and also spit on a juvenile family member twice during the incident. At one point, the same adult forced a door open with such force that it broke off the hinges and struck a small child, causing the child to fall. The adult was arrested and charged with two counts of Domestic Battery and Neglect of a Child for creating a dangerous situation that resulted in the child being struck.

Another juvenile family member admitted to punching and spitting on the adult during the altercation while the adult was holding the child, and charges for Domestic Battery are being filed for that offense as well. All involved parties provided statements, photographs and video footage were collected, and the Department of Children and Families was notified for further investigation.

#### September 8 – DUI Arrest and Drug Seizure

An officer conducted a traffic stop on Hoffner Avenue after clocking a vehicle at 44 mph in a posted 30 mph zone. During contact with the driver, signs of impairment were immediately observed, including the odor of alcohol and cannabis, bloodshot and glossy eyes, and slurred speech. The driver admitted to consuming beer and taking a shot of whiskey earlier in the evening. A probable cause search of the vehicle revealed an open bottle of Johnnie Walker Black Label and two small baggies containing cannabis.

Field sobriety exercises were conducted, during which the driver displayed multiple indicators of impairment across all three tests. A breath test at the DUI Center later revealed a BAC of 0.172—more than double the legal limit. The driver was arrested for DUI, issued citations for speeding and open container, and transported to the Orange County Jail. Cannabis was submitted for destruction per policy.

#### **September 9 – Aggravated Battery Arrest (Vehicle Involved)**

Officers responded to the Sienna Place Apartments regarding a physical altercation between two residents. The victim reported that a known individual had followed her around the complex, yelling profanities and escalating a prior verbal dispute. The suspect reportedly kicked her foot and later struck her in the leg with the front bumper of his vehicle while she was on foot, causing visible bruising. A witness confirmed the verbal altercation and observed the suspect driving after the victim, though they did not witness the physical contact.

Based on the statements, observed injury, and investigation, probable cause was established for aggravated battery with a deadly weapon (vehicle). The suspect was arrested without incident and transported to BRC. The victim was provided with a Victim's Rights pamphlet and advised of available protections due to her continued fear for safety.

#### September 10 – Felony Warrant Arrest / Suspect Flees Into Residence

During the morning hours, a detective from Belle Isle Police Department conducted a warrant check on an individual encountered along Daetwyler Drive. When the individual was informed of an active in-county felony warrant for aggravated stalking after an injunction, he fled into a nearby residence located outside city limits. Additional officers responded and established a perimeter with assistance from Orange County K-9.

Consent to search was granted by the homeowner of the initial residence, but the subject was not located. Officers then tracked the suspect through a known fence-jump location and were advised by individuals at a second residence that someone was inside. Permission was granted to enter, and the suspect was located hiding inside a closet by K-9.

The subject was secured and later transported by Rescue 50 to a local hospital after complaining of dizziness and chest pain during transport. He was charged with resisting without violence for fleeing and hiding from clearly identified officers and was also served with his final injunction while in custody.

#### September 11 – Vehicle Burglary / Suspicious Person Matching Prior Description

An officer responded to a vehicle burglary at a residence along Hoffner Avenue during the early morning hours. The victim reported that several fishing rods, valued at approximately \$550, were taken from the bed of his pickup truck sometime between 5:30 AM and 6:10 AM while he was preparing for a trip. A sworn statement was obtained and the victim expressed a desire to prosecute.

During a canvass of the area, a nearby resident provided surveillance footage showing an unknown male on a white bicycle or tricycle with a baby trailer passing the victim's truck and returning. The view of the bed area was obstructed, but the timing aligned with the theft. A suspicious person call earlier that morning at a nearby condominium complex had also described a white male on a similar bicycle peering into parked vehicles.

A department-wide alert was issued, and another officer later referenced a prior field interview that may identify the person of interest. The investigation remains open pending confirmation and further leads.

#### September 12 – DUI Investigation in Gym Parking Lot Arrest

An officer was flagged down by two citizens regarding a woman sitting in a running vehicle with her pants down in the rear parking lot of a gym along Hoffner Avenue. The officer located the woman in the driver's seat of a gray SUV with her pants down, legs outside the door, and a strong odor of urine in the area. Three empty 32-ounce beer cans were visible on the front passenger seat. The woman admitted to consuming all three beers. She displayed bloodshot and watery eyes, slurred speech, and belligerent behavior.

The officer attempted field sobriety exercises, but the driver was argumentative and uncooperative, ultimately failing to complete them. The driver was diabetic but refused medical attention after paramedics arrived for a well-being check. She refused to provide a breath sample at the Orange County DUI Center after being advised of the consequences.

Based on the totality of circumstances open containers, impairment indicators, urination at the scene, poor performance on sobriety exercises, and refusal to comply the driver was placed under arrest for DUI and transported to the Orange County Jail. The vehicle was secured at the scene.

#### September 12 – Petit Theft at Wawa Arrest

An officer responded to the Wawa gas station on Hoffner Avenue to assist with a subject stop involving a theft in progress. Another officer on scene observed a male subject exit the store carrying four cases of beer and loading them into a vehicle parked in a handicap spot. When confronted, the male admitted to stealing the items. A total of six 12-packs of beer and two 12-packs of Sprite were taken without payment. Surveillance footage confirmed the suspect entered the cooler twice, bypassed all points of sale, and exited through the rear of the store with the items. The total value of merchandise was \$149.01. The store manager recovered the items and provided a sworn statement along with a receipt for documentation. The suspect was arrested and transported to the Orange County Jail without incident. The vehicle was released to the registered owner at the scene.

#### September 13 – DUI Arrest at Judge and Conway Arrest

While on patrol, an officer observed a vehicle stationary at a green light at Judge and Conway Road. Upon approach, the driver was found asleep at the wheel with the vehicle in drive and their foot on the brake. Once awakened, the driver appeared disoriented, with slurred speech, bloodshot watery eyes, and the odor of alcohol present. A cup containing beer was observed in the center console. The driver admitted to consuming alcohol and agreed to participate in field sobriety exercises, during which multiple impairment indicators were observed. Based on the totality of circumstances, the subject was arrested for DUI and transported to the Orange County

DUI Center. Breath tests returned results of .181 and .182, both over twice the legal limit. The vehicle was towed and the subject was later transported to BRC without incident.

#### September 14, 2025 – Destruction of Suspected Cannabis

At approximately 10:04 a.m., an officer made contact with a subject at 2323 McCoy Road in Belle Isle. During the encounter, suspected cannabis was located inside the center console of a white 2015 Audi A4. The officer detected the odor of cannabis and developed probable cause for a search based on both the smell and the subject's admission. A total of 30.3 grams of suspected cannabis, contained in a ziplock bag, was seized and submitted for destruction under case number BI25-0676.

#### September 17 – Accidental Firearm Discharge (Medical Assist)

Officers responded to a residence on Horizon Court in reference to a male who accidentally discharged his firearm, resulting in a gunshot wound to his hand. The subject reported he was cleaning his firearm when it discharged unexpectedly, striking his right hand. He was alert, coherent, and not under the influence of any substances. Orange County Fire Rescue transported him to Orlando Regional Medical Center for treatment. No children or others in the residence were harmed. The investigation determined the incident was accidental in nature, with no criminal violations observed.

#### **September 18 – Traffic Stop Attempt and Fleeing Occupant (FLOCK Hit)**

An officer attempted a traffic stop on a white Nissan Rogue following a FLOCK alert for an expired tag. As the vehicle turned onto St. Marie Avenue and slowed, the driver unexpectedly fled on foot while the vehicle was still in drive. The officer, in full BIPD uniform and operating an unmarked unit, issued loud verbal commands but did not pursue due to potential unknown occupants in the vehicle. Additional units canvassed the area with negative results. A phone was located inside the abandoned vehicle, displaying a mapped route to an Orlando address. Based on phone content and items found in the car, a person of interest was identified. The registered owner later confirmed the subject had access to the vehicle. The Nissan was towed by ACE Wrecker and the registered owner was informed of recovery procedures. No positive identification of the fleeing subject has been made at this time.

#### September 19, 2025 – Cannabis for Destruction

At approximately 7:48 PM, an officer made contact with a subject near the intersection of Hoffner Avenue and Cullen Lake Shore Drive in Belle Isle. During the interaction, the officer took possession of a bag containing approximately 14.9 grams of suspected cannabis. The substance was documented for destruction. A property receipt was completed, and the subject was not arrested. Body-worn camera footage was captured during the incident.

#### 09/20/2025 - Suspicious Incident Involving Cannabis and Drug Paraphernalia

At approximately 7:53 PM, an officer made contact with a male subject on Lindos Drive near the intersection of McCoy Road in Belle Isle. The interaction led to the discovery of suspected cannabis and related paraphernalia inside the subject's possession. The subject voluntarily surrendered the following items for destruction:

- One orange THC vape pen
- A bag containing 17.6 grams of cannabis
- Drug paraphernalia, including a grinder with green leafy residue

The subject did not possess a valid Florida address and was temporarily residing in Lake Placid, Florida. The items were properly documented under Belle Isle Police Department case number BI25-0692 and submitted for destruction. No arrests were made in connection with this incident.

#### September 20 – Motorcycle Traffic Stop and Arrest on Warrant

While conducting traffic enforcement in the early morning hours, an officer observed a motorcycle traveling 48 mph in a posted 30 mph zone near Hoffner Avenue and Wandsworth Avenue. The motorcycle had a loud modified exhaust, and the operator was not wearing the required eye protection. A traffic stop was conducted, during which the rider admitted he had recently purchased the motorcycle, had not registered it, and did not possess a motorcycle license or endorsement. A records check revealed an active warrant out of Orange County for fleeing and eluding. The operator was arrested without incident and transported to the Orange County Jail. The motorcycle was towed from the scene. Additional charges included driving with a suspended license, no registration, and no motorcycle endorsement. Body-worn camera footage documented the entire encounter.

# September 21 – Arrest for Battery on Law Enforcement Officer and Resisting with Violence

While conducting a patrol of a hotel parking lot on McCoy Road, an officer observed a male sitting in a black SUV emitting a strong odor of both burnt and fresh cannabis. A consensual encounter quickly escalated when the subject became increasingly aggressive and noncompliant. The officer observed drug paraphernalia and a large axe within reach of the subject. The individual refused multiple commands, resisted attempts to detain him, and began striking the officer with his hands and feet. The officer deployed a Taser warning to gain compliance, and with backup assistance, the subject was ultimately secured. A probable cause search revealed approximately 5.4 grams of suspected cannabis, multiple cannabis roaches, grinders, rolling trays, and additional paraphernalia. The subject was transported to the Orange County Jail and charged with battery on a law enforcement officer and resisting with violence. No narcotics-related charges were filed. The officer sustained minor injuries during the altercation.

#### September 24 – Cannabis Seizure Following Suspicious Incident Call

An officer responded to a suspicious incident at a hotel on McCoy Road and was met on scene by another unit who had initiated a consensual encounter with the driver of a parked vehicle. A strong odor of cannabis was detected coming from the car. Upon contact, the driver admitted—through a language barrier—that marijuana was in the center console. A probable cause search of the vehicle revealed a plastic bag containing a green leafy substance. No additional contraband or evidence was located. The subject was identified by a foreign passport and cleared through state and national databases with no warrants or alerts. The individual was released without charges, and approximately 8.6 grams of suspected cannabis were collected and submitted for destruction.

#### September 25, 2025 – Narcotics Arrest (2323 McCoy Road)

At approximately 11:00 PM, officers responded to a suspicious incident involving four individuals inside a parked vehicle at 2323 McCoy Road. Upon contact, a strong odor of cannabis was detected, establishing probable cause for a search. All occupants were detained without incident.

A search of the vehicle resulted in the discovery of a red backpack containing ten individually packaged bags of suspected cannabis and a THC vape. Two additional bags of cannabis were found in the front passenger area. The total combined weight of the presumed cannabis was approximately 347 grams.

Two individuals were arrested and charged with possession with intent to sell. A third subject admitted to purchasing cannabis and is being charged through the State Attorney's Office.

#### September 26 – Injunction Service at Wyndham Hotel

An officer responded to the Wyndham Hotel on McCoy Road in reference to a court-ordered injunction. Upon arrival, the petitioner provided documentation and requested service of the injunction against a female subject who was staying on-site. Contact was made with the respondent inside the hotel, and the injunction was formally served. A copy of the served order was returned to the petitioner. The Orange County Sheriff's Office Warrants Section was notified to update the status of service.

#### September 27 – Traffic Stop Leads to Arrest for Suspended License

At approximately 10:21 p.m., a sergeant observed a black Hyundai traveling eastbound on Hoffner Avenue near Driscoll Court and conducted a traffic stop after discovering the vehicle's registration was over 11 months expired. The vehicle stopped near Wandsworth Avenue. Upon contact, the driver was found to have a suspended license with multiple suspensions, including a criminal failure to appear. The driver was placed under arrest for knowingly operating a vehicle with a suspended license. Citations were issued for the expired registration, knowingly driving with a suspended license, and displaying an altered tag. The subject was transported to booking without incident.

#### September 29 – Suspicious Incident / Welfare Check

At approximately 2000 hours, officers responded to a report at 5140 Conway Road regarding a possible suicide attempt, which was later determined to be a suspicious incident. The initial caller stated that a church member had sent "goodbye" and "thank you" messages to several people, behavior described as out of character. Attempts to reach the individual by telephone were unsuccessful. It was further reported that the person has no permanent address and is currently staying at an Airbnb in the Pine Hills area while working at a restaurant on International Drive.

Officers attempted to identify the individual through FCIC/NCIC and Teletype systems, including checks in Florida, Ohio, and Illinois, with negative results. Screenshots of the text messages were collected and submitted into evidence under this case number.

#### **Traffic Crash Reports**

Belle Isle PD investigated 7 crashes in September, ranging from minor collisions to more serious incidents involving injuries and significant property damage. Below is a brief overview of each incident:

#### September 3 – Crash

At approximately 5:20 PM, a rear-end collision occurred on McCoy Road at Daetwyler Drive. One vehicle failed to stop in time, striking another that was yielding to traffic. No injuries were reported, and both vehicles were drivable. A citation was issued for careless driving.

#### 09/11/2025 - Vehicle Crash

At approximately 7:40 PM, officers responded to a two-vehicle crash at 4400 Hoffner Avenue. One vehicle was exiting a private parking lot and attempted to turn left onto Hoffner Avenue, failing to yield to eastbound traffic. The second vehicle struck the rear quarter panel of the turning vehicle. Both vehicles sustained minor damage and were able to be driven from the scene. No injuries were reported. A citation was issued for careless driving.

#### September 12, 2025 – Traffic Crash

At approximately 9:00 AM, two vehicles were involved in a crash near the intersection of Daetwyler Drive and Prairie Fox Lane. One vehicle was making a right turn when the second vehicle, traveling behind, failed to see the turn in time and struck the rear of the turning vehicle. Both vehicles sustained approximately \$1,500 in minor damage. No injuries were reported. The at-fault driver was cited for following too closely. Both vehicles were removed from the scene by the drivers. My body-worn camera was activated during the incident.

#### September 15, 2025 – Traffic Crash (Mortier Avenue and Hoffner Avenue)

At approximately 6:00 PM, officers responded to a traffic crash at the intersection of Mortier Avenue and Hoffner Avenue. Vehicle 1 was stopped on Mortier Avenue attempting to make an eastbound turn onto Hoffner. As it entered the roadway, the front bumper of Vehicle 1 collided with the front quarter panel of Vehicle 2, which was traveling westbound on Hoffner.

Vehicle 1 sustained approximately \$3,000 in damage and was driven from the scene. Vehicle 2 incurred an estimated \$10,000 in damage and was towed by ACE Wrecker to 5601 S. Orange Blossom Trail. The driver of Vehicle 2 was transported to H.C.A. Airport North Hospital by OCFR 72 for injuries sustained in the crash. The driver and passenger of Vehicle 1 declined medical attention.

#### September 16, 2025 – Traffic Crash (Wallace Street and Hansel Avenue)

At approximately 3:00 PM, officers responded to a traffic crash on Wallace Street near Hansel Avenue. Vehicle 2 was stopped in traffic, waiting to make a northbound turn onto Hansel Avenue, when it was struck from behind by Vehicle 1. The front bumper of Vehicle 1 collided with the rear bumper of Vehicle 2, resulting in minor damage to both vehicles.

Vehicle 1 sustained approximately \$100 in damage.

Vehicle 2 sustained approximately \$1,000 in damage.

Both vehicles were driven from the scene by their owners. ACE Wrecker did not respond. All involved parties refused medical attention after being asked multiple times. The driver of Vehicle 1 was cited for careless driving resulting in a crash (citation #AK35VKE).

#### September 22, 2025 – Traffic Crash (CVS Parking Lot, 5190 Conway Road)

At approximately 2:00 PM, officers responded to a minor crash in the parking lot of CVS located at 5190 Conway Road in Belle Isle. Vehicle 1 (V1) was parked facing northbound. As V1 exited its parking space with a sharp right turn, it made contact with Vehicle 2 (V2), which was also parked facing northbound in the adjacent space. V1 struck the left front bumper of V2, nearly detaching it.

Estimated damage to V1 was approximately \$800.

Estimated damage to V2 was approximately \$5,000.

There were no reported injuries, and fire rescue was not called to the scene. The driver of V2 had the vehicle towed, while the driver of V1 left the scene in their vehicle.

#### September 29, 2025 – Traffic Crash (CVS Parking Lot, 5190 Conway Road)

At approximately 1:08 PM, officers responded to a traffic crash in the parking lot of CVS located at 5190 Conway Road in Belle Isle. Vehicle 1 (V1) exited a parking space by making a sharp right turn and struck the left front bumper of Vehicle 2 (V2), which was stationary in the adjacent space and also facing northbound. The impact nearly detached the bumper of V2.

Estimated damage to V1 was approximately \$800. Estimated damage to V2 was approximately \$5,000.

No injuries were reported and fire rescue was not called. The driver of V2 had the vehicle towed, while the driver of V1 drove away from the scene.

#### **Code Enforcement**

During September, the Code Enforcement Division opened a total of 36 new cases and closed 22. The most common violation addressed was related to rental permits, with 16 cases opened and 3 resolved. Parking-related complaints remained steady, with 3 new cases opened and 4 closed. Issues involving tall grass and weeds resulted in 3 new cases, while two were successfully resolved. Other common violations included expired vehicle tags (2 opened, 1 closed), landscaping concerns (2 opened, 1 closed), and permit-related issues, including "no permit" and "permit required" violations, all of which were addressed and closed by month's end.

Less frequent violations included animal control, stormwater issues, tree trimming, accessory structures, and complaints about trash or debris, each of which had one new case opened. In several instances, cases from previous months, such as watering violations and public nuisance issues, were also resolved during this reporting period. Overall, the department continued to maintain proactive enforcement while closing out several lingering cases from earlier in the year.

# CITY OF BELLE ISLE NEIGHBORHOOD GRANT "BING" PROGRAM GUIDELINES

1. **Definition: Only** Neighborhood improvement projects in the municipal limits for the City of Belle Isle proposed by a group of homeowners or by neighborhood or homeowners' associations within registered and operating limits of the City of Belle Isle shall be considered and eligible for funding under this program.

## **PROJECT CRITERIA**

- 2. To be eligible, proposed neighborhood projects **shall:** 
  - a. Be located or take place within the city's boundaries or its contiguous right of way within Belle Isle City limits.
  - b. Provide a public benefit to the neighborhood.
  - c. Shall not endorse or promote any religious or political affiliation or beliefs;
  - d. Involve neighborhood residents directly in all phases;
  - Be limited to capital improvements, and not association's operating expenses or budget, or fees and costs of consultants, attorneys or accountants, or any other professional services (costs of consultants, attorneys or accountants or any other professional services are considered in-kind as stated in 2.n., below);
  - f. Not conflict with or modify existing or proposed public improvement projects (Curb, sidewalk, drainage structures or pipes, utilities), unless approved by the City Manager or City Council:
  - g. Represent the neighborhood property owners;
  - h. Designate a person, association, or responsible entity to perform the administration and maintenance for the next ten years.
  - i. Do not count the maintenance effort as part of the applicant's match. It is NOT the intent of this grant program for the City to provide or pay for future maintenance.
  - j. Be able to award a construction contract within one month of grant allocation approval by City Council
  - k. Provide a 50/50 match of the total cost of the project, including cash, volunteer effort, materials, or any combination (based on availability)
  - I. Provide project cost estimate and project schedule. Petitioners must use Orange County estimate forms.
  - m. Include a signed letter of agreement with the City, assuming all liability, insurance, maintenance, and holding the city harmless; the letter of agreement will provide the applicant with the city's acceptance of the project and confirmation of project grant allocation.
  - n. Consider, as part of the project cost at full market value, in-kind contributions received by the neighborhood. Such contributions shall include items of the total project cost when

- provided by residents possessing specific skills as an in-kind contribution (i.e., a licensed plumber providing plumbing work at a discounted rate or no charge, a lawyer rendering legal services, or a surveyor providing survey work. Non-skilled labor contributions can benefit the project at the minimum hourly wage. Federal labor and wages will apply.
- o. Neighborhood improvement grants shall be limited to the available funds, which the City Council will determine upon adopting the annual City Budget. A District Commissioner may agree to hold over any spending from one year to the next.
- p. Before receipt of a grant through this program, Applicants shall make every effort to secure funding from Orange County neighborhood grants before considering their application.

  Grants are limited to one per year per neighborhood group.

#### **TYPES OF PROJECTS**

- 3. The types of projects include capital improvements, but they are not limited to them. They may also include a playground and minor park improvements, benches, neighborhood beautification, neighborhood identification signs, neighborhood walls, fences, landscaping of common areas, common area improvements, irrigation of common areas, lighting, etc.
- **4.** All projects will be conducted in accordance with all applicable federal, state, and local laws. Projects involving private property must have the written permission of the property owners. It is the grant recipient's responsibility to obtain any normally required permits (e.g., **building permits**).
- 5. Applications will be evaluated by the City Manager. The City Manager will inform the District Council Commissioner of the application. The City Manager will consider each grant application based on the following:
  - a. The quality and scope of the proposed project;
  - b. Level of neighborhood participation in the project;
  - c. Need for the project, and;
  - c. Neighborhood's matching contribution.

## 6. Requirements: To participate in the BING Program, applicants must;

- a. Meets all requirements listed in item #2
- b. Meets all requirements under eligible projects;
- c. submit the proposed Project Budget (projected expenses and contributions), Project Title Plan/Timeline, Volunteer Hour Pledge Sheets, documentation of the required match, and a copy of the association's meeting minutes reflecting the membership vote of approval for the grant (if applicable) or petition of support from the majority of affected residents; One bid required for mini-grants \$1,500 or less and, three bids required for grants over \$1,500.
- 7. Payment

City Manager shall review and approve all payments under this Program, when a detailed budget is submitted, invoices are provided and W-9s are signed and delivered for any check greater than \$600.00 made out to an individual.

8. Submit the completed BING application to the City Manager

City of Belle Isle City Hall 1600 Nela Avenue Belle Isle, Florida, 32809.

- 9. The funding application shall include a description of the project or improvement that is to be made, a budget for the project (which includes in-kind contributions and projected costs), a project plan (which estimates the amount of time from start to completion of the project), and evidence of support for the project through a signature petition of the majority of residents in the impacted area.
- 10. To determine the maximum matching grant money for which a project is eligible, the applicant must document residents' volunteer labor at minimum wage, in-kind donations at actual retail value, and skilled labor at a normally billed hourly rate.
- 11. The City Council will consider each project individually on its own merit and determine if it shall receive funding and the level of financial support warranted. The maximum 50/50 match per district for any one project.
- 12. Projects may be shared between districts and will be given a high priority for funding
- 13. The City may pay Grant monies directly to vendors for services or materials or at the end of the project to the homeowners' group in reimbursement for monies expended, provided sufficient supporting documentation.
- 14. the minor project grant program intends to assist with neighborhood improvements to as many neighborhood groups within the City as possible. Due to funding limitations, there is no guarantee that any project will receive the maximum grant. Rather, this program intends to ensure that as many qualified projects as possible receive some level of financial support.

# Background:

We spend around \$75,000-\$85,000/year on credit cards. We do not spend enough to qualify for other types of cards, like we discussed earlier. We don't come close to the minimum spend requirement.

After investigation, we are going to stay with the cards we have now, earning gift-card rewards, and we will amend the current policy in place as to how we can use the rewards.

# Staff Recommendation:

Stay with the cards we currently have and amend the policy governing redemption and use of the rewards. We currently have around 137,628 points. The best current option is to redeem the points for \$100 Amazon gift cards @,13,000/points each, since we do make several purchases from Amazon. We would track the use and make sure they are recorded correctly.

# Suggested Motion:

I move to authorize the city manager and finance director to amend the current credit card policy governing redemption and use of the gift-card rewards for Amazon gift cards.

#### PROFESSIONAL SERVICES AGREEMENT

THIS PROFESSIONAL SERVICES AGREEMENT (herein "Agreement"), is extended and entered into this 20<sup>th</sup> day of August 2025 by and between the **CITY OF BELLE ISLE**, a municipal corporation of the State of Florida, whose address is 1600 Nela Avenue, Belle Isle, FL 32809 (hereinafter referred to as the "City") and **Fisher Planning and Development Services, Inc.** (herein "Firm").

#### 1.0 SERVICES OF FIRM

#### 1.1 Scope of Services.

During the term of this extended Agreement, April Fisher with the Firm will serve as the City's contract City Planner and provide general planning services to the City. The scope of services has been provided by the Firm and incorporated herein and include other matters that are typical for the City's City Planner.

#### 1.2 Compliance with Law.

All services rendered hereunder shall be provided in accordance with all ordinances, resolutions, statutes, rules, and regulations of CITY and any Federal, State or local governmental agency having jurisdiction in effect at the time service is rendered.

## 1.3 Licenses, Permits, Fees and Assessments.

Firm shall obtain at its sole cost and expense such licenses, permits and approvals as may be required by law for the performance of the services required by this Agreement. Firm shall have the sole obligation to pay for any fees, assessments and taxes, plus applicable penalties and interest, which may be imposed by law and arise from or are necessary for the Firm's performance of the services required by this Agreement, and shall indemnify, defend and hold harmless CITY against any such fees, assessments, taxes penalties or interest levied, assessed or imposed against CITY hereunder.

#### 1.4 Care of Work.

The Firm shall adopt reasonable methods during the life of the Agreement to furnish continuous protection to the work, and the equipment, materials, papers, documents, plans, studies and/or other components thereof to prevent losses or damages, and shall be responsible for all such damages, to persons or property, until acceptance of the work by CITY, except such losses or damages as may be caused by CITY's own negligence.

#### 1.5 Further Responsibilities of Parties.

Both parties agree to use reasonable care and diligence to perform their respective obligations under this Agreement. Both parties agree to act in good faith to execute all instruments, prepare all documents and take all actions as may be reasonably necessary to carry out the purposes of this Agreement. Unless hereafter specified, neither party shall be responsible for the service of the other.

#### 2.0 COMPENSATION

For the services rendered pursuant to this Agreement, the Firm shall be compensated by the City a fixed fee of \$5,950.00 per month. The Firm will invoice the city no more than once per month. The City will make payments of invoices timely in accordance with Florida's Local Government Prompt Payment Act.

#### **3.0 TERM**

The extended term of this Agreement shall commence on the date when the last of the parties executed this Agreement and will continue until **September 30, 2026**. The City Manager shall have the right to extend the term of this Agreement for up to one additional year.

#### 4.0 INDEPENDENT CONTRACTOR.

The Firm is an independent contractor. Neither CITY nor any of its employees shall have any control over the manner, mode or means by which Firm, its agents or employees, perform the services required herein, except as otherwise set forth herein. CITY shall have no voice in the selection, discharge, supervision or control of Firm's employees, servants, representatives or agents, or in fixing their number, compensation or hours of service. Firm shall perform all services required herein as an independent Firm of CITY and shall remain at all times as to CITY a wholly independent Firm with only such obligations as are consistent with that role. CITY shall not in any way or for any purpose become or be deemed to be a partner of Firm in its business or otherwise or a joint venturer or a member of any joint enterprise with Firm.

#### 5.0 PUBLIC RECORDS.

Firm acknowledges and agrees that the City is a public entity that is subject to Florida's public records laws and as such, records in Firm's possession relating to Project(s) and work performed for the City are subject to inspection and copy pursuant to Chapter 119, Florida Statutes, unless otherwise exempt, deemed confidential, or excepted by applicable law. Firm shall comply with Chapter 119, Florida Statutes, and specifically with the "Contractor" requirements of Section 119.0701(2)(b), Florida Statutes concerning public records, which statutory requirements are hereby incorporated herein by this reference. IF FIRM HAS QUESTIONS REGARDING THE APPLICATION OF CHAPTER 119, FLORIDA STATUTES, TO THE FIRM's DUTY TO PROVIDE PUBLIC RECORDS RELATING TO THIS AGREEMENT, CONTACT THE CUSTODIAN OF PUBLIC RECORDS AT CITY OF BELLE ISLE, ATTN: CITY CLERK, TELEPHONE: 407-851-7730, EMAIL: <a href="mailto:yquiceno@belleislefl.gov">yquiceno@belleislefl.gov</a>; 1600 Nela Avenue, BELLE ISLE, FLORIDA 32809.

#### 6.0 RECORDS AND REPORTS

#### 6.1 Reports.

updates concerning the performance of the services required by this Agreement as the City Manager shall require.

#### 6.2 Release of Documents.

The reports, records, documents and other materials prepared by Firm in the performance of services under this Agreement shall not be released publicly without the prior written approval of the City Manager.

#### 7.0 ENFORCEMENT OF AGREEMENT

#### 7.1 Florida Law.

The parties acknowledge that this Agreement is governed by the laws of the State of Florida and is binding upon the parties' successors and assigns.

## 7.2 Disputes.

In the event of any dispute arising under this Agreement, the injured party shall notify the injuring party in writing of its contentions by submitting a claim therefor. The injured party shall continue performing its obligations hereunder so long as the injuring party commences to cure such default within ten (10) days of service of such notice and completes the cure of such default within forty-five (45) days after service of the notice, or such longer period as may be permitted by the injured party; provided that if the default is an immediate danger to the health, safety and general welfare, such immediate action may be necessary. Compliance with the provisions of this Section shall be a condition precedent to termination of this Agreement for cause and to any legal action, and such compliance shall not be a waiver of any party's right to take legal action in the event that the dispute is not cured, provided that nothing herein shall limit CITY's or the Firm's right to terminate this Agreement without cause pursuant to Section 7.8.

## 7.3 Retention of Funds.

Firm hereby authorizes CITY to deduct from any amount payable to Firm (i) any amounts the payment of which may be in dispute hereunder or which are necessary to compensate CITY for any losses, costs, liabilities, or damages suffered by CITY, and (ii) all amounts for which CITY may be liable to third parties, by reason of Firm's acts or omissions in performing or failing to perform Firm's obligation under this Agreement. In the event that any claim is made by a third party, the amount or validity of which is disputed by Firm, or any indebtedness shall exist which shall appear to be the basis for a claim of lien, CITY may withhold from any payment due, without liability for interest because of such withholding, an amount sufficient to cover such claim. The failure of CITY to exercise such right to deduct or to withhold shall not, however, affect the obligations of the Firm to insure, indemnify, and protect CITY as elsewhere provided herein.

#### 7.4 Waiver.

No delay or omission in the exercise of any right or remedy by a nondefaulting party on any default shall impair such right or remedy or be construed as a waiver. A party's consent to or approval of any act by the other party requiring the party's consent or approval shall not be deemed to waive or render unnecessary the other party's consent to or approval of any subsequent act. Any waiver by either party of any default must be in writing and shall not be a waiver of any other default concerning the same or any other provision of this Agreement.

# 7.5 Rights and Remedies are Cumulative.

Except with respect to rights and remedies expressly declared to be exclusive in this Agreement, the rights and remedies of the parties are cumulative and the exercise by either party of one or more of such rights or remedies shall not preclude the exercise by it, at the same or different times, of any other rights or remedies for the same default or any other default by the other party.

# 7.6 <u>Legal Action</u>.

In addition to any other rights or remedies, either party may take legal action, in law or in equity, to cure, correct or remedy any default, to recover damages for any default, to compel specific performance of this Agreement, to obtain declaratory or injunctive relief, or to obtain any other remedy consistent with the purposes of this Agreement. The sole and exclusive venue for any litigation shall be in Orange County, Florida before the County Court or Circuit Court of the Ninth Judicial Circuit, in and for Orange County, Florida.

#### 7.7 Termination Prior to Expiration of Term.

CITY reserves the right to terminate this Agreement at any time, with or without cause, upon ten (10) days' written notice to Firm. The Firm reserves the right to terminate this Agreement at any time, with or without cause, upon forty-five (45) days' written notice to CITY, except that where termination is due to the fault of CITY, the period of notice may be no less than ten (10) days. In the event of early termination of this Agreement, the Firm will be paid for services rendered prior to the effective date of the termination of this Agreement on a pro-rata basis, and will not receive payment for time after the effective date of termination.

#### 7.8 Attorneys' Fees.

Each party shall bear their own attorneys' fees and costs in any litigation arising out of this Agreement.

# 7.9 <u>Sovereign Immunity</u>.

Nothing contained in this Agreement shall be considered or deemed a waiver of the City's sovereign immunity protections. In no event shall any obligation of the City under this Agreement be or constitute a general obligation or indebtedness of the City, a pledge of the ad valorem taxing power of the City or a general obligation or indebtedness of the City within the meaning of the Constitution of the State of Florida or any other applicable laws, but shall be payable solely from legally available revenues and funds.

### 8.0 CONFLICTS OF INTEREST/NON-DISCRIMINATION

#### 8.1 Conflict of Interest.

No officer or employee of CITY shall have any financial interest, direct or indirect, in this Agreement nor shall any such officer or employee participate in any decision relating to the Agreement which effects his financial interest or the financial interest of any corporation, partnership or association in which he/she is, directly or indirectly, interested, in violation of any State statute or regulation. The Firm warrants that it has not paid or given and will not pay or give any third party any money or other consideration for obtaining this Agreement.

#### 8.2 Covenant Against Discrimination.

Firm covenants that, by and for itself, its heirs, executors, assigns, and all persons claiming under or through them, that there shall be no discrimination against or segregation of, any person or group of persons on account of race, color, creed, religion, sex, marital status, national origin, or ancestry in the performance of this Agreement. Firm shall take affirmative action to insure that applicants are employed and that employees are treated during employment without regard to their race, color, creed, religion, sex, marital status, national origin, or ancestry.

#### 9.0 MISCELLANEOUS PROVISIONS

## 9.1 Notice.

Any notice, demand, request, document, consent, approval, or communication either party desires or is required to give to the other party or any other person shall be in writing and either served personally or sent by prepaid, first-class mail, in the case of CITY, to City Manager at the City's address specified in the opening paragraph of this Agreement along with a copy via email to rickr@belleislefl.gov; and in the case of the Firm, notice is to be sent to the person at the address designated on the execution page of this Agreement. Either party may change its address by notifying the other party of the change of address in writing. Notice shall be deemed communicated at the time personally delivered or in seventy-two (72) hours from the time of mailing if mailed as provided in this Section.

#### 9.2 Interpretation.

The terms of this Agreement shall be construed in accordance with the meaning of the language used and shall not be construed for or against either party by reason of the authorship of this Agreement or any other rule of construction which might otherwise apply.

## 9.3 Integration; Amendment.

It is understood that there are no oral agreements between the parties hereto affecting this Agreement and this Agreement supersedes and cancels any and all previous negotiations, arrangements, agreements and understandings, if any, between the parties, and none shall be used to interpret this Agreement. This Agreement may be amended at any time by the mutual consent of the parties by an instrument in writing.

#### 9.4 Insurance.

The Firm shall procure and maintain, at its sole cost and expense, in a form and content satisfactory to City, during the entire term of this Agreement, including any extension thereof, the following policies of insurance:

- A. Comprehensive General Liability Insurance. A policy of comprehensive general liability insurance written on a per occurrence basis in an amount not less than a combined single limit of One Million Dollars (\$1,000,000.00).
- B. Workers compensation insurance for its employees and other applicable insurance as may be required by the State of Florida.
- C. Errors and Omissions Insurance. A policy of professional liability issuance written on a claims made basis in an amount not less than Five Hundred Thousand Dollars (\$500,000.00).

Except for the policy of professional liability insurance, all of the above policies of insurance shall be primary insurance and shall name City, its officers, employers and agents as additionally insured. Except for the policy of professional liability insurance, the insurer shall waive all rights of subrogation and contribution it may have against the City, its officers, employees and agents and their respective insurers.

Except for the policy of professional liability insurance, all of said policies of insurance shall provide that said insurance may not be amended or canceled without providing thirty (30) days prior written notice by registered mail to the City. In the event any of said policies of insurance are cancelled, the attorney shall, prior to the cancellation date, submit new evidence of insurance in conformance with this Section to the City.

## 9.5 <u>Severability</u>.

In the event that any one or more of the phrases, sentences, clauses, paragraphs, or sections contained in this Agreement shall be declared invalid or unenforceable by a valid judgment or decree of a court of competent jurisdiction, such invalidity or unenforceability shall not affect any of the remaining phrases, sentences, clauses, paragraphs, or sections of this Agreement which are hereby declared as severable and shall be interpreted to carry out the intent of the parties hereunder unless the invalid provision is so material that its invalidity deprives either party of the basic benefit of their bargain or renders this Agreement meaningless.

# 9.6 Authority.

The persons executing this Agreement on behalf of the parties hereto warrant that (i) such party is duly organized and existing, (ii) they are duly authorized to execute and deliver this Agreement on behalf of said party, (iii) by so executing this Agreement, such party is formally bound to the provisions of this Agreement, and (iv) the entering into this Agreement does not violate any provision of any other Agreement to which said party is bound.

9.7 <u>Entire Agreement</u>. The terms of this Agreement are intended by the parties as a final expression of their agreement with respect to such terms herein, and also as a complete and exclusive statement of such terms. There are no other provisions, terms, conditions

or obligations. Provided however, the terms of this Agreement may be subsequently modified in writing upon the mutual consent of the parties.

# **City Manager Work Plan:**

# 3904 Arajo condemnation:

The council approved helping Ms. Lizer with her house. We will check with attorneys for pro-bono work and check with contractors and real estate people for ideas and solutions. It will come back to council for an update and decision within 30 days of October 7.

## Hurricane lan:

KPMG and Florida DEP said there will not be any reimbursement of funds spent. We are waiting on a report memo stating their findings. They want us to withdraw our application and that seems inappropriate since they are rejecting us.

# · Revenue stream needs:

This FY, we will look at a stormwater fee increase for FY 26/27 and any other ways to generate revenue. The state may reduce/reform property taxes for homeowners which could impact ad valorem tax revenue. More to come on that.

# Lancaster House Carve Out:

We are working on a lease agreement language currently that needs some additions/changes and legal opinions. The renovation will begin in FY 25/26.

# Annexation:

Orange County is not open to future annexation possibilities to grow the footprint of Belle Isle. We might have to go with involuntary annexation as there is no movement by the county. We might try sending a letter explaining our challenges/solutions.

- IT Services Our current vendor wants to stay as our consultant. We have some ideas for change, and it will go out to RFP after talks, going on right now.

# Purchasing Policy

Our purchasing policy is working now. Purchase order (PO) language needs to be added. We are continuing to make changes and talking with staff on these changes. We will send this to our attorney to look at legal and state statute conditions/requirements after the additional language is put in.

# Property Acquisition/Municipal Complex

There is no funding at all for land or a new building(s). I am waiting for a response from Orlando on the partial purchase of the 20 acres and I have received a response from Bio-Tech on the mitigation. It is all done at once and needs to be in place before the impact.

# • Stormwater Grant:

This appropriation from Congressman Soto's office was vetoed for 2024/2025. This is moving forward through the process in the state's budget for next FY 2025/2026.

Judge/Daetwyler Dr. Transportation Grant:

This grant application is in the process of being accepted as we are working with the grant administrator. Will meet with our engineer to discuss the project at the start of this FY 25/26.

 Updating and closing previous grants and reimbursements from FEMA, Florida PA, and Florida DEP:

SOL Ave grant has been accepted. We have sent in more documents and are waiting for them to send the acceptance letter and funds.

Hoffner Ave Traffic Improvements Grant:

The city has the fully executed State Funded Grant Agreement, (SFGA agreement) between the city and the Florida Department of Transportation (FDOT) for **453225-1-54-01 (FY24) SFGA**, **Hoffner Ave Traffic Improvements**, **\$1.5M**. We are trying to talk with the county about a financial partnership to make these improvements on Hoffner. The city has no match money for this project. To move forward, a revenue stream will have to be recognized and approved. We are also looking at other state grant funding for this.
