**III. Consideration of Open Issues**

1. Arbor Day / Spring Fling  
Hannah Wooten  
Committee discussed the event and what we can do better next year to increase attendance.  
Board discussed more marketing. Advertise in the Conway paper. Advertise at Cornerstone and put it in the weekly chatter.  
Develop signs just for our event that states Arbor Day event. Make sure it is included on facebook and other social medias. Start advertising sooner. Richard brought up the idea of combining the event with the Easter egg hunt to capture a audience.  
Over all the board thought the event was well organized, nice setup and well attended by vendors.  
The use of Wallace field was also discussed to increase visibility.

2. Pollinator Bed  
Douglas DeYoung  
The committee reviewed potential locations for a pollinator garden at city hall. Placement could be around the existing bench in the park west of city hall. The board wants to use the design, already put in place for the fountain garden that was to reside in the island across from the front door of city hall. The addition of a structure or structures to grow pollinator vines will be incorporated. Doug will retrofit existing landscape plane to new area and board will review at next meeting.
3. Pollinator Garden Roadsides

The board discussed creating a pilot project to showcase the use of areas of Belle Isles roadsides as wildflower/pollinator areas.  
The board would like to use the potential garden that could be installed at city hall as a demonstration.  
The board feels some of the city common areas ,weather parks or roadsides, would be enhance .  
Discussion on some rejection within the community took place. Educating public on benefits and resource savings ,

visual attractiveness and helping the dwindling bee and butterfly population.  
Board brought to light how many surrounding municipalities have pollinator programs.  
Doug to research how to initiate and install a municipal garden.

4. Palm Tree At Nela Bridge

Hanna revisited the decline of one of the Sylvester palms at Nela bridge. Last meeting , she offered to get a sample of the dead tree to confirm its cause of death.

Hannah retrieve a sample and confirmed it was Lethal Bronzing that killed the tree. The existing live tree on the other side of the road does not have it at this time. The board agreed to remove the dead tree to eliminate it infecting other trees.

The city could begin a fungicide injection program in the alive Sylvester to help prevent the palm from succumbing to the Lethal Bronzing. This comes at a cost and will relay to the city council.

3 trim, and remove trees; amending s. 163.045, F.S.;  
4 defining terms; revising conditions under which a  
5 local government may not require a notice,  
6 application, approval, permit, fee, or mitigation for  
7 the pruning, trimming, or removal of a tree on  
8 residential property; specifying when a tree poses an  
9 unacceptable risk; providing an effective date.

11 Be It Enacted by the Legislature of the State of Florida:

12  
13 Section 1. Section 163.045, Florida Statutes, is amended to  
14 read:

15 163.045 Tree pruning, trimming, or removal on residential  
16 property.—

17 (1) For purposes of this section, the term:

18 (a) “Documentation” means an onsite assessment performed in  
19 accordance with the tree risk assessment procedures outlined in  
20 Best Management Practices - Tree Risk Assessment, Second Edition  
21 (2017) by an arborist certified by the International Society of  
22 Arboriculture (ISA) or a Florida licensed landscape architect  
23 and signed by the certified arborist or licensed landscape  
24 architect.

25 (b) “Residential property” means a single-family, detached  
26 building located on a lot that is actively used for single-  
27 family residential purposes and that is either a conforming use  
28 or a legally recognized nonconforming use in accordance with the  
29 local jurisdiction’s applicable land development regulations.

30           (2) A local government may not require a notice,  
31 application, approval, permit, fee, or mitigation for the  
32 pruning, trimming, or removal of a tree on a residential  
33 property if the property owner possesses ~~obtains~~ documentation  
34 from an arborist certified by the ISA ~~International Society of~~  
35 ~~Arboriculture~~ or a Florida licensed landscape architect that the  
36 tree poses an unacceptable risk ~~presents a danger~~ to persons or  
37 property. A tree poses an unacceptable risk if removal is the  
38 only means of practically mitigating its risk below moderate, as  
39 determined by the tree risk assessment procedures outlined in  
40 Best Management Practices - Tree Risk Assessment, Second Edition  
41 (2017).

42           (3)~~(2)~~ A local government may not require a property owner  
43 to replant a tree that was pruned, trimmed, or removed in  
44 accordance with this section.

45           (4)~~(3)~~ This section does not apply to the exercise of  
46 specifically delegated authority for mangrove protection  
47 pursuant to ss. 403.9321-403.9333.

48           Section 2. This act shall take effect July 1, 2022.
