#### 2. Tree Protection Bill

Christopher Stalder

Chris brought to the attention a bill in State legislature that would create standards to the newly created law which overrides local municipalities tree ordinance.

Current law pasted recently allows a property owner to remove any tree which a Arborist or Landscape Architect demes unsafe and is exempt from getting a permit nor relacing the tree. The property owner does have to supply the city with the report prior to commencement.

The board will monitor this legislation.

#### 3. Tree Ordinance / Protection 48-63 (d) (3)h

The board, with the guidance of the city manager, discussed the boards participation in future tree removal request. When asked to review future tree permits, a board member will visit the site with the home owner or his representative. Pictures will be taken of all marked trees to be removed. Apon home owners completion of removal. The board member will return to the site to verify correct trees were removed.

#### 4. City Tree Prunning

The board had the privilege to Derrek, Director of public works. Pruning of the trees within the city parks was discussed. The board will work on supplying public works with information and guidance on tree pruning per ISA standards.

The future pruning of Crepe myrtles was also discussed.

#### 5. Roadside Mowing

Chris suggested that we , as a community , designate areas of the cities roadsides to sit fallow to allow native flowers to develop at certain times of year.

The board will discuss this topic further at the next meeting and devise a plan to back the city against controversy.

## 6. Lethal Bronzing

Hanna Wooten

Hanna pointed out to the board that one of the palms at Nela bridge in declining and there is a great possibility it is due to Lethal Bronzing.

This is a non curable and contagious disease of palms and affects certain species more then others. Hanna concern is of the same species of palm on the other side of the bridge and its susceptibility.

If caught in the very early stages, Injection into the cambium could be beneficial

Doug motioned to have Phytoplasma tested for the disease and Hanna seconded.
