Solid Waste Recycling Committee Meeting Minutes Thursday June 10, 2021

Chairman Richard Weinsier called meeting to order at 6:05pm on May 13, 2021.

Members present – Richard Weinsier, Clayton Van Camp, Katie Durni, Frank Noge.

- 1. Meeting called to order at 6pm.
- 2. Citizen comments none.
- 3. Approval of minutes from May 13.
 - a. Motion to approve from C. Van Camp, K. Durni seconded.
 - b. All present voted in favor.

4. New Business

- a. Electronic recycling
 - i. R. Weinsier called French at Urban Recycling to confirm next event on Aug 21st.
 - ii. Bob Francis reported he would "have to see" about new signs for the August recycling event.
- b. Adopt-a-street/area discussion
 - i. City manager Bob Francis reported a citizen complain concerning the program since "we pay people to do that". Bob informed the complainant of the limited city resources and that it was everyone's responsibility to control litter within the city. There was also a report on the difficulties hiring a new Public Works Supervisor.
 - ii. Discussion was held on proposed areas for inclusion in program, including both sides of the roads. Four areas were agreed upon:
 - 1. Conway Road.
 - 2. Judge/Daetwyler/McCoy to Via Flora.
 - 3. Hoffner Ave from Orange Ave to bridge.
 - 4. Hoffner Ave from bridge to Conway.
 - iii. Motion to include these areas in the adopt-a-street program made by K. Durni, seconded by V. Van Camp, passed unanimously.
 - iv. Groups will be encourages to pick up trash on a quarterly basis.
 - v.Bob Francis requests 48 hours notice to city prior to get "caution" signs out. Bob or Heidi Peacock will take calls from groups for getting signs up for litter cleanup.
 - vi. Groups are free to do this more often than quarterly.
 - vii. B. Francis suggested a link be added to the city website to a road safety video from the Dept. of Transportation.

c. Absenteeism

i. Proposal made to remove any member after two unexcused absences instead of "successive" absences.

- ii. Motion was made by C. Van Camp to excuse Steve Jackson absence (vacation). Seconded by F. Noge, passed unanimously.
- iii. Motion made by C. Van Camp to record Todd Tatum's absence as unexcused. Seconded by K. Durni, passed unanimously. This is T. Tatum's first unexcused absence.
