# Minutes of the Monthly Meeting of the Tree Advisory Board June 13, 2024

6:30PM

#### **Location of meeting**

Belle Isle City Hall 1600 Nela Avenue Belle Isle, FL 32809

#### Present at meeting

The regular meeting of the Tree Advisory Board of the City of Belle Isle was called to order at 6:39pm on June 13, 2024, at Belle Isle City Hall by Richard Weinsier.

- 1. The minutes for the May 9, 2024 meeting were approved with the following changes.
  - a. Date of meeting was corrected from 2023 to 2024.
  - b. At the end of #6 the following sentence was added: The motion was approved by a 3-1 vote.
- 2. Citizen's Comments: Jeff Rhodes who lives on 3135 Indian Drive shared his drawing of his lot that was approved for removal of many trees about 2 years ago. After sharing his information to the board, Rick will be working with Raquel to figure out how many trees he needs to replant and/or pay into the Tree Fund.
- 3. Richard Weinsier suggested that the following statement be added to the Belle Isle Tree Ordinance. "Removal of a tree with a DBH of 24" or greater MUST have the approval of the Tree Advisory Board PRIOR to receiving a Tree Removal Permit for a Developed Property." Motion to approve by Chris Stalder and seconded by Sue Nielson. Motion was approved by a 3-0 vote.
- 4. Richard Weinsier suggested that we add \$1000 to the budget that can be used for a raffle during the Arbor Day event to trim a resident's oak or

- similar tree. The idea was approved by a 3-0 vote with Chris Stalder making the motion and Sue Nielson seconding it. After much discussion on the budget Rick suggested that Richard Weinsier attend the Budget committee meeting next week and let them know what we want to spend our budget on.
- 5. Next there was discussion on an updated Tree Removal Permit for a developed property. Most of the discussion was how much should the penalty be for illegally removing a tree with a DBH of 24" or greater. The discussion was tabled so the members could think about it before the next meeting.
- 6. Richard Weinsier presented another version of the flyer that could be used to give to new residents to help make Belle Isle a better Tree City. It was decided to wait until we see our budget to know if we can present it to Council for approval.
- 7. The last discussion topic was the Belle Isle Fee Schedule that was missing a lot of the fees that would be charged to a resident for a variety of illegal tree work or removal.
- 8. Chris motioned for adjournment at 7:50pm.

## Details for July 2024 Tree Board meeting.

- 4. List of questions that I sent to Rick last week for discussion at meeting.
  - a. How much money is presently in the \$2 account that is collected from every household each year to improve our BI tree canopy?
  - b. What is the total each year that is collected and put into the \$2 account and when does it come available to be used?
  - c. Can the money from the \$2 account be used for anything besides a tree?
  - d. Assuming that some, or all, of the monies in the \$2 account have been spent on the BI tree canopy, what specifically was the money spent on in recent times?
  - e. How much money is presently in the Tree Fund account? What restrictions are there with this account for being able to spend it? Was any of the monies in this account spent on anything in recent times and if so, what was the project?
  - f. How did/does the administration decide where and how much to spend on any tree project?
  - g. Do you (Rick) have any positive or negative thoughts about dividing up the City into quadrants and that one quadrant on a rotating basis will have priority in any given year for work on their tree canopy?
  - h. Do you (Rick) have any positive or negative thoughts about allowing the Tree Board to be a contributing factor in how, where, when and how much of the tree monies should be spent on any given BI tree project?
- 5. Tree Board Duties and Responsibilities in Ordinance:
  - Develop and present annually a written community tree management program and supporting work plan which, upon acceptance by city council shall constitute the official comprehensive tree plan for the city. How will the Tree Board accomplish this work?
- 6. Note: I attended the budget committee meeting 2 weeks ago and they were very positive about our suggested line-item budget request of \$7000 that will be presented to Council. If we get less than requested, then I am suggesting priorities to be:
  - a. Arbor Day without tree give away or trimming
  - b. New resident program
  - c. Arbor Day tree give away
  - d. Arbor Day tree trimming
  - e. Tree acquisition for planting in a BI park
  - f. Tree acquisition to give away at other BI events

- 7. Arbor Day 2025 Think about an available date (? Saturday, April 26, 2025, any conflicts?) and to whom we should send invitations.
  - a. Work with Special Events committee to prepare event.
  - b. Event to be held at City Hall (inside and out).
  - c. Participant suggestions: Tree board, Solid waste & Recycling with trashcan raffle, Forestry service/Arborist, Nursery, PC Historical Society/Pioneer Days, Solar company, Duke, OUC, NAV board, Police & Code enforcement, BI administration, Live animal program, Balloon person, Face painters, Food trucks, Local establishments, others.
  - d. Raffle for a special tree give away.
  - e. Raffle for trimming of an oak tree.
- 8. Tree Removal Permit for a Developed Property Include form & fee info
  - a. Penalty for removal of a tree with a DBH of 24" or more.
  - b. Fines for trees with a DBH of less than 24".
  - c. Fee schedule values
  - d. Motion to approve upon agreement.
- 9. New resident program Include form
  - a. Create list of homes sold the previous three (3) months in Belle Isle, their address, and the district they are in.
  - b. Commissioners will visit each home in their district to share and explain the New Resident sheet along with a trash truck flash drive donated by JJs Waste and Recycling Company containing information from our Belle Isle online New Resident Welcome Packet. May also include coupons from local establishments.
  - c. New residents will then come to a Tree Board meeting to find the best trees for their home and its care.
  - d. New residents will then receive one or two free trees from an approved nursery which will be paid for from the Tree Board budget.
  - e. Motion to approve upon agreement.
- 10. Planting of trees in our parks. Will work in coordination with Public Works for which park and the type, size, number of trees to be considered.
- 11. Volunteer to bring goodies to next meeting.
- 12. Adjournment

#### **Submit** to City

1. Plan specifying location and type of replacement tree(s), if required.

#### **Commercial Tree Service** must

- Be registered with the City before doing any work. Registration application form is available at www.belleislefl.gov.
- 2. Remove all tree debris.

#### **Understand** that

- 1. Entire permit must be posted at job site that is valid for six (6) months.
- 2. If a City Arborist is required, resident will bear the cost.
- 3. City Arborist's report will certify whether the criteria for tree removal are met.
- 4. City Arborist's fee is non-refundable whether the permit application is approved or denied.
- 5. Tree(s) requested for removal must be visibly marked with large red "X" for identification.
- 6. Replacement tree(s) must be planted while this permit is valid, inspected by Code Enforcement, and meets the requirements of the Belle Isle ordinance.
- 7. Replacement tree(s) will be inspected by Code Enforcement one (1) year after replacement date.
- 8. There will be a fine of \$800 per tree having a DBH of less than 12", \$1200 for less than 18", and \$2000 for each tree with a DBH of 18" up to 24" removed in violation of the Tree Ordinance.

Please refer to the Code of Ordinances of Belle Isle, Florida, at <a href="www.municiode.com">www.municiode.com</a> to view a full copy of the City Ordinance Chapter 48, Art 111, Section 48-63(d). Tree Protection – HB 1159

NO permit/fee is required if a report or documentation from an arborist certified by the International Society of Arboriculture or a Florida licensed landscape architect is provided that demonstrates the tree's danger to person or property. Documentation must be provided to the City within ten days of receipt.

# A HEALTY tree CANNOT be removed unless one of the following circumstances exists:

- 1. The location of the tree restricts the opening of a street or road right-of-way.
- 2. The location of the tree restricts the construction of utility lines or drainage facilities.
- 3. The location of the tree restricts access to the property.
- 4. The area of the tree restricts the use of the property consistent with all other city regulations.
- The selective removal of up to 25% of existing trees with a diameter at breast height (DBH) of less than six four inches to provide increased light and air circulation.
- 6. Removal of the tree is required, in writing, by the homeowners' insurance company or proposed insurance company.

<u>Replacement Trees</u> <u>MUST</u> have a minimum DBH of four inches and done according to this chart.

| DBH of Removal Tree             | Number of<br>Replacement Trees |  |
|---------------------------------|--------------------------------|--|
| 4' up to but not including 12"  | 1                              |  |
| 12' up to but not including 18" | 2                              |  |
| 18-inches or greater            | 3                              |  |
