City of Belle Isle Special Events Committee July 17, 2024 Meeting Minutes

Call to Order

The meeting was called to order by Chair Kathy McCoy at 6:00 p.m. and a quorum was confirmed.

Approval of Minutes

• The minutes from the June meeting were distributed to the committee via email and in writing. A motion was made by John Trembly to approve the minutes as written. Doug DeYoung seconded the motion and the motion was passed.

Unfinished Business

- Midnight Mayhem is the only band available for the Centennial celebration. The city manager said he would sole source the band since they are the only ones available.
 - John Trembly will ask Paul Magrone if he is willing to play just a short set at the beginning of the event while the band sets up.
- It was agreed that Kathy McCoy would reach out to a rental company for pricing on tables and chairs for the event.
- The City Attorney because of insurance and other regulations and liabilities notified the committee through the City Manager, that the city cannot sell alcohol.
 - Commissioner Brobrowski and John Eversten secured a donation from Randy Ross of 600 bottles of wine. The city will give these out at the centennial event and other city events.
- The quotes for the carnival games/rides have been submitted.

New Business

• The Centennial celebration was discussed as follows

- The salon owner at Wallace and Randolph is complaining about the event interfering with his business. The City Manager has sent an e-mail to the owner with our intentions to accommodate his customers. The City Manager will also request a list of that's day's customers to ensure that they can access to the salon's parking.
- It was decided to not use Wallace Field for the event as the ground would be muddy if it rains. The city will close down Randolph between Wallace and Waltham. This may include a little north of Waltham as well.
 - The city has permission to shut down part of Hansel Avenue as well if needed.
 - The event will be held on the street as well as the CCA parking lot
- The city is asking the School Board for permission to use the parking lot at the old Pine Castle Elementary location.
- Yolonda will be sending out a mailer to everyone in the city to advertise the event
- $\circ~$ Tree dedication plaques came in and the dedication will be held on September 7^{th} at 10 a.m.
 - A sound system is needed for the dedication and Kathy McCoy will ask the person doing sound for the event if he can provide a sound system
- Jay's Cone Zone, Red Panda Noodles, Camel Toe Taco and Uncle Tony's BBQ have confirmed. Still waiting on responses from Bread for the Masses and Charlies Bakery.
- It was clarified that any denial or non-response also counts when looking for quotes for items that go over the \$2,499 limit
- It was suggested that we provide light up bracelets, necklaces, etc. for the children.
- Lynn DeJarnette and Doug DeYoung will look for 10-15 vendors for the event, and Lynn will provide a vendor registration form to Kathy McCoy.
- The Christmas event dates were set
 - Light the Way December 4, 2024
 - \circ ~ Santa Ride December 10^{th} and 12^{th}
 - Golf cart and bicycle parade December 14, 2024
