A RESOLUTION OF THE CITY OF BELLE ISLE, FLORIDA, AMENDING THE BUDGET FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2019 AND ENDING SEPTEMBER 30, 2020, CREATING A CAPITAL IMPROVEMENT FUND FOR REVENUE BOND, SERIES 2020.

WHEREAS, pursuant to Resolution 19-14, the City of Belle Isle has adopted the budget for fiscal year 2019-2020; and

9 WHEREAS, pursuant to Resolution 20-11, the City of Belle Isle has 10 authorized the issuance of the Capital Improvement Revenue Note, Series 2020, 11 for the purpose of financing the acquisition of one or more parcels of land 12 and the improvements located thereon and/or the construction, acquisition, 13 and equipping of certain capital improvements; and

WHEREAS, the City of Belle Isle entered a Loan Agreement with Centerstate Bank and Florida Municipal Loan Council on September 25, 2020, and Section 2.02 of the Loan Agreement states the City of Belle Isle agrees to establish a separate fund for the Capital Improvement Revenue Note, Series 2020; and

19 WHEREAS, the City of Belle Isle has determined it is necessary to 20 create a new fund within FY 2019-2020 Annual Budget; and

21 WHEREAS, the creation of the Capital Improvement Fund is necessary to 22 record the Revenue Bond, Series 2020 and track the use of the funds as 23 intended; and

24 WHEREAS, Section 166.241(4)(c) Florida Statutes require such a budget 25 amendment to be adopted in the same manner as the original budget; and

1	WHEREAS, the City Council hereby authorizes the creation of the Capital						
2	Improvement Fund as "Exhibit A" attached hereto;						
3	Now, therefore, the City Council of the City of Belle Isle, Florida						
4	hereby resolves:						
5	Section 1. The budget for the City of Belle Isle, Florida for fiscal						
6	year 2019-2020 is hereby amended by "Exhibit A". The Attachment is hereby						
7	incorporated into this Resolution by reference thereto.						
8	Section 2. This Resolution shall take effect upon its adoption.
