**1. Call to Order and Confirmation of Quorum**

Redistricting Committee Vice President Emily DeLozier opened the meeting at 6:00 pm. A quorum was confirmed.

**2. Consent Items**

City Manager Bob Francis introduced Carolyn Holihan as the newest member of the Redistricting Committee responsible for District 4. Carolyn was selected to replace Randy Holihan who resigned when he was appointed to the City Council.

David Evertsen volunteered to be the new President of the Redistricting Committee. Brandon Shaw moved to approve the nomination. Alexa Dowlin seconded the motion, which was passed unanimously.

The committee discussed editing the minutes from the previous meeting to reflect the correct date of August 11, 2021 and to include Alexa Dowlin. The motion passed unanimously.

**3. New Business**

The committee discussed the results of the district counts: Each member stated what the residential counts were for their appointed districts.

District 1 - 364

District 2 - 366

District 3 - 366

District 4 - 631

District 5 - 360

District 6 - 389

District 7 - 347

These counts were consistent with the counts that Mrs. DeLozier did while using the Orange County Property Appraiser website. Based on these counts, the Committee determined that the districts needed to be revised to get the numbers in each District as close to equal as possible. The Committee redrew the District boundaries. Once completed, a map was marked up to define the boundaries of each district. The Committee will again verify numbers for the next Committee meeting. If those numbers do not change, then the new District boundaries will be attached to an ordinance for the Council to adopt.
