CALL TO ORDER

Mayor James called the meeting to order at 5:32 PM.

COUNCIL WORK SESSION ITEMS:

PRESENTATIONS

- 1. Approval of Sample Agreement and Application Process for 5G small Cell Towers with Crown Castle:** *Town Staff and Town Attorney will provide an update. This agreement allows the Mayor and Town Administrator to enter into agreements with Crown Castle at certain sites throughout the Town.*

The Town Administrator provided the proposed agreement that the Town attorney completed while working with Crown Castle's Counsel. Town attorney Ms. Ferguson gave details on the agreement drafted between the Town and Crown Castle.

- 2. Approval of Memorandum of Understanding (MOU): Flooding Mitigation Pilot Program with Prince George County DPWT:** *Town Staff and the Prince George's County DPWT will provide an update. This MOU implements a pilot program to assist with flooding mitigation in the Town along Edmonston Channel and Quincy Run.*

Ms. Joanna Smith, among other members of the project team, shared details about the Bladensburg flood reduction project, including the partnership overview, the project overview, the project schedule, and what to expect in the next couple of months. The Town Administrator highlights that the agreement formalizes a relationship with the County and allocates \$500,000 in Town ARPA funds for the project.

- 3. FY 2025 Budget Update:** *The Town Treasurer will update the Council on the draft Budget for FY 2025.*

Town Treasurer Mr. Tinelli discussed budget assumptions, the FY2025 Budget summary, revenue options, and other town needs. He also provided an overview of the Budget timing and reminded the Council about the next meeting scheduled for May 20, 2024.
