## A. Executive Session 5:00 p.m.

#### IV. COMMUNICATIONS TO TRUSTEES

Citizen Comments (Non-Agenda Items Only- 3-minute limit please). Any written communications are included in the packet.

Manager Eddy noted communications received via email from Paul Semmer and Clint Siddons this morning in addition to communications received at 4:30 p.m. this afternoon.

Mayor Babich noted deadlines for written comments to be provided in the packet. Communications are due the second Tuesday of the month.

Eric Hann-Whispering Pines-asked about the status of the town and the dark skies discussion. It was noted this would be discussed later in the meeting.

#### V. NEW BUSINESS

D. 911 Communications Center IGA Approval for Mayor Signature.

Manager Eddy reviewed the recent changes with the 911 Communications Center. With these changes a new IGA has been developed over the last several months to reflect the new agreement among the jurisdictions, county and 911 Center. She noted the agreement has been approved today by the County and will be approved by the remaining entities by the end of the week. A resolution for approval is on the agenda.

E. Dark Skies Survey & Report-Citizen Advisory Committee

Manager Eddy reviewed the staff report from the Citizen Advisory. Members of Citizen Advisory were present to answer questions.

Communication was received from Martie Semmer on the recommendation in addition Committee Members provided additional comments.

Manager Eddy read communication from Steve Kucera.

Charlie Brittz Citizen Advisory Chair spoke on behalf of the committee and reason for recommendation. Jodie Wiley, Committee member echoed comments from the Committee.

Trustee Finley noted that the committee had conducted a thorough review and due diligence. She noted that the committee is not against dark skies and the concept but is not in favor of mandates and enforcement piece.

Mayor Babich noted the work conducted by the committee.

Trustee Finley suggested a question that should have been included would be "do you want this to be enforced." This may have had a different result.

Trustee Dixon asked about what the \$250 application fee involves. Manager Eddy explained the process and that it would mean the town is ready to become a dark sky community. There was discussion about the confusion around the application and process.

Trustee Pilling asked about the 62% stating to consider pursuing the designation versuls what the committee is recommending. Discussion that the comments didn't reflect that sentiment and the enforcement question wasn't asked. Trustee Finley noted that the enforcement is required. Trustee Pilling noted Timber Creek Estates has in their covenants with penalties for dark skies in the subdivision. He stated the HOA did have an incentive program to encourage compliance.

It was noted that in addition to enforcement, there is a requirement of annual reporting, compliance and an additional committee to submit reports.

Mayor Babich remarked residents are in favor of wanting to have dark skies but not enforcement. He noted that the education and incentive programs to build compliance seems reasonable.

Trustee Slaughter noted in agreement with recommendations with maybe reviewing the current ordinance to see if it needs anything else.

Trustee Finley noted a desire by the committee to develop a meaningful incentive program.

It was recommended to have the committee review the current ordinance.

Motion made by Trustee Finley, Seconded by Trustee Dixon to approve the Citizen Advisory Committee recommendation and the development of an incentive program. Voting Yea: Mayor Babich, Trustee Dixon, Trustee Finley, Trustee Pilling, Trustee Slaughter. Motion passed unanimously.

### F. Discussion of Trail Signage within the Town

Mayor Babich noted memo included in the packet. He noted reason for the signs being installed and emails circulating spurring the conversation. He stated there is a need to adopt a policy for signage either based on the advisory document or with additional input to guide staff in the future. He remarked on trails throughout the area there is various signage based on

location. The one in the plan is consistent within the Town of Breckenridge and the County. He noted the language for signs in the plan.

Discussion and clarification on the Open Space & Trails Plan is an advisory document to guide decisions around trails, signage, and open space for consideration by the Trustees.

Trustee Dixon stated a recommendation to follow the plan as outlined. He noted a need for a policy in place to be consistent. He feels the posts should be 6x6 versus the 8x8 installed and that the signs are too large. The goal is not advertisement but for local use. Trustee Finley agreed.

Trustee Slaughter noted he is against all signage for the trails while understanding the need for respecting private property. He questions need and has a concern for the committee and trails in town.

Trustee Dixon noted the committee is awaiting the digital plan so it can conduct an open house and promote to the public. He feels any signage now is premature. He would be in favor of a policy to have signage as it shows in the plan.

Mayor Babich remarked that a need to address resident concerns for signage are considered when obtaining an easement and a need for flexibility. He would support the consistent signage with a caveat for special circumstances. Special circumstances should be reviewed by the Town Attorney and Town Manager for recommendations.

Consensus that the sign in the plan would be the preferred type with exceptions. Mayor Babich directed the Town Attorney and Town Manager to develop a policy and resolution for the Trustees to consider.

#### G. Discussion of a road maintenance policy.

Mayor Babich reviewed current conversations around requests and demands from individual owners and the need to develop a policy.

The recommendation for process and policy was reviewed. It was recommended to add a form to the website for requests and follow up. Decision to formalize the process and develop a webpage to bring back to the Trustees for adoption.

Michelle,

First, can you tell my how to sign up for TextMyGov?

I just read the August Newsletter. Specifically, it looks like road maintenance has concluded for the year. Considering that the road is free of snow and exposed dry dirt from June until October, this is disappointing. The magnesium chloride on Spruce Creek Rd. usually lasts for around 2 to 3 months without heavy rain. As I recall in years past the road used to get two treatments of magnesium chloride.

This is a serious issue as the dust plums that are created from all of the vehicular traffic going primarily to Mohawk Lakes Trail Head is out of control and unhealthy.

If we are lucky, we get rain which keeps the dust down.

The mag chloride on Spruce Creek Rd. needs to start in June not the current schedule, which is well into July. Plowing the road early to take out the wash boards and not immediately treating with mag chloride only exacerbates the dust problem by plowing up the mag chloride that is still remaining. Grading the road lasts for about 5 days before it is right back to the wash boards. I would suggest you not plow at all until you are ready to apply mag chloride.

I like the job the new grading contractor is doing. I am not sure what the new treatment is called that was applied this year but it was great, while it lasted. Unfortunately, with all of the rain it is now pretty much completely gone and we are starting to get the dust cloud as cars drive by our home.

The once a year mag chloride program works for the majority of the roads in Blue River. I know this because Gold Nugget and Crown Drive are dust free for the entire summer. It makes sense since they do not get the same amount of traffic as Spruce Creek Rd.

Spruce Creek Road is unique and requires more maintenance than the other roads, it is just a fact. It is very disappointing that the Town continues to act interested, spend money on engineering reports and surveys and ultimately does nothing to help with the actual problem. In fact, if I am correct, the Town has done the opposite by going from two applications of mag chloride per year to only once a year.

The Town needs to start taking this problem seriously. When is it going to happen? What is the problem? Road maintenance is not rocket science. Roads should be the number one priority. That is why the Town of Blue River Government was originally started. I don't believe it is about money because I see the Town spending money on other programs and projects that I consider much lesser priorities. So, I am left to assume that Road maintenance is not the number one priority for the Town.

Thank you for your email. I will include this with the Trustees packet along with this response. Please note the following per your comments.

1. TextMyGov is on the website with a phone number to text for information as well as a "Learn More" tab to be directed to an informational page. Attached is the flyer that is included in the newsletter to sign up.

2. Grading began mid-June with only a slight delay due to the rainy weather and continued through mid-July. The schedule is not any different than years past which has also included a spot grading at the end of April/beginning of May.

While the June/July grading is the major grading for the season, there will be, as in years past, a minor regrade and winter prep in September. It is at this time that we will ensure the roads are ready for winter

and all culverts are clear.

4. Mag-chloride as well as the earth bind product were applied to Spruce Creek Road in an effort to see if it reduces the amount of wear/tear on the road in the summer. It's been over a month since that was applied. I drove both Crown and Spruce Creek today and I will say Spruce Creek is in the best shape I've ever seen and is driving nicely. Again, in September, any issues needing to be addressed including additional applications of mag or earth bind, will be and this is the same schedule that has been in place for the last several years.

Our engineers are continuing to work on a more permanent solution for this road and the Town is

committed to its continued improvement.

Thank you again for your comments and concerns. If you have additional issues on the road, our new road maintenance request form will be live within the next week. Please feel free to fill out the forms and we will address them as best we can in a timely manner.

Revenues are tracking ahead of budget by 16.26%. Sales tax is tracking ahead of budget. Building is doing better than expected with many small permits. Other income including interest on investments are ahead of budget. Court is currently tracking behind budget but is picking up momentum as we become fully staffed again. Expenditures are above budget by 3.56%. Utilities continue to increase in expense primarily at Town Hall. Auto repairs are exceeding budget due to unforeseen repairs on the 2015 sedans. The Town is sitting in a good position and staying on track with planned revenues and expenditures.






