Consolidated budget increase- Land Acquisition budget increase and Capital Improvement Projects increase, Resident Rates to include property owners for rentals on Master Fee Schedule, Adding FTE for Affordable Housing position to be funded after study and Affordable Housing Committee review and recommendation, Recommend 30% increase from FY2025 for Lowcountry Regional Transport Authority.
