I. CALL TO ORDER

Mayor Toomer called the meeting to order at 5:00 PM.

II. PLEDGE OF ALLEGIANCE

The Pledge of Allegiance was led by Mayor Toomer.

III. INVOCATION

The Invocation was given by Councilmember Hamilton.

IV. ADOPTION OF THE MINUTES

1. Regular Meeting Minutes of 07/08/2025

A motion made by Councilmember Burden; Seconded by Councilmember Frazier to approve the Regular Meeting Minutes of 07/08/2025 as submitted.

Town Council unanimously approved the minutes as submitted.

A motion made by Councilmember Hamilton; Seconded by Mayor Pro-tempore Wood to approve the Regular Meeting Minutes of 07/15/2025 as submitted.

Town Council unanimously approved the minutes as submitted.

V. PRESENTATIONS, CELEBRATIONS, AND RECOGNITIONS

1. USCB Sand Shark Welcome Week Proclamation - Mayor Larry Toomer

Mayor Larry Toomer, on behalf of Town Council presented USCB with the Welcome Week Proclamation celebrating the week of (August 18-22, 2025) students returned to campus. Student representatives Daniela Lopez and Tayla Wilson were present to receive the proclamation.

VI. PUBLIC COMMENT

<u>Marie Kowalchuk 161 Pinecrest Circle</u> - Ms. Kowalchuk addressed council with concerns regarding potential development of the Pinecrest.

<u>Sharon Brown 163 Buck Island Road</u> - Ms. Brown addressed council regarding the Neighborhood Assistance Program and the Resident Resource Guide.

<u>Garfield Moss 4 Garfiled Way</u> - Mr. Moss addressed council regarding an incident that occurred several years ago during the time frame of the covid pandemic.

VII. COMMUNICATIONS FROM MAYOR AND COUNCIL

Councilmember Frazier - Ms. Frazer had requested Town staff reach out to Mr. Moss to further discuss the incident that occurred. Town Manager Steese responded to the request advising the

incident occurred three years ago, the trespass order was lifted within a few days. The reason he was directed to the attorney was due to Mr. Moss threatening to sue the Town, therefore it was recommended that Mr. Moss speak directly to legal counsel.

Mayor Pro-tempore Wood - Mr. Wood expressed his gratitude for a job well done to Beaufort County for repaving a portion of the Bluffton Parkway, removing the speed bump on Goethe Road and the Live Well Project would not have been possible without the partnership of Beaufort County, Beaufort Memorial Hospital and the Town.

Councilmember Hamilton - Mr. Hamilton expressed his praise to Councilmember Frazier for her efforts to feed Bluffton. He expressed his appreciation and wishes of success to her business venture. Mr. Hamilton also addressed the members of the Pinecrest regarding community concerns of development, expressing his support for the community members.

Councilmember Burden - Mrs. Burden shared the positive feedback in the town working with Kim Conte with Non-Toxic Neighborhoods and the Town of Bluffton Public Works Department to test non-toxic spray in our parks. There has been great success in the testing. Any spraying that may be seen is a non-toxic chemical. This is a huge win for our entire community, our children, pets and the runoff into the river. She expressed the desire to make this usage a policy for the town.

Mayor Toomer - Mayor Toomer has requested the community keep the Reeves family in prayer in the passing of Ms. Mary Reeves at the age of 95. She and her late husband were very instrumental in the Bluffton community.

VIII. WORKSHOP AGENDA ITEMS

- Update on the South Carolina Law H3292 Related to Golf Carts and the Allowance of Local Municipalities to Adopt Similar Regulations - Kevin Icard, Director of Growth Management
 - Town Council requested to schedule an additional workshop to further discuss its legal options to restrict golf cart use to promote public and personal safety.
 - Background: The new state law allows municipalities to adopt additional golf cart laws to either allow or restrict nighttime driving and also adopt additional safety restrictions. The state law restricts golf carts on any road which is above 35 mph, it requires seat belts for any riders 12 years old or younger, the driver must have a license, and the golf cart insurance is required.
- Consideration and Direction on Potential Amendments to the Town of Bluffton Code of Ordinances, Chapter 23, Unified Development Ordinance, Article 5 – Design Standards -Accessory Buildings - Kevin Icard, Director of Growth Management
 - Town staff presented changes to the proposed ordinance which relates to the use of car ports. Town Council agreed to bringing the proposed ordinance to Historic Preservation Commission (HPC) and Planning Commission (PC) for review and comments. After review by both committees, Town staff will present the proposed ordinance to Town Council.

A motion made by Councilmember Frazier; Seconded by Councilmember Hamilton to approve the second reading of the Ordinance providing for an amendment of the Buckwalter Development Agreement to incorporate certain properties owned by Beaufort Memorial Hospital, consisting of 10.9 Acres, more or less, located at 333 and 335 Buckwalter Parkway, and bearing Beaufort County Tax Map No. R610 030 000 0712 0000, to provide for an Affordable Housing Density Bonus increasing the total permitted Development Rights by sixty (60) Residential Dwelling Units and incorporate certain terms to the Buckwalter Development Agreement.

Town Council unanimously approved this amendment.

A motion made by Councilmember Burden; Seconded by Councilmember Hamilton to approve second reading of the Ordinance providing for an Amendment of the Buckwalter Concept Plan to incorporate certain properties owned by Beaufort Memorial Hospital, consisting of 10.9 Acres, more or less, located at 333 and 335 Buckwalter Parkway, and bearing Beaufort County Tax Map No. R610 030 000 0712 0000, to provide for an Affordable Housing Density Bonus increasing the total permitted Development Rights by sixty (60) Residential Dwelling Units and incorporate certain terms to the Buckwalter Concept Plan.
