VIII. PROGRAM COMPANY PRESENTATION

Barbers of the Lowcountry

Brent Nelson of Barbers of the Lowcountry presented the Board with his story on how his local barbershop has grown from a small business to a thriving community staple, thanks in part to the support of the Don Ryan Center for Innovation. The barbershop, known for its top-notch grooming services and friendly atmosphere, has been a fixture in the area for over a decade. With the help of the Don Ryan Center, the Barbers of the Lowcountry have expanded their operations, upgraded their equipment, and implemented innovative marketing strategies. Through mentorship, business coaching, and access to resources, the Don Ryan Center has helped the barbershop navigate challenges, seize opportunities, and achieve remarkable growth.

X. NEW BUSINESS

CEO Comments

Nelems gave an update on DRCI. We are very busy and are currently incubating 12 companies and have 70 mentors. The most at one time in DRCI history. Bill Fuge submitted his resignation along with Ray Deal. Both are currently too busy to attend the meetings. Deal suggested appointing Tom Henz to the board. Several members of the board are familiar with Tom and spoke very highly of him. We currently have 3 seats open and we will get the word out for applicants.

GROWTH PROGRAM PRICING

There has been some price sensitivity for a couple companies recently who are not STARTUP but not quite GROWTH. They are somewhere in between and the pricing for the GROWTH company is too much for these companies. The question was asked if we should have a tiered system based on revenue. The board discussed the options and gave guidance and said that DRCI staff can price accordingly.

"BETTER CALL PAUL" - BUSINESS HELATH CHECK

Nelems announced Business Health Check which is a 15-question survey that assesses a business health through a scoring key. At the end of the survey a score is given and they are offered the option to setup

a call with Paul about the health of their business. The program was launched yesterday and there have been 6 phone calls booked.

HARDEEVILLE UPDATE

Hardeeville partnership is going well. We are working with Wheeler Trucking and Capital Chiropractic with a power washing company in the pipeline. DRCI will be holding a Business 301 in April. The contract is up for renewal in June.

PROGRAM UPDATE

Arvantides gave an update on the program companies at the DRCI with ESA being close to getting a training contract oversees, Crossflight re-focusing their attention to drone education, MXM changing their strategy and interviewing marketing companies. HHI Coffee Roasters just opened their new roasting facility on HHI and several new companies in the pipeline. Roache gave an update on Wheeler Trucking. They are growing and hiring drivers. Capital Chiropractic had their kickoff meeting today.

Nester spoke about a company that was giving a touching presentation about Veterans and it turns out that they are working with DRCI and he was very impressed.
