1. FY26 Neighborhood Assistance Budget Update

The budget for the Neighborhood Assistance Program for FY 2026 has been approved at \$450,000 by Town Council.

Thirteen homes have received home repairs at a total of \$106,270. These repairs consist of roofing, flooring, decks and plumbing. One home has received tree services for \$761. A total of \$107,031 has been paid to date.

Applications are being processed weekly, and contractors are responding to estimate requests promptly.

Four homes are waiting on estimates to be submitted for repairs to begin. Smalls projected that 20 homes will be repaired by the end of October.

Staff Smalls, let the committee know that the NAP has used the full \$144,000 grant from BJHT and that 14 homes were able to receive repairs from these funds.

Smalls provided information on the progress of The May: Stormwater mains have been installed; conduit is going in; and compaction and gravel work will follow. Building pads have been prepped and vertical construction is on track to begin. Dominion Energy is scheduled to install poles and power in a month. Target completion for the development is Q1 2026. The Committee requested that the project developers attend a future meeting for accountability.

Smalls gave the committee dates to place on their calendar for upcoming events.

- Smoke Alarm Blitz: Partnership with Bluffton Fire Dept. and Red Cross.
 Tentative dates are Nov. 8 or Nov. 15 at Fuller Court (Habitat community).
 Smoke alarms installation is always open to additional individual requests.
- The next November AHC meeting falls on Strategic Planning Day, we will need to cancel November meeting.
- Homebuyer Workshop the location will be The Bluffton Rotary Center. The Town of Bluffton will sponsor the workshop; Pinnacle Partners and Coastal States Bank will be the presenters. The topics discussed will be credit scores, home maintenance & insurance, mortgage process, debt-to-income ratio, required documents, etc.
- Bluffton Hispanic Business Expo, October 11 from 9am to 4pm at Bluffton High School.

DATE: December 4, 2025

The budget for the Neighborhood Assistance Program for FY 2026 has been approved at \$450,000 by Town Council.

A total of twenty-two homes have received repairs at a total of \$170,097. These repairs consist of roofing, flooring, decks, plumbing and tree service.

Applications are being processed weekly, and staff is reviewing those estimates along with Building Safety to make sure that funds are spent accurately and all requested repairs are being made.

Repair estimates continue to rise, and staff will make every effort to ensure our residents have safe, decent and suitable living environments.

To date, four homes are waiting on estimates to be submitted, and two applications are out for income verification.
