BUDGET MESSAGE

May 8, 2025

Members of the Boardman Urban Renewal Agency Budget Committee,

The Boardman Urban Renewal Agency (URA) was formed with the idea of adding utility infrastructure and streets to areas that were blight or undeveloped. This vision was started over twenty-five years ago but has established the foundation that has allowed for the currently identified projects to be feasible. Within the URA, there are three districts known as the Central Urban Renewal District (CURD), the West Urban Renewal District (WURD), and the recently added, North Urba n Renewal District (NURD). Tonight, we will review the budget for each district.

As the city grows and expands, the needs and opportunities change, as the needs of the community change. The CURD will have a busy year with lots of infrastructure going into that district. The WURD, however, is seeing a slowdown of projects and winding down. The NURD was established in the northeast section of town to accomplish a similar goal, of the other two districts, in promoting development.

This year, an anticipated loan from the City to CURD is for water and sewer infrastructure and some streets in the SE Boardman area. Expanding these services will allow for more development to occur within our central part of town and the increase in the assessed value will help to recoup those costs.

The WURD has fulfilled its liability with the City, and no funds are due for repayment. No additional funds will be levied for WURD, this year.

In the NURD, plans for land purchases, new streets, and water and sewer line infrastructure are anticipated. This area is being designed for commercial use along NE Front St. and N. Olson Rd. with housing development to be considered in the area behind these lots. There is a lot of planning, a lot of what-ifs, and a lot of consulting as ideas are brought to the table and feasibility and resource availability are considered. Some ideas are easily discarded while others remain on the table for further consideration and analysis. It's an exciting time in Boardman, as the growth pushes us to create on the empty canvases we've had for so long. The added amenities will bring new opportunities and added benefits to our community. Thank you for your continued support on the budget committee. I will now present and review with you these financial plans.

BOARDMAN URBAN RENEWAL AGENCY

Boardman Urban Renewal Agency

The Boardman Urban Renewal Agency was established on August 19, 2008 to help with development activities in designated areas of Boardman. These activities are designated by its Governing body. Under an urban renewal agency, the governing body can establish districts, which are identified by boundaries, and submitted to the state. The duration of an urban renewal district may have an end date or may be perpetual as per state regulations. WURD is the only district with an established term of 25 years, which would discontinue the district in the year 2038.

If feasible, the City of Boardman is the district's financial leverage. The alternative option is an external loan for infrastructure. The overall total construction, improvements, and investments in the Urban Renewal Agency have a combined total of \$3,399,409. There are plans for additional construction and investment in the coming years.

CENTRAL URBAN RENEWAL DISTRICT

Central Urban Renewal District

The Central Boardman Urban Renewal District was adopted on August 19, 2008 without an end term date. It covers the area from SE Front Street to Wilson Lane along the East side of Main Street. Multiple projects have been completed and these have brought in new ventures along the areas of improvement.

- In 2014, approximately 900 feet of water and sewer lines were constructed from Oregon Trail Blvd North to SE Front Street with additional connections and street upgrades on a section of SE Front Street.
- In fiscal year 2015-2016 a commercial food entity along with two additional retail spaces was constructed and has been operational on SE Front Street.
- In 2018-2019 an upgrade to the City's main water line, along Wilson Road, was completed.
- In 2020, a food pod was constructed and has 4-5 vendors at any given time.
- In 2021, a new hotel establishment opened its doors along SE Front Street and is now considering expanding its business, at the same location.
- In May 2024, it acquired land underneath the Bonneville Power Administration power lines, along S Main ST. The plans are to create a green space with walking trails, road access and parking.
- In 2024-205 SE Front St. was completely redone and SE 1st St. was constructed as a connector to SE Oregon Trail Blvd.

In 2025-2026, CURD anticipates the construction of SW (1st Street) Loop Rd., which includes SW Oregon Trail Blvd. This will connect to Tatone St. This project will be funded by the City, who will upfront the money and the CURD will repay it over the coming years. This area is anticipated to have commercial development soon, reducing the outstanding liability timeframe.

Also in the CURD will be new water, sewer, and street infrastructure in the SE Boardman quadrant. This project should increase the assessed value in the area and, in turn, increase the property taxes levied, bringing in the money to help repay this infrastructure investment. This area is also expected to have commercial development soon, which would reduce the repayment period necessary, as well.

WEST URBAN RENEWAL DISTRICT

West Urban Renewal District

The West Boardman Urban Renewal District was adopted on November 18, 2013 covering 169.7 acres in West Boardman. It is bordered by W. Wilson Lane to the south and Paul Smith Road to the west. This district has an end term date of November 2038.

Projects accomplished

- In 2014, the street extension of Mt. Hood Ave, in the Chaparral subdivision (photo on cover page) was completed along with the construction of additional water and sewer infrastructure. Much of the improvements were aided by in-kind support from the Port of Morrow and financial backing by the City for utility services.
- Two duplexes were constructed in 2016 and two more were completed in 2019, and as of 2023 there are a total of seven duplexes on that street.
- In fiscal year 2018-2019, Faler Road was repaired and upgraded. Along with Faler Road, the City's main water and sewer lines were upgraded to replace the outdated utility lines.

WURD fulfilled its liability with the City in the 2025 fiscal year. No further payments are expected to be made to the City. This district is being considered for closure. For this year, there will be no further tax levy for the WURD.

The district is planning on completing some more sidewalk and street improvements with the current funds in the WURD.



NORTH URBAN RENEWAL DISTRICT

North Urban Renewal District

The North Urban Renewal District was just adopted on September 5, 2023. There are currently apartments and condos being built within that district that will contribute to the property taxes the NURD would be entitled to. This district anticipates construction of NE Front St., completion of some smaller streets that would connect to the expanded Boardman Ave. These projects are being analyzed for funding sources and viability. The budget allows for Grants and Loans are funding options for this project that would include not only new streets but some sewer and water lines. If the funding is not attainable, the project will be reviewed for completion in phases or postponed. These developments are projected to cost approximately \$4,150,000. The taxes collected in fiscal year 2025 surpassed the budgeted amount of \$65,000 by over double the taxes received at approximately \$164,000. This is promising for financial viability of the potential projects.
