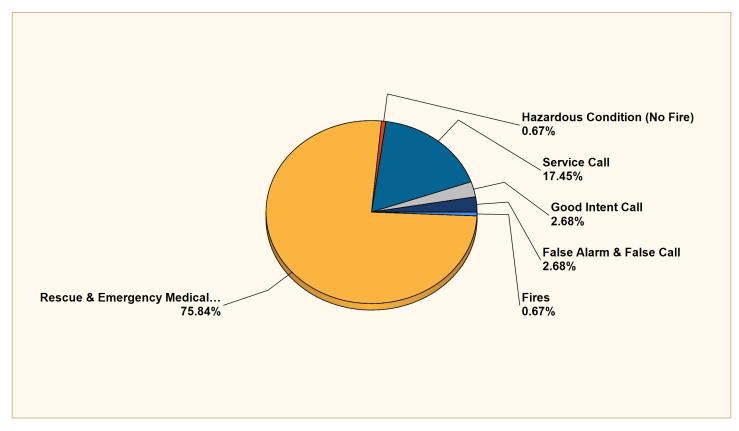

BE IT FURTHER RESOLVED that any Resolution or party thereof in conflict with this Resolution is hereby repealed.

BE IT FURTHER RESOLVED that if any section of this Resolution is declared to be invalid or unconstitutional, such shall not affect any other section of this Resolution.

ORDINANCE No. 2023-1180

ORDINANCE PROVIDING THAT RETIRING POLICE OFFICER RECEIVE SERVICE BADGE AND WEAPON.

BE IT ORDAINED by the Mayor and City Council of the City of Boaz as follows:

SECTION 1. Any law enforcement officer who at the time of his or her retirement is employed by the City of Boaz, Alabama Police Department shall receive, as part of his or her retirement benefit without cost, his or her badge and duty weapon. To be eligible for this benefit the employee must meet the following requirements:

- (1) Be in good standing and employed with the City of Boaz.
- (2) Meet the requirements for retirement as determined under the city's retirement plan.
- (3) Have a minimum of twenty (20) years of continuous service with the City of Boaz.
- (4) The city council shall approve the request of the officer if the above requirements are met and he or she shall be awarded their weapon and badge.
- (5) The personnel director of the city is directed to keep a record of all transactions related to the transfer of the weapon and badge to the employee under this section.
- (6) The City shall determine and resolve and determine that it is appropriate to declare said duty badge and weapon as surplus property and gift it to the retiring police officer as set forth herein.

SECTION 2: Each and every provision of this Ordinance is hereby declared to be an independent provision, and, if any section, sentence, paragraph, clause, phrase or word of this Ordinance is for any reason held or declared to be unconstitutional, inoperative, invalid or void, such holding or declaration shall not affect the remaining portions of this Ordinance, and it shall be construed to have been the intent of the City Council of the City of Boaz, Alabama, to pass this Ordinance without such unconstitutional, invalid or inoperative part therein, and the remainder of this Ordinance shall be deemed and held to be valid as if such part had not been included herein.

SECTION 3: This Ordinance shall be deemed cumulative with and supplemental to any and all statutes of the State of Alabama regarding the subject matter hereof and to be subordinate to same and in no manner intended to supersede any such statutes of the State of Alabama. Any provision hereof, in conflict with any provision of any state statute shall be construed so as to be in harmony with the same where possible and otherwise to be subordinate to and superseded by the provisions of such state statute

SECTION 4: This Ordinance shall become effective immediately after posting and publication as required by law.

RESOLUTION NUMBER 2023-1760

RESOLUTION AMENDING THE DISTRIBUTION OF AMOUNTS RECEIVED FROM THE CITY OF BOAZ, ALABAMA, SALES, USE AND RENTAL TAXES

Whereas, the Boaz City Council adopted a \$0.01 Sales, Use and Rental/lease tax increase (herein referred to as Sales Tax) and further adopted an allocation for said Sales Tax pursuant to Ordinance No. 2018- 1129; and

Whereas, Ordinance No. 2018-1129 stated that the allocation therein of said Sales Tax could be changed at any time in the future to allocate the use of such funds to other projects or to the general fund of the City by unanimous consent of the mayor and council; and

Whereas, the Boaz City Council further finds that it is in the best interest of the City of Boaz, Alabama, to amend Ordinance No. 2018-1129 to amend the allocation of the revenues received from such Sales Tax in a way which is beneficial to the City.

NOW THEREFORE, BE IT RESOLVED, by the Mayor and City Council for the City of Boaz, Alabama, as follows:

- 1. That the City Clerk/Treasurer shall establish a procedure, method or accounts to allocate and use the sums received from the \$0.01 (one cent) Sales Tax as follows:
- (a) Sixty five percent (65%) of the sums received from such Sales Tax shall be allocated to the General Fund. These amounts may be used for street improvements, including but not limited to paving, widening, striping, and other street maintenance issues, as needed by the City with the remainder for general purposes of the City.
- (b) Twenty five percent (25%) of the sums received from such Sales Tax shall be allocated for Capital Projects, including but not limited to equipment purchases, maintenance of existing buildings, structures, and facilities, and construction of new facilities.
- The City Council and Mayor shall specifically approve any withdrawal of funds from this capital projects fund prior to use of the funds except where such withdrawal is less than \$15,000.00.
- (c) Ten percent (10%) of the sums received from such Sales Tax shall be allocated to a reserve account which may be the current reserve account previously established. The City Council and Mayor shall specifically approve any withdrawal of funds from this reserve account prior to use of the funds.
- 2. That this resolution may by unanimous consent of the Mayor and City Council be rescinded or changed at any time in the future to allocate the use of such funds to other projects or to the general fund of the City.
