C. Employee Spotlight

Assistant Fire Chief Landis Messer presented the Council Members with two submissions for the Employee Spotlight.

The first was Fire Fighter Brennon Granberry. On March 5, 2025, after his shift at the station, Granberry was on his way to Dothan when Bonifay Fire Rescue received two mutual aid calls. On of the calls was in the Poplar Springs area, and Granberry knew he was the closest one to the fire, which was threatening several structures. Once Grandberry arrived on scene, he reported a size up, called for additional resources, and established incident command. The fire was 10 yards from a residential structure when Engine 1 arrived on scene, and began structure protection, while waiting on Florida Forest Service to help contain the fire.

The next morning, Fire Fighter Austin Medley and his family woke up to storm damage at their home, which resulted in 3 vehicles being damaged as well as their house. around 8:30 that morning, our fire department was dispatched to a possible residential structure fire in the Gritney area. Medley responded, knowing he was probably the closest fire fighter in the county. When he arrived on scene, he reported a size up, established incident command, and began investigating the fire. Medley reported this was a working structure, with fire in the ceiling. Our department,, as well as Gritney, extinguished the fire and controlled the damage to the structure.
