Rosalie McClain, local resident, stated she would like someone else to read water meters for the City. She also asked that the City notify people before they pick up discarded items by the road that they will be charged for.

Richard Willsey questioned how often Council Members meet outside of public meetings to discuss City business. He stated that he is going to have people take pictures and sign affidavits stating that Council Members were meeting over lunch and discussing matters of City business.

Mr. Willsey revisited the stormwater retention park. He expressed his appreciation that gates have caution tape over them. Willsey stated it is not supposed to hold water after the storm and the vegetation prevents that from happening. Willsey stated this was a violation of DEP and EPA standards.

Mr. Willsey requested that when members of the staff are making a presentation or reading something for public discussion, that they come to the podium.

Mr. Willsey questioned the status on the City Hall renovations.

The three-minute timer alarmed.

A. Melvin Engineering- D0298 Bonifay Southside Drainage Improvements Work Authorization

Executive Assistant Sierra Smith informed the Council Members that John Udochi, with Melvin Engineering, has the Southside Drainage Improvements Work Authorization for the RIF D0298 that the City was awarded in the amount of \$1,233,000.

Mr. Udochi stated this is for the culverts and drainage improvements on St. John's Rd. Hightower Ave., Jernigan Ave., and Clifford Street. This work authorization will be for them to do the inspection.

Ms. Smith stated that Chief Plant Operator Matt Perry and Director of Public Works Director Aaron Taylor agreed on using Ardurra for these items.

#### A. Red Cross Proclamation

Mayor Cook stated he has received several complaints of Florida Power & Light's tree trimming and tree removal. Some of it is hideous; some of it didn't need to be done. FPL sent an arborist, and the person that was over construction to the City to discuss the complaints that we have gotten. From that meeting, they have done a stop work order on all tree cutting in the City of Bonifay.

Downhome Street Festival is March 15th.

The Holmes County High School girls' basketball team is State runner-up and we are proud of them.

Executive Assistant Sierra Smith told the Council Members that Emma Meredith has won her 3rd State Championship in weightlifting, in both traditional & Olympic. She will be recognized at a meeting soon.

#### **Personnel Policy**

#### Current version

"Maximum annual leave accumulation shall not exceed two hundred forty (240) hours at the end of the calendar year. Unused annual leave above two hundred forty (240) hours will be forfeited by the employee at the end of the calendar year."

Proposed Version- "While there is no cap on total leave accumulation during employment, the payout of unused leave upon separation will not exceed twenty-five percent (25%) of the employee's total accumulated leave balance, up to a maximum of two hundred fifty (250) hours, whichever is less."

#### **RESOLUTION 2025-02**

A RESOLUTION OF THE CITY OF BONIFAY, FLORIDA ESTABLISHING A FEE SCHEDULE FOR CONNECTION TO WATER AND SEWER UTILITIES; PROVIDING FOR SCRIVENER'S ERRORS; PROVIDING FOR LIBERAL INTERPRETATION; PROVIDING FOR REPEAL OF CONFLICTING RESOLUTIONS AND FEE POLICIES; AND PROVIDING FOR AN EFFECTIVE DATE

#### BE IT RESOLVED BY THE CITY COUNCIL OF BONIFAY, FLORIDA AS FOLLOWS:

**SECTION 1: ESTABLISHMENT OF A WATER AND SEWER CONNECTION FEE SCHEDULE.** There is hereby established a Water and Sewer Utility Connection Fee Schedule as attached hereto, which is incorporated herein by reference. The connection fees set forth in the Water and Sewer Utility Connection Fee Schedule shall be charged to any customer connecting to the City's potable water and/or sewer utilities on and after the Effective Date set forth herein.

**SECTION 2: SCRIVENER'S ERRORS.** The correction of typographical errors which do not affect the intent of this Resolution may be authorized by the Mayor or the Mayor's designee, without public hearing, by filing a corrected or re-codified copy with the City Clerk.

**SECTION 3: RESOLUTION TO BE LIBERALLY CONSTRUED.** This Resolution shall be liberally construed in order to effectively carry out the purposes hereof which are deemed not to adversely affect public health, safety, or welfare.

**SECTION4: REPEAL OF CONFLICTING RESOLUTIONS AND POLICIES.** Resolutions, or parts of resolutions or portions thereof of the City of Bonifay, and policies of the City relating to the subjects hereof, in conflict with the provisions of this Resolution are hereby repealed to the extent of such conflict.

**SECTION 5 – EFFECTIVE DATE.** This Resolution shall take effect immediately upon adoption.
