#### **RESOLUTION NO. 23-90**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BONIFAY, FLORIDA, APPROVING AN APPLICATION FOR A STATE OF FLORIDA DEPARTMENT OF TRANSPORTATION, SHARED-USE NONMOTORIZED (SUN) TRAIL GRANT FOR PEDESTRIAN SAFETY IMPROVEMENTS FOR THE CITY OF BONIFAY, PROVIDING AN EFFECTIVE DATE; PROVIDING FOR AN EFFECTIVE DATE.

**WHEREAS**, the Florida Department of Transportation (FDOT) has established the Shared-Use Nonmotorized (SUN) Trail Program;

**WHEREAS,** it has been determined the City of Bonifay is eligible to make application for certain funds under this program;

**WHEREAS**, the City of Bonifay has identified the following project as pertinent to citizen connectivity within the City limits;

**City of Bonifay SUN Trail project**. This project will increase the connectivity and pedestrian safety along State Road 90 from Banfill Ave to the Holmes County Sheriff's Office.

**WHEREAS**, the City intends to submit grant funding application to the Rural Infrastructure Fund Program for the City of Bonifay; and

**WHEREAS**, the City Clerk has authority and rights to execute all required grant related application and agreement documents in the absence of the Mayor.

The entering into and performance of the Agreement and other related documents will not violate any judgment, order, law or regulation applicable to the Customer or result in any breach of, or constitute a default under, or result in the creation of any lien, charge, security interest or other encumbrance upon any assets of the Customer or the Equipment pursuant to any indenture, mortgage, deed of trust, bank loan, credit agreement or other instrument by which the Customer is a party or by which it or its assets may be bound. 5. There are no actions, suits or proceedings pending or, to the knowledge of the Customer, threatened against or affecting the Customer in any court or before any government commission, board or authority, which, if adversely determined, will have a material adverse effect on the ability of the Customer to perform its obligation under the Agreement. 6.
