A RESOLUTION OF THE CITY OF BONIFAY, FLORIDA **APPROVING CONTRACT** Α PANASONIC CORPORATION OF NORTH AMERICA **AUTHORIZING EXECUTION** OF **FOR** CONTRACT; **PROVIDING SCRIVENER'S PROVIDING FOR ERRORS:** LIBERAL INTERPRETATION; PROVIDING FOR REPEAL OF **CONFLICTING RESOLUTIONS AND FEE POLICIES;** AND PROVIDING FOR AN EFFECTIVE DATE

# BE IT RESOLVED BY THE CITY COUNCIL OF BONIFAY, FLORIDA AS FOLLOWS:

**SECTION 1: APPROVAL OF CONTRACT.** The City Council of the City of Bonifay, Florida, hereby authorizes a Master Services Agreement with Panasonic Corporation of North America and its successors and assigns, in the form presented to the City Council, relating to services described therein, and ancillary documents associated therewith.

# **SECTION 2: AUTHORIZATION TO EXECUTE CONTRACT ON BEHALF OF THE CITY.** The City Council of the City of Bonifay, Florida hereby authorizes the Mayor of the City of Bonifay, in his official capacity and on behalf of the City, to execute the Master Services Agreement with Panasonic Corporation of North America and its successors and assigns, in the form presented to the City Council, relating to services described therein, and ancillary documents associated therewith. The City Clerk or Interim City Clerk is further authorized to sign such documents as and if necessary to attest to the proper authorization and execution of such documents by the City of Bonifay and its Mayor.

**SECTION 3: SCRIVENER'S ERRORS.** The correction of typographical errors which do not affect the intent of this Resolution may be authorized by the Mayor or the Mayor's designee, without public hearing, by filing a corrected or re-codified copy with the City Clerk.

**SECTION 4: RESOLUTION TO BE LIBERALLY CONSTRUED.** This Resolution shall be liberally construed in order to effectively carry out the purposes hereof, which are deemed not to adversely affect public health, safety, or welfare.

**SECTION 5: REPEAL OF CONFLICTING RESOLUTIONS AND POLICIES.** Resolutions, or parts of resolutions or portions thereof of the City of Bonifay, and policies of the City relating to the subjects hereof, in conflict with the provisions of this Resolution are hereby repealed to the extent of such conflict.

**SECTION 6: EFFECTIVE DATE.** This Resolution shall take effect immediately upon adoption.

#### **RESOLUTION NO. 2025-07**

A RESOLUTION BY THE CITY OF BONIFAY, CITY COUNCIL, FLORIDA, APPROVING AN APPLICATION FOR A STATE OF FLORIDA, RURAL INFRASTRUCTURE FUND (RIF) GRANT FOR THE CONSTRUCTION OF PUBLIC INFRASTRUCTURE IMPROVEMENTS FOR THE CITY OF BONIFAY, PROVIDING AN EFFECTIVE DATE

WHEREAS, The State of Florida has established the Rural Infrastructure Fund Grant Program, and it has been determined that the City of Bonifay, FL, is eligible to make an application for certain funds under this program; and

WHEREAS, The City of Bonifay, FL has identified the following priority project as central to encourage job creation, capital investment, and the strengthening and diversification of its rural economy:

**Decon Road Sewer Extension Project** to upgrade and extend the existing sewer from the intersection of Son-In-Law Road and Weeks Street to Decon Road.

The City intends to submit a grant funding application to the Florida Department of Commerce Rural Infrastructure Fund Grant Program for the City of Bonifay; and

WHEREAS, the City Council hereby authorizes the Mayor to have authority and rights to execute all required grant related application and agreement documents for the grant application.
