Executive Assistant Smith stated that last Friday there was a Special Session regarding the CDBG application. The week before, she sent the legals to the newspaper regarding the advertisement of the CDBG application. The owner of the paper called that Friday afternoon and informed her that they made a mistake and did not put it in the paper. With that information, the City will not be submitting that CDBG application due to advertising requirements from the program.

Executive Assistant Smith informed the Council Members that her and Mayor Cook spent the last few weeks meeting with Florida Power & Light, Lumens, and Mediacom regarding their lines and poles through town. All entities are linked and should be working together now.

C. Employee of the Quarter Award

Executive Assistant Smith told the Council Members that Waukesha Way sponsored the Employee of the Quarter Award.

Fire Chief Travis Cook invited Josh Myers and his family up to the council tables. Fire Chief Cook read the Employee Spotlight nomination that he submitted for Josh Myers. It is an honor to recognize Josh Meyers as the City of Bonifay's Employee of the Quarter.

Fire Chief Cook stated that on April 10, 2025, Bonifay Fire Department responded to the scene of a tragic motor vehicle crash on State Road 79, just south of the city limits. Assistant Fire Chief Larry Cook was directed to a lifeless child on the side of the highway. Assistant Chief Cook began CPR, including chest compressions and mouth-to-mouth breaths. Without the timely actions of Assistant Chief Cook, Trinity would not be here today. Chief Cook presented Assistant Chief Larry Cook a lifesaving award for his heroic actions that day.

AMENDMENT FOUR TO GRANT AGREEMENT BETWEEN THE FLORIDA DEPARTMENT OF COMMERCE AND CITY OF BONIFAY, FLORIDA

On **December 3, 2021**, the State of Florida, Department of Commerce ("Commerce") and the **City of Bonifay, Florida** ("Grantee"), entered into Grant Agreement **HL128** ("Agreement"). Commerce and Grantee are sometimes referred to herein individually as a "Party" and collectively as "the Parties."

WHEREAS, Section D, Modification, of the Agreement provides that any amendment to the Agreement shall be in writing and executed by the Parties thereto; and

WHEREAS, the Parties wish to amend the Agreement as set forth herein.

NOW THEREFORE, in consideration of the mutual covenants and obligations set forth herein, the receipt and sufficiency of which are hereby acknowledged, the Parties agree to the following:

1. Section A, Agreement Period, is hereby deleted and replaced with the following:

This Agreement is effective as of July 1, 2021 (the "Effective Date") and shall continue until the earlier to occur of (a) June 30, 2026 (the "Expiration Date") or (b) the date on which either Party terminates this Agreement (the "Termination Date"). The period of time between the Effective Date and the Expiration Date or Termination Date is the "Agreement Period."

2. Section U, Employment Eligibility Verification- E-Verify, is hereby deleted and replaced with the following:

U. EMPLOYMENT ELIGIBILITY VERIFICATION- E-VERIFY

- 1. E-Verify is an Internet-based system that allows an employer, using information reported on an employee's Form I-9, Employment Eligibility Verification, to determine the eligibility of all new employees hired to work in the United States. There is no charge to employers to use E-Verify. The Department of Homeland Security's E-Verify system can be found at: https://www.e-verify.gov/.
- 2. In accordance with section 448.095, F.S., the State of Florida expressly requires the following:
 - a) Every public agency and its contractors and subcontractors shall register with and use the E-Verify system to verify the work authorization status of all newly hired employees. A public agency or a contractor or subcontractor thereof may not enter into a contract unless each party to the contract registers with and uses the E-Verify system.
 - b) An employer shall verify each new employee's employment eligibility within three (3) business days after the first day that the new employee begins working for pay

as required under 8 C.F.R. 274a. Beginning July 1, 2023, a private employer with 25 or more employees shall use the E-Verify system to verify a new employee's employment eligibility.

- 3. If an entity does not use E-Verify, the entity shall enroll in the E-Verify system prior to hiring any new employee or retaining any contract employee after the effective date of this Agreement.
- 3. The Agreement is hereby reinstated as through it has not expired, if not executed by the Expiration Date.
- 4. All other terms and conditions of the Agreement remain in full force and effect.


