ORDINANCE NO. 439

COMPREHENSIVE PLAN, AND ORDINANCE 401 WHICH AMENDED THE CITY OF BONIFAY FUTURE LAND USE MAP TO PROVIDE THE CONSIDERATION OF ADOPTION OF A CERTAIN AMENDMENT TO THE CITY OF BONIFAY COMPREHENSIVE PLAN TO REVISE AND UPDATE THE EXISTING COMPREHENSIVE PLAN AND FUTURE LAND USE AN ORDINANCE AMENDING ORDINANCE 358, WHICH ADOPTED THE CITY OF BONIFAY MAP IN ACCORDANCE WITH CHAPTER 163, FLORIDA STATUTES; PROVIDING FOR SEVERABILITY AND FOR REPEALER; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Legislature adopted Chapter 163, laws of Florida, which requires the City of Bonifay ("City") to prepare, adopt, enforce and update a Comprehensive Plan; and

and recommended the Amendment be transmitted by the City Council for Adoption to the consider the recommended amendment to the Comprehensive Plan on March 4, 2024, WHEREAS, the City of Bonifay Planning Commission held a Public Hearing to Florida Commerce Department and other State, Regional and County agencies; and WHEREAS, the Legislature adopted Chapter 163, Florida Statutes which requires the City of Bonifay ("City") to prepare, adopt, enforce and update a Comprehensive Plan to guide its future development and growth; and WHEREAS, Section 163.3177(6)(i)2, Florida Statutes (Chapter 2021-195, Laws of Florida) requires the City to include a property rights element and an updated Capital Improvements Element in its City of Bonifay Comprehensive Plan; and WHEREAS, the City respects judicially acknowledged and constitutional protected private property rights; and WHEREAS, The City respects the rights of all people to participate in land use and planning processes; and

WHEREAS, this ordinance will amend the comprehensive plan by adding a property rights element; and

WHEREAS, this ordinance will amend the comprehensive plan to update the current language to follow the 2023 version of Florida Statutes; and

WHEREAS, this ordinance updates referenced measurements; and

WHEREAS, this ordinance updates the 2023-24 Capital Improvements Element; and WHEREAS, the City Council of Bonifay, Florida held a public hearing as required reviewed and considered all comments received during the public hearings, and provided for by Chapter 163, Florida Statutes with due public notice having been provided, and having

necessary revisions; and

WHEREAS, in exercise of its authority, the City Council finds it necessary and desirable to adopt and does hereby adopt the Amendment to the Comprehensive Plan, in order to update the Comprehensive Plan.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BONIFAY, FLORIDA, THAT:

Florida Statutes by adding the attached as Exhibit A and made part of this ordinance as is for in SECTION 1. The City of Bonifay Comprehensive Plan is amended in accordance with

Section 1.01 of the Charter of the City of Bonifay. Amendment consists of the attached hereto as Exhibit A, and made a part hereof and which will be incorporated in the current SECTION 2. Authority. The authority for enactment of this ordinance is Article 1, Comprehensive Plan of the City of Bonifay.

SECTION 3. Amendment. The Comprehensive Plan for the City of Bonifay is hereby amended, read as follows in Exhibit A. SECTION 4. Severability. Each separate provision of this ordinance is deemed independent of all other provisions herein so that if any portion or provision of this ordinance is declared invalid, all other provisions there of shall remain valid and enforceable.

SECTION 5. Effective Date. This Ordinance shall become effective upon its adoption by the City Council as provided by law. City of Bonifay Wastewater System Improvements

Dear Ms. Knecht:

I am the duly appointed City Attorney for the City of Bonifay. The City proposes to borrow \$708,892 from the State Revolving Fund for the design of planned improvements to the City's sewer system. The loan will be secured by the net revenues of the City's water and sewer system, together with the net revenues of the City's sanitation system, and the pledged revenues are legally available to pledge. The City of Bonifay has the legal authority to increase rates to ensure repayment of the loan.

The pledge on revenues is subject to a prior lien with the following issues:

- 1. The City of Bonifay, Florida, Water and Sewer System Revenue Bonds, Series 1985A issued in the amount of \$520,300.00, pursuant to Resolution No. 83-50 (passed October 24, 1983), under which the lienholder is the United States Department of Agriculture, being USDA Loan Number 92-01;
- 2. The City of Bonifay, Florida, Water and Sewer System Revenue Bonds, Series 1985B issued in the amount of \$100,000.00, pursuant to ordinance, under which the lienholder is the United States Department of Agriculture, being USDA Loan Number 92-03;
- 3. The City of Bonifay, Florida, Water and Sewer System Revenue Bonds, Series 1989A issued in the amount of \$1,498,100.00, pursuant to ordinance, under which the lienholder is the United States Department of Agriculture, and being USDA Loan Number 92-06;
- 4. The City of Bonifay, Florida, Water and Sewer System Revenue Bonds, Series 1989B issued in the amount of \$427,600.00, pursuant to ordinance, under which the lienholder is the United States Department of Agriculture, and being USDA Loan Number 92-08;
- 5. The City of Bonifay, Florida, Water and Sewer System Revenue Bonds, Series 2005A issued in the amount of \$1,436,300.00, pursuant to ordinance, under which the lienholder is the United States Department of Agriculture, and being USDA Loan Number 91-12; and
- 6. The City of Bonifay, Florida, Water and Sewer System Revenue Bonds, Series 2005B issued in the amount of \$246,700.00, pursuant to ordinance, under which the lienholder is the United States Department of Agriculture, and being USDA Loan Number 91-13;
- 7. The City of Bonifay, Florida, Water and Sewer System Revenue Bonds, Series 2010A issued in the amount of \$51,081.32, pursuant to ordinance, under which the lienholder is the State of Florida Dept.

- 8. The City of Bonifay, Florida, Water and Sewer System Revenue Bonds, Series 2010B issued in the amount of \$60,023.20, pursuant to ordinance, under which the lienholder is the State of Florida Dept. of Environmental Protection State Revolving Loan Fund (Funding Number 300111), and the actual revenues pledged are water and sewer revenues; and
- 9. The City of Bonifay, Florida, Water and Sewer System Revenue Bonds, Series 2012A dated October 26, 2012, issued in the amount of \$2,244,000.00, pursuant to ordinance, under which the lienholder is the United States Department of Agriculture, and being USDA Loan Number 92-15; and
- 10. The City of Bonifay, Florida, Water and Sewer System Revenue Bonds, Series 2012B dated October 26, 2012, issued in the amount of \$145,000.00, pursuant to ordinance, under which the lienholder is the United States Department of Agriculture, and being USDA Loan Number 92-18.



LAND SWAP AGREEMENT

This Land Swap Agreement is made and entered into this ____ day of February, 2024, between City of Bonifay, a municipal subdivision of the State of Florida (referred to herein as the "City") and Kiwanis Club of Bonifay, Florida, a Florida not for profit corporation (referred to herein as "Kiwanis").

WITNESSETH:

WHEREAS, the City is the owner of that certain property described as 15.42 +/- acres described as Parcel ID# 0606.02-002-001-001.000, Holmes County, Florida that is known as Memorial Field; and

WHEREAS, Kiwanis and the City entered into that certain agreement for improvements to and use of Memorial Field dated on or about March 29, 1955 as recorded in Deed Book 81, Page 221-224, as subsequently amended on October 30, 1970 as recorded in Official Records Book 11, Page 233 and as subsequently amended on April 10, 1995 as recorded n Official Records Bok 231, Page 384, public records of Holmes County, Florida; and

WHEREAS, Kiwanis is the owner of that certain property described as 1.17+/- acres described as Parcel ID# 0606.02-000-000-052.000, Holmes County, Florida (the "Kiwanis Parcel"); and

WHEREAS, Memorial Field is at risk of becoming unusable due to safety concerns and is in need of substantial improvements to alleviate those risks; and

WHEREAS, the City is unable to fund the improvements required for the continued use of Memorial Field; and

WHEREAS, Kiwanis has historically paid for such improvements to Memorial Field; and

WHEREAS, Kiwanis is willing to invest the funds required to improve Memorial Field on the condition that fee title to that portion of Memorial Field described in attached Exhibit "A" (the "City Parcel") is conveyed to Kiwanis; and

WHEREAS, Kiwanis is willing to transfer and convey fee title to the Kiwanis Parcel in consideration of the conveyance of the City Parcel; and

WHEREAS, the City and Kiwanis desire to swap the City Parcel for the Kiwanis Parcel.

NOW THEREFORE, for ten dollars and other valuable consideration, the parties agree as follows:

- 1. The recitals stated hereinabove are true and accurate.
- The City shall transfer and convey via general warranty deed to Kiwanis the City Parcel.
- Kiwanis shall transfer and convey via general warranty deed to the City the Kiwanis Parcel.
- 4. Kiwanis shall accept title to the City Parcel subject to any agreements with the Holmes County School District pertaining to the use of the City Parcel.
- Either party may purchase title insurance as to the respective parcel it is receiving
- 6. Either party may at its own expense obtain an owner's title insurance policy insuring such party's interest in the property being acquired by such party. If title to the property is found to be defective in the opinion of such party's attorney, then such party may terminate this Agreement or waive any such defect and proceed to closing. For purposes of clarity, neither party shall have a duty to cure any defects in title.

- 7. Each party shall be responsible for all documentary stamps and recording fees associated with the transfer of title of their respective property described herein, including title insurance premiums, title search fees and closing fees associated with the transfer of title.
- 8. Each party acknowledges and agrees that the property described herein is being exchanged in its current AS-IS condition, with all faults and makes no representation or warranty as to the right of ingress or egress to the property or its fitness for any intended use by such party.
- 9. Each party shall be responsible for their own attorney's fees, if any.
- 10. Closing will take place on or before March 15, 2024.
- 11. Kiwanis shall designate the closing agent for this transaction.
- 12. If either party defaults under this Contract, the parties do hereby acknowledge and agree that its sole remedy against the defaulting party shall be to terminate this Agreement.
- 13. This Agreement contains the entire agreement between the parties with respect to the subject matter hereof and cannot be amended or supplemented except by written agreement signed by both parties
- 14. Time is of the essence of this Agreement.
- 15. This Agreement may be executed in one or more counterparts, each of which shall be deemed an original, and all such counterparts together shall constitute one and the same instrument.

Section VIII, ItemA.

16. Each party shall at the time of Closing execute all such documents as may be necessary or appropriate in order to consummate the transaction contemplated by this Agreement.
