VOTE-BY-MAIL BALLOTS (aka absentee ballots) MAY BE PICKED UP AT CITY HALL ON FRIDAY, MARCH 24, 2023 FROM 8:00 AM TO 3:00 PM, MONDAY, MARCH 27, 2023 FROM 8:00 AM TO 3:00 PM, AND ON ELECTION DAY ON TUESDAY, MARCH 28, 2023 DURING ELECTION HOURS, BUT MUST BE RETURNED BEFORE 7:00 PM ON ELECTION DAY.

“ANY ELECTOR MAY DESIGNATE IN WRITING A PERSON TO PICK UP THE BALLOT FOR THE ELECTOR; HOWEVER, THE PERSON DESIGNATED MAY NOT PICK UP MORE THAN TWO VOTE-BY-MAIL (aka absentee ballots) PER ELECTION, OTHER THAN THE DESIGNEE’S OWN BALLOT, EXCEPT THAT ADDITIONAL BALLOTS MAY BE PICKED UP FOR MEMBERS OF THE DESIGNEE’S IMMEDIATE FAMILY. FOR PURPOSES OF THIS SECTION, “IMMEDIATE FAMILY” MEANS THE DESIGNEE’S SPOUSE OR THE PARENT, CHILD, GRANDPARENT, GRANDCHILD, OR SIBLING OF THE DESIGNEE’S SPOUSE.
