Chief Cook told the Council Members that he had negotiated with Ten-8 Fire & Safety on the cost of a 1000-gallon pumper and equipment to match this appropriation, and asked the Council to waive the procurement policy.

Resolution Number: 2025-05

Whereas, the City of Bonifay, Florida, intends to apply to the State of Florida for FY25-26 Florida Recreation Development Assistance Program Grant consideration under the provisions as set forth in Chapter 62D-5, Part V, Florida Administrative Code (F.A.C.), and

Whereas, the City of Bonifay, Florida, has determined the need for additional recreational space within the town and intends to apply for grant funding in an amount up to \$200,000.00 to acquire the property identified as Parcel IDs 0531.03-003-00C-005.000, 0531.03-003-00C-004.000, & 0531.03-003-118-002.000 (Parcels) within the City of Bonifay city limits; and

Whereas, the City of Bonifay, Florida, plans to use future funding from the Florida Recreational Development Assistance Program Grant to implement needed improvements to develop the Parcel as these funds become available from State of Florida; and

Whereas, the City of Bonifay agrees to amend their Capital Improvements Schedule to include the project "Development of Parcel IDs 0531.03-003-00C-005.000, 0531.03-003-00C-004.000, & 0531.03-003-118-002.000" into their 5-Year Capital Improvement Plan.

NOW THEREFORE, BE IT HEREBY RESOLVED that this legislative body of the City of Bonifay, Florida, will apply to the Florida Department of Environmental Protection, Division of Recreation and Parks for a Florida Recreation Development Assistance Program Grant in the amount up to \$200,000 to fund said acquisition and commits to amend the Capital Improvements Schedule to include referenced project should funding be awarded.
