The contract does have a clause for continued use of the equipment for a five-year period.

Interim City Manager Robertson-Caraway stated the packet contains Truth and Taxation worksheet showing the calculations for the proposed tax rates. The Stephens County Appraisal District certified roll has a different dollar amount than we were originally given. The Appraisal Office said two properties had changed and that is why the numbers are different. When you vote it needs to be contingent upon receiving the corrected SCAD Certified Roll corrected amount of \$210,353,345.00.

12. Request to approve Resolution 21-16 Designation required by SB 2 on Tax Rate Calculations

Interim City Manager Robertson-Caraway stated Senate Bill 2 went into effect in 2019, different parts of the bill were effective in 2019, 2020, and 2021. The City needs to appoint an individual to be responsible for the calculations of the Tax Rates. This resolution will give that responsibility to the City Manager or Interim City Manager.

14. Request to approve the calculations of the 2021 No New Revenue Tax Rate

Interim City Manager Robertson-Caraway stated the Truth and Taxation worksheet was completed according to the corrected Certified Appraisal Roll. It appears that our tax rate will be reduced from 1.12229 to 1.06000.

Commissioner Rob Durham made a motion to approve the 2021 No New Revenue Tax Rate calculations, consider a proposed tax rate of \$1.06000 which will exceed the No New Revenue Tax Rate by \$.06744 and set public hearing for August 31st at City Offices, to consider the proposed tax rate.

15. Request to consider discussing tax rate, take a record vote and schedule required Public Hearing

Interim City Manager Robertson-Caraway stated the Public Hearing must be within 7 days of final approval of ratifying the tax rate. Therefore, the Public Hearing will need to be set for August 31st.

16. Request to approve Resolution 21-17 Supporting the RV Development Project at Hubbard Creek Reservoir

Colton Buckley, BEDC Director introduces Brooke Hatchett reviews the project scope and design and Colton reviews the economic impact.

Timeline is 10 to 12 months we want May 2022 for the Grand Opening.

Interim City Manager Robertson-Caraway stated this ordinance is one of the ordinances

that is included in the back of the budget. The fee schedule requires to be read twice at regular meetings of the City Commission; second reading will be the September 7th meeting. The fee schedule will be posted on our website and published with Breckenridge American and Breckenridge Texan. Charter states that it can become effective 5 days after publication. Our effective date will be October 1st. Included is Republic Services sanitation rate increases, water and sewer rate increases using scenario 5 approved by the Commission. We reviewed water and sewer tap rates and made changes on the rates to be more in line with actual costs and to incorporate pavement and rock issues.

CITY MANAGER REPORTS

18. Rate adjustment settlement for Texas Gas Service

Interim City Manager Robertson-Caraway explained we follow the lead of Mineral Wells and Weatherford. They work with attorneys that review the filings from Texas Gas Service and negotiate with Texas Gas to get the best COSA rates for our generalized areas. The rate is lower than what originally was asked. There is nothing we need to do to accept the rate, we would only need to act if we were disputing the rate.

19. Permission to research the legal requirements and possible advantages / disadvantages of turning over the YMCA Building to BEDC

Public Works Director Houston Satterwhite explains that nothing has been done with the building in years. The funds are not there to make the repairs needed. The future of the building would be best served in the hands of the BEDC. The roof needs to be repaired along with many other issues. The roof needs repaired as soon as possible. The building is and will continue to deteriorate at a faster rate without roof repairs.

Public Services Director Stacy Harrison spoke about the history of the building and the condition of the building. BEDC Director Colton Buckley stated it will take a lot of money for repairs and will need to check into working with the County and City.
