BACKGROUND INFORMATION:

Article IV of the City of Breckenridge Code of Ordinances provides for the guidance of elections of the governing body election. Additionally, state statute sets the first Saturday in May as a uniform election date. This year's election day was held on May 3, 2025.

This year, two citizens were to be elected at-large to serve a two-year term as Commissioner Place 2 and Commissioner Place 3. The incumbents for these positions were Vince Moore and Rob Durham

There was a total of 233 ballots cast. The tentative results of this election are as follows:

Commissioner Place 3

Vice Moore 80 Votes
Richard "Dicky" Russell 20 Votes
Junior Fernandez 104 Votes
Scott Ensey 26 Votes

Commissioner Place 3

Paul J. Huntington Jr. 126 Votes Tony Patterson 82 votes

There are 2 outstanding provisional ballots. Ballot board will meet on Monday, May 12th to accept or reject those ballots. At that time the votes will be updated.

RESOLUTION NO. 2025-11

RESOLUTION CANVASSING ELECTION RETURNS FOR THE CITY OF BRECKENRIDGE, TEXAS GENERAL ELECTION HELD ON SATURDAY, MAY 3, 2025 FOR MAYOR AND CITY COMMISSIONER PLACES NO. 3 AND 4.

WHEREAS, the City Commission of said City ordered an election to be held in said City on May 3, 2025, for MAYOR AND CITY COMMISSIONER PLACES NO. 3 AND 4; and

WHEREAS, said City Commission has investigated all matters pertaining to said election, including the ordering, giving notice, officers, holding and making returns of said election; and

WHEREAS, the election officers who held said election have duly made the returns of the result thereof, and said returns have been duly delivered to said City Commission.

THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF BRECKENRIDGE:

- 1. That the City Commission officially finds and determines that said election was duly ordered, that proper notice of said election was duly given, that proper election officers were duly appointed prior to said election, that said election was duly held, that due returns of the result of said election have been made and delivered, and that the City Commission has duly canvassed said returns, all in accordance with law and the Ordinance calling said election.
- **2.** That the City Commission officially finds and determines that the following votes were cast at said election, CITY COMMISSIONER PLACES NO. 3 AND 4, by the residents, qualified electors of said City, who voted at the election:

FOR CITY COMMISSIONER PLACE NO. 3

80 VOTES: VINCE MOORE

20 VOTES: RICHARD "DICKY" RUSSELL

104 VOTES: JUNIOR FERNANDEZ

26 VOTES SCOTT ENSEY

FOR CITY COMMISSIONER PLACE NO. 4

126 VOTES: PAUL J. HUNTINGTON JR.

82 VOTES: TONY PATTERSON

3. That the City Commission officially finds, determines and declares the result of said election to be for CITY COMMISSIONER PLACE NO. 3 <u>Junior Fernandez</u> has received a majority vote of <u>104</u>; for CITY COMMISSIONER PLACE NO. 4 <u>Paul J. Huntinton Jr.</u> has received a majority vote of <u>126</u>; there being cast a total of <u>233</u> votes at said election.
