Highland Drive Major Subdivision 9457 Highland Dr.

Hanna Cohan Plessner, Triban Investment, LLC, 7555 Fredle Drive, Ste 210 and Kirk Schmidt were in attendance at the meeting. The came seeking final approval of the major subdivision at 9457 Highland Drive, Brecksville, OH 44141, PPN 603-15-009, as described in the Improvement Plans dated July 29, 2024, by Davey Resource Group and the application dated May 20, 2024 by Triban Investment, LLC, on behalf of Harris Park Development, LLC and contingent upon approval of the Law Director, City Engineer and City Council.

Revisions to the HOA Declaration were proposed by the Law Department and Planning & Zoning Department, and such changes were reported to have been made by the applicant. Members of the Planning Commission had not had opportunity to review the updated HOA Declaration.

Bryan Stowe, Horticulturist/Tree Warden for the City of Brecksville, submitted his summary of a review of the landscaping plan and responded to its favorable nature for moving forward.

Mr. Sciria asked why this major subdivision did not have a master development plan as all others to date in Brecksville have. This is specifically called out in 1119.02 requirement to provide and install grading of lots.

Mr. Caruso commented that this lack could create grading problems for each lot as they are individually purchased and built upon.

Mr. Sciria does not believe it is a good idea to not have a master grading plan.

Kris Schmidt suggested that they place grade elevations for each lot on the drawings for the project to give direction to future purchasers/builders about the requirements they will have.

After discussion of Mr. Wise's report of the large number of outstanding items, Mayor Kingston noted that while progress is obvious, the actual final approvals are lacking as of today's meeting. He asked Kris Schmidt how many of these items could be finalized in another two weeks, when the next Planning Commission meeting is scheduled.

Hanna Cohen Plessner agreed to continue working with the outside parties to get their final approvals done before the next Planning Commission meeting and to return for that meeting seeking final approval.
