Police Chief Korinek said the Police Department membership in the Southwest Council of Governments includes the join use of the SWAT Team, Bomb Team, Mobile Field Force Team. The City does not have the means to support all of these resources on an individual basis. Officers on the SWAT Team are outfitted with body armor, special tactical body armor, helmets and specialized training. Membership also provided the availability of 50-100 officers within a short amount of time.

Lt. Bender said the membership for the Fire Department comes under the same umbrella of the Southwest Emergency Response team and provides specialized rescue, technical response and hazmat response among many other specialized rescues.
