It took approximately 2 hours to put the fire out. Service Director Kickel said the service building is a total loss along with the contents. The fire may have been caused by a street sweeper parked in the building. The vehicles included a semi tractor, an asphalt roller, a street sweeper

In addition to the repaving, ODOT requires evaluation of all intersections to verify ADA compliance at all crossings. As part of ODOT requirements, Categorical Exclusion Level C1 environmental services are required for this project. Such work includes Section 106 – Scoping Request Form, Section 4F - Ecological Exempt Form, Environmental Site Assessment – Regulated Material Screening, & Public Involvement. We have obtained the attached proposal from Chagrin Valley Engineering, LTD (CVE) in the amount of \$6,500.00 to provide these services. CVE, worked with us on Phase 1 and we would like to utilize their services again. CVE is an ODOT pre-qualified firm for the requested work.
