COMMENTS: Jennifer Speer, 6545 Glen Coe Drive. MS. Speer said she is the Director of BBH Pride and speaking on behalf of the task force and over 300 Pride members, many are in attendance tonight. BBH Pride has been approved by the treasury as a 501c3 non-profit organization. Ms. Speer said she is here to discuss the specifics of Pridefest 2024. Ms. Speer provided an aerial view of the needed square footage and expected food trucks, portable toilets, stage and walking areas, approximately 21,000 square feet. Ms. Speer said she feels the Central School lawn and United Church of Christ next to that, the United Methodist Church and the Horticultural Building provide adequate space. Ms. Speer said the group wants the LGBTQ+ population and their allies to know Brecksville sees, respects, honors and celebrates them. Ms. Speer said Council member Koepke said, at candidate night "I love everybody, I feel everybody should feel great right off the bat I would love for the city to feel that as a whole and everyone that comes here feel comfortable I'm dedicated to working to make that happen I feel it's so important having an organized group like BBH pride is a great way to bring awareness."

Ms. Speer said Mayor Kingston said "Many residents have chosen to leave pride signs up year round. which is great the impact of representation is massive because it promotes opportunities for discussions among friends and within families. Through these conversations over time that will prevent anyone especially children from feeling like they don't belong or are unwelcome or invisible."

Ms. Speer said for many years LGBTQ+ couples who sought to get married in this building (City Hall)were told go to Broadview Heights. Ms. Speer said she would like to apply for a standard permit, but found that type of permit does not exist. Ms. Speer said she needs to provide a date and location for the sponsors and asked if Brecksville could settle on a date and location today so she can send out the press release tomorrow. Council President Caruso thanked Ms. Speer for providing information for Council to think about. Ms. Speer asked Mayor Kingston when she could receive an answer. Mayor Kingston said Ms. Speer is addressing Council at a Council meeting, not Mayor. Mayor Kingston said he has not heard anything that will change his mind. Ms. Speer asked when she could have an answer. Ms. Speer said they do not have 150 vendors and is sure the Brecksville Police and Fire can provide the same resources Broadview Heights provided (2023). Ms. Speer asked for an answer by Friday. Council President Caruso said it was a nice presentation and Council will have a lot of items to consider. Council President Caruso said the item may be placed on the next Council meeting agenda. Council President Caruso said Council would have to confer officially in public, Council can't make decisions in private. Council member Stucky asked where the event was held in Broadview Heights. Ms. Speer said it was held at the Middle School parking lot. Council member Stucky said school property, not Broadview Heights city property. Ms. Speer asked if there is a permit application on line, and the nondiscrimination policy on line is outdated by 50 years. Council member Koepke asked what makes the policy outdated. Ms. Speer said it cites 1964 and 1978 in the policy. Ms. Speer argued the group brings their own paid security and has a \$2 million liability insurance policy, with no incidents last year. Council member Koepke said Council will need to look at, if there is a permit process, what that would look like and how it would be approved. Ms. Speer said she cannot wait another month and she did submit the request at the end of January. Ms. Speer said the Police Force is able to protect Home Days, surely they can protect Pride Fest.

Council member Stucky said he are not aware of a time where the City has rented out city property. Council President Caruso said there is a rental list, Public Square was purposely kept off of that list.

Ms. Speer said The Black Lives Matter (Protest) was much larger and held on the Municipal Lot. Council President Caruso that eventwas coordinated by the Safety Director at the time. Ms. Speer said that event set a precedent. Council member Stucky said not a good one. Ms. Speer said that event and was safe and nothing happened. Ms. Speer said her event is a family friendly event.

Council President Caruso said there are many things to be considered. Ms. Speer said Mayor Kingston offered to meet, and asked when she could meet, the group needs to talk to their sponsors and vendors who are requesting information on a date and location. Mayor Kingston said he would check with Council leadership to find availability for a meeting, possibly by the end of this week. Ms. Speer said Pride Fest Chairpersons could possibly attend, there are also task force members who could meet with City Officials. Law Director Matty reminded Council there may not be a meeting discussing City business, without public notice and required notification, of 2 or more committee members, or 4 members of Council creating a quorum.

Nicola Foley, Gatewood Drive – Ms. Foley said in Mr. Kingston's denial letter to BBH Pride Mayor Kingston stated space, the gathering could not be accommodated. Mayor Kingston said he is not convinced that the event would not grow. Mayor Kingston said he is not aware of any organizations allowed to use City space for a private event, not a city event. Ms. Foley said it is a public event. Mayor Kingston said it is not a city driven event. Mumbled comments from the audience.

Council President Caruso said he feels the meeting should be held and discussion on the subject continue.

Ms. Foley said in the letter sent to (BBH Pride)Mayor Kingston said he talked to Council, the Safety Committee, Police Chief and all the others and just now Mayor Kingston said he didn't get past the first sentence before he said no. Ms. Foley wants to know why Mayor Kingston said that. Mayor Kingston said he spoke with the Police Chief, Fire Chief and Building Commissioner. Mayor Kingston said he did not offer a list of why he said no, he feels the event may be too big. Mayor Kingston said he may allow use of the area for wedding photos for a short amount of time. Mayor Kingston said, as with signs on city property, we allow all signs or we allow no signs. Brecksville does not allow signs to be placed on City property. We have not allowed events on city property. Mayor Kingston said he has received demands to change the past 50 years of City precedent and will not make these changes now.

Mayor Kingston said there are many things to discuss, financial, safety, precedent. There are other groups requesting to hold events on City property and the answer is no to all groups.

Inaudible comments.

Ms. Foley said she would like Mayor Kingston to contact Broadview Heights Mayor Alai and the Police Chief of Broadview Heights before the Friday meeting. Ms. Speer said this is public property and the group are taxpayers and believes this is not legal.

Council member Koepke said she doesn't believe this is accurate. City Council is asking for time, notice of a week or two is too fast to make a decision. Council members are not allowed to discuss any city business outside of a public meeting. Council member Koepke said the group has a good message and people willing to put the message out.

Ms. Speer argued she did not believe that is true.

Council member Stucky asked why they did not go back to the Middle School, the property overlaps both communities. Ms. Speer said there was a lot of harassment given to the Pride Group because they were at the middle school and several of the members did not safe because they were threatened by the opposing group.
