Mr. Lahrmer opened the Work Session at 7:02 p.m.

PICKLEBALL COURT IN LANDSCAPE BUFFER EASEMENT - 2383 SPRINGSIDE OVAL

Mr. Pat Beam, Landscape Architect, was present on behalf of an application for a pickleball court to be located in a landscape easement at the Four Seasons subdivision. Included in the application was a letter of approval from the Four Season's HOA. Mr. Beam indicated neighbors on both sides were more than 200 ft. from the area for the pickleball court. When asked if the proposed installation had been discussed with the immediate neighbors, Mr. Beam didn't know.

Mr. Stucky noted the landscape buffer easement was on the property owner's land and not on HOA common land. Mr. Lahrmer read from the original development agreement the clause relative to the landscape buffer easement that prohibited any encroachment and/or structures on the easement without the agreement of the City. Concern for setting precedent was raised. Mayor Hruby indicated encroachment on a landscape easement has happened in other developments such as the Woodlands on Snowville, and permitted with the approval of neighbors and their HOA. Commission members were favorably influenced by the significant distance between the proposed court and any neighboring property. There was a general consensus to make a motion for approval contingent on notification of neighbor to the south. The Work Session recessed into the Regular Meeting for a motion.

VERIZON CELL TOWER EQUIPMENT UPGRADES - 6898 MILLER ROAD

Ms. Casey Conrad was present on behalf of Verizon's request to update equipment on the Miller Road communications tower by swapping out three antennas and a ground cabinet. Mr. Wise saw no problem with the request mentioning that the ground cabinet would be located within their current fenced area. Commission members had no questions and the Work Session recessed into the Regular Meeting for two motions.

VA – OFFICE BUILDING I ADDITIONAL FAÇADE DESIGN – MILLER RD/BRECKSVILLE RD.

Final approval of Valor Acres Office Building I was recommended by the Planning Commission in a motion on June 8, 2023 contingent on additional studies of the west and north facades. Mr. Kevin DiGeronimo, DiGeronimo Properties, was present to discuss four façade option drawings for the Valor Acres Building I that were developed through meetings of his team with Mr. Lahrmer and Mr. Payto. Their focus was to better articulate entries to the building on the west and north facades.

Mr. DiGeronimo reviewed each of the four renderings. He identified Options 3 and 4 as facades that would be acceptable with Option 3 their preferred façade choice. Discussion among Commission members was confined to Options 3 and 4, with a mixture of support for both. Since both options were agreeable to Commission members they felt the DiGeronimo organization could make the choice for their headquarters building. The Work Session recessed into the Regular meeting for a motion.
