Broadview Heights has decided not to be party to this agreement at this time. That means, to the City of Brecksville, that an attempt was made to have Broadview Heights participate in the agreement and cover the cost of the repair of the portion of Valley Parkway that is in Broadview Heights. They have refused to do so. Law Director Matty said the way this is drafted is, should they at some point in time during the term of this agreement change their mind and agree to do so they will either do so at the same percentage that we are taking care of with Metro Parks. If the portion of the roadway that's in Brecksville or if Broadview Heights does at a lesser percentage than us, our percentage is decreased. Council member Stucky said even though part of the roadway is in their Community they are not plowing the road. Law Director Matty said that is correct.

Councilmember Bender asked Brecksville will be plowing outside of the City. Law Director Matty said yes. In a similar concept that Police and Fire go with their organizations to help other communities. Law Director Matty said Brecksville is doing this to ensure the safety of the buses. On the roadway you've school buses going with Broadview Heights not participating, we're the only agency that can assure that it be done. The other reason is as our plows clear that roadway, there isn't any safe way for them to return other than going to the end and turning around and coming back so the will be going to be driving that roadway anyways so it seemed to be the most practical way to solve the problem. Councilmember Stucky asked if the City is covered with the respect to liability of operating under mutual aid. Law Director Matty said yes.
