I do so both personally and on behalf of the Recreation Commission, my fellow City Council members, and the City of Brecksville.

Meg's extraordinary journey in supporting and organizing youth sports began long before the organizations she helped to build. Meg coached baseball for many years with the "Breck Rec" starting in the late 1980's, winning two championships; along with coaching CYO Baseball for St. Basil. Meg was a Cub Scout Den Leader. 2003 was the start of Brecksville Travel Baseball Association, or as we know BTBA. With the later addition of soccer and then basketball, her efforts helped shape what is now a thriving multi-sport nonprofit—the Cuyahoga Valley Youth Organization (CVYO), officially founded in 2008.

Meg's behind-the-scenes efforts—organizing teams, attending Recreation Commission meetings, coordinating events, and balancing the needs of passionate coaches and athletes all competing for the same field or court—are simply irreplaceable. Truthfully, it's hard to imagine anyone stepping up to do all that she did with such dedication and grace. To quote Mayor Jerry N. Hruby, "She was kind, compassionate yet she commanded ones respect by her manner of leadership, firm and decisive."

Meg's impact wasn't just on the fields and courts, but in the hearts of everyone who knew her. She embodied what it means to give selflessly, always putting the kids and community first. Jackie Robinson said, "A life is not important except in the impact it has on other lives."

On behalf of all of us, we say thank you, Meg, for your dedication, passion and love. You've been an inspiration in your service to this community.

With that, I respectfully move that Council authorize the Administration to prepare a Resolution of Condolence and Appreciation in honor of Meg English, ensuring that her legacy of service and dedication to our community is formally recognized.
