Mayor Hruby said the City of Brecksville provides the headquarters for the Historical Association at Blossom Hill. Mayor Hruby said he does not recommend providing the additional funds for gravel to be used at the Squire Rich Museum. Councilmember Carouse said the Historical Association has a pretty healthy balance in their checking account but I think the city should continue to support what it has in the past.

**FIN 3. Insurance and Risk Mgt. Renewal Proposal-Wichert** - Consideration of a motion recommending to Council approval of a Resolution accepting the renewal of the City's Insurance Policies with Wichert Insurance for the period May 25, 2022 through May 25, 2023.

Purchasing Director Riser said the property and liability policies are broken out into two resolutions. The law enforcement liability and the public officials policies remained relatively flat. The 7. 2% overall increase is mainly for property with the new field house which was expected and also the anticipated increase in the cyber liability. The quote for the cyber and crime combo coverage with Travelers Insurance was just a quote at the time it was submitted it for the agenda. Chagrin Valley Dispatch (CVD) was able to provide the multi-factor authentication required for the cyber policy. Purchasing Director Riser said many surrounding communities have had cyber attacks and the deductibles are doubling and tripling. Traditionally in cyber policies, deductibles were \$25,000 compared to the City of Brecksville's \$10,000 deductible because Wichert Insurance was able to negotiate that for us with Travelers for the past several years. The standard deductible for cyber coverage is \$50,000 and many are going as high as \$100,000. Wichert was able to get travelers to agree to a \$25,000 deductible for our policy. Purchasing Director Riser thanked Councilmember Ganim for bringing information our way about a local company that has protection for us to consider. Purchasing Director riser said she met with them today and spoke with the Mayor and provided a summary of that meeting and I am going to be sitting down with CVD to have them view a demo and it it's just additional protections of the data that could be added at a small cost per system that it's put on that could possibly help bring these soaring premiums down because Travelers insurance is aware of it and they would offer a discount for people who are involved with it. Purchasing Director wanted to extend sincere appreciation to Wichert Insurance, in their fortieth year of exceptional service, guidance, and ongoing support

to the city for all of our property and liability insurance needs, and in these days with the soaring prices and everything going on they have really been a good partner for the city.
