The Brecksville Planning Commission will hold a Public Hearing at 7:00 pm on Thursday, May 23, 2024, at Brecksville City Hall, 9069 Brecksville Road, Brecksville, Ohio to establish a front yard setback of 40' for two proposed lots at 6864 Chaffee Court (601-33-024)

Mr. Wayne Jantsek of 6864 Chaffee LLC presented the project to the Public. Mr. Lahrmer reminded all that the purpose of the Public Hearing was to discuss the establishment of a front yard set back of 40' for the two proposed lots. Future probable requests for considerations for variances for sidewalks and establishment of an irregular lot at the property will be considered at a future date by the Board of Zoning Appeals.

Rita Brocco of 6837 Chaffee Ct, Brecksville asked questions about what kind of accessory structures would be allowed on the lots. Mr. Lahrmer informed that the lot is zoned 8A and that allows for gardens, sheds, garages and pools. Monica Bartkiewicz added that any additions would be subject to the zoning in place including a 50' rear yard setback.

Rita Brocco also asked about the height of the lot. Mr. Jantsek stated that there are not currently drawings in place but it is their intent to lower the grade to match the existing homes nearby.

Rita Brocco also sought clarification about the request for an irregular lot and Wayne Jantsek demonstrated that location on the plot map.

Paul George of 6829 Chaffee Ct, Brecksville, asked about the lot split plans and where the driveways would be located. Wayne Jantsek showed the probable lot split on the plot map and reminded that the drawings for the buildings, including driveway locations were not yet done.

There being no additional public comments, Mr. Lahrmer moved to close the public hearing, seconded by Mr. Sciria.
