**AN ORDINANCE PROVIDING FOR THE SUBMISSION TO THE ELECTORS OF THE CITY OF BRECKSVILLE THE QUESTION OF AMENDING THE ZONING MAP BY ADDING AN MS MOTOR SERVICES OVERLAY ZONING DISTRICT FOR A TRUE NORTH GAS STATION AND CARWASH ON THE APPROXIMATELY 2.62 ACRES FRONTING ON MILLER ROAD AND AN LB LOCAL BUSINESS OVERLAY ZONING DISTRICT ON THE APPROXIMATELY 2.48 ACRE REMAINDER OF PP #604-17-003 LOCATED AT 6850 MILLER ROAD**

**WHEREAS**, pursuant to Article IV Section 12. of the City Charter, Council hereby initiates this ordinance and desires to submit it to the electors of the municipality at the next primary election for approval by a fifty-five percent (55%) favorable vote as required by said charter provision; and

**SECTION 3.** The City Engineer be and he is hereby authorized and directed to amend the Zoning Map of the City of Brecksville to reflect the change in zoning classification as specified in Section 1 hereof, upon the effective date of this Ordinance.

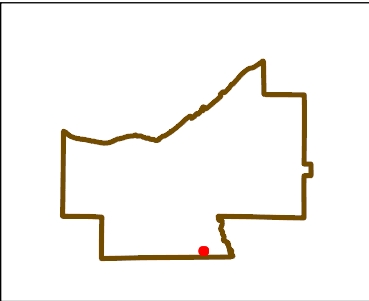

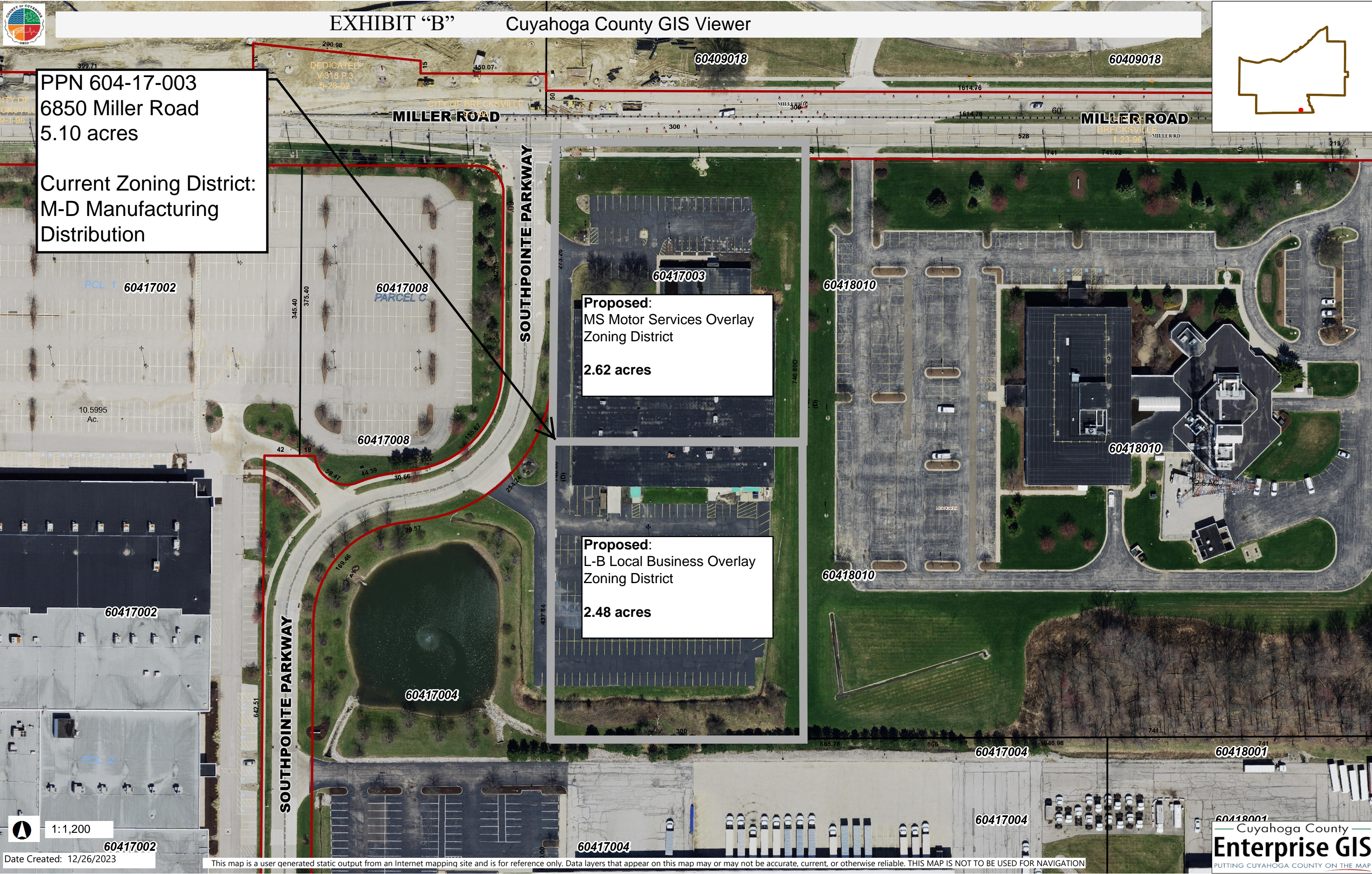


EXHIBIT "B" Cuyahoga County GIS Viewer
