SECTION 1. The Municode Supplement 3 to the Codified Ordinances of the City of Brecksville, as submitted by the City's Codifier, a complete copy of which is attached hereto as Exhibit "A" and expressly made a part hereof by reference be, and the same is, hereby adopted in its entirety.

SECTION 2. Any existing Sections of the Codified Ordinances of the City of Brecksville which are inconsistent with the provisions contained in the aforesaid Thirtieth Supplement to the Codified Ordinances of the City of Brecksville be and the same are hereby repealed from and after the effective date of this Ordinance.

SECTION 3. The Council declares this Ordinance to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare, the reason for the emergency is the necessity to update the Codified Ordinances of the City of Brecksville, therefore, said Ordinance shall be in full force and effect immediately upon its adoption by this Council and approval by the Mayor, otherwise,

WHEREAS, the MOU is required by section 2151.4220 of the ORC and section 5101:2-33-26 of the OAC.

SECTION 1. The Mayor be, and he hereby is, authorized to enter into a Memorandum of Understanding with Cuyahoga County to set forth expected and normal operating procedures regarding child abuse or neglect, a copy of which Memorandum of Understanding is attached hereto as Exhibit "A."
